**ALLEGHENY COUNTY**  
**ANNUAL ACTION PLAN FY 2024**

Notice is hereby given that Allegheny County has prepared the 2024 Annual Action Plan, which lists the proposed projects for the Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Emergency Solutions Grant (ESG) funds. For FY 2024, which begins July 1, 2024, Allegheny County expects to receive the following: CDBG funds in the amount of \$13,000,000, HOME funds in the amount of \$3,200,000, and ESG funds in the amount of \$1,174,237. These amounts are estimates. Actual allocation amounts will be included in the final Plan submitted to HUD.

To obtain the views of citizens, public agencies, and other interested parties, Allegheny County will place the FY 2024 Annual Action Plan on display beginning April 12, 2024, at the following locations in Allegheny County:
