Dear Mr. Hammond:

The Allegheny County Health Department (ACHD) hereby submits a requested revision to Allegheny County's portion of the Pennsylvania State Implementation Plan (SIP) for the Attainment and Maintenance of the PM_{2.5} National Ambient Air Quality Standards (NAAQS). This SIP revision consists of a Redesignation Request and Maintenance Plan for the Liberty-Clairton, PA and Allegheny County, PA PM_{2.5} Nonattainment Areas for the 1997, 2006, and 2012 NAAQS.

This SIP revision, tracked internally as our SIP Revision Number 100, was the subject of a public comment period from August 9 to September 9, 2022, with a public hearing on September 8, 2022. The final version of the Redesignation Request and Maintenance Plan following public comment is dated September 22, 2022.

The ACHD is a separate local air pollution control agency approved by the Pennsylvania Department of Environmental Protection (PA DEP) in accordance with Section 12 of the Air Pollution Control Act (35 P.S. § 4012). The Local Health Administration Law, 1951, Aug. 24, P.L. 1304, 16 P.S. §§12001 et seq., states the ACHD's Director "shall be the administrator" of the health department (16 P.S. § 12012(a)), and in that capacity is responsible for implementing and enforcing the SIP, and in this instance responsible for its final approval. I approve and adopt this Redesignation Request and Maintenance Plan for submittal to the U.S. Environmental Protection Agency (EPA) as a revision to Allegheny County's Portion of the Pennsylvania SIP for the Attainment and Maintenance of the PM_{2.5} NAAQS.

To the best of my knowledge, information, and belief, I certify via my signature as contained below, that the Redesignation Request and Maintenance Plan has been developed in accordance with Clean Air Act requirements and EPA guidance. ACHD followed all the applicable procedural and legal requirements of the Commonwealth's laws and constitution in conducting and completing the adoption and issuance of the SIP revision. ACHD published the proposed
