III. Attainment Emissions Inventory and Mobile Source Control Measures

The maintenance plan for the first 10 years contained a base year inventory of 1990. This analysis in this 2nd 10-Year Plan documents a base year inventory of 2008. The 2008 emissions inventory was taken from the 2008 National Emissions Inventory, Version 2 (April10, 2012). The 2008 National Emissions Inventory was selected because it is current and representative of the emissions in Allegheny County during the period air quality has shown maintenance of the NAAQS. This is the most recent and comprehensive emissions inventory for Carbon Monoxide in Allegheny County. The 2011 National Emissions Inventory has yet to be released and ACHD only updates the point sources annually, therefore the 2008 National Emissions Inventory in its entirety would be representative of actual emissions in Allegheny County for the duration of this maintenance plan and future inventories, once developed, would have minimal effect on CO Typical Winter Day Emissions. This inventory contains emission estimates of point, area, highway, and nonroad sources of CO in Allegheny County for the year 2008; seasonal adjustment factors were used to produce CO emission in Allegheny County for typical winter day CO emissions. A typical winter day is averaged from the months of December, January, and February for workdays only. Ideally the month of December should be from the previous year than January and February; however there is no know inventory that is setup in this fashion, so the month of December is taken from the 2008 National Emissions Inventory rather than a 2007 inventory.

The 2008 National Emissions Inventory is comprised of four major categories:

Point – large stationary sources such as refineries, power generating stations, and other facilities with large boilers;

<u>Area – small stationary sources not included in the point inventory such as home</u> <u>heating; and some mobile sources such as aircraft, commercial marine vessels, and</u> <u>railroad locomotives;</u>

Highway – automobiles, trucks, and other vehicles that operate on roads and highways; and

<u>Nonroad</u> – equipment not otherwise counted in the inventory such as that used for light commercial, lawn and garden, construction, and airport support.

Once the four major categories for CO are assembled on an Annual Basis, those categories need to be adjusted for the CO season and for workdays only. Point Sources that are non-heating operate evenly throughout the year and those sources were given a seasonal adjustment factor of 1.0. Point Sources that are heating sources would have been given a seasonal adjustment factor greater than 1.0, but there are no sources in Allegheny County that fit that subcategory. Biogenics are also included as a point source in the 2008 NEI, and that subcategory has monthly CO emissions found at: (www.epa.gov/ttnchie1/net/2008inventory.html). Biogenics data for Allegheny County, PA in this data set for the months of January, February, and December were used to determine the emissions for the winter season. Area source emissions were seasonally adjusted using the appropriate seasonal adjustment factor from Table 5.8-1 Area Source Seasonal Adjustment Factors for Peak Ozone and CO Seasons; Procedures for the Preparation of Emission Inventories for Carbon Monoxide and Precursors of Ozone (EPA-450/4-91-016). The highway source category is taken from the 2008-Based Modeling Platform (Under Development), 2008 Emissions Data Files (ftp://ftp.epa.gov/EmisInventory/2008dev) for the CO season. The highway source emissions are daily emissions by month for January, February, and December. The highway source data includes weekend data, so ACHD determined a scaling factor of 7/5.8 was appropriate to scale the data to workdays only. The scaling factor for the highway source was determined using the Diesel Vehicle and Gasoline Vehicle Weekday/Weekend Contribution Charts for both Alleghany County speciation sites, Lawrenceville and Liberty Borough⁵. The nonroad category was also taken from the 2008-Based Modeling Platform (Under Development), 2008 Emissions Data Files for the CO season. Akin to the highway emissions, the nonroad source emissions are daily emissions by month for January, February, and December. However, no scaling factor was applied to the nonroad category, since residents of Allegheny County are just as likely to do activities, that fall under the nonroad category, on weekdays and weekends.

IV. Maintenance Demonstration

The dominant source of CO emissions is from on-road motor vehicles. Other contributing sources include nonroad mobile emissions, which include lawn and garden equipment and construction equipment, as well as area and point sources such as wood burning and cement production. Although CO emissions are also the result of point, area, <u>highway</u>, and nonroad sources, the CO inventory <u>inventories below</u> only includes emissions from on-road (highway) sources, since motor vehicles are still the primary source in the CBD. Finally, note that the data is representative of the "typical winter day," and was modeled with MOVES2010⁵⁶. Table <u>12</u> illustrates the CO emissions for a typical winter day in 2013 and Table <u>23</u> illustrates the CO emissions for a typical winter day in 2022.

2. Technical Support Document

Summary of Change

Allegheny County Health Department (ACHD) submitted a State Implementation Plan (SIP) revision for CO under the limited maintenance plan option. In that analysis, each redesignation criterion in Section 107(d)(3)(E) of the Clean Air Act (CAA or the Act) is listed, along with a short description of the guidance provided by EPA in relation to that criterion, and the justification that supports the request for redesignation to attainment. Significantly, since the area is "not classified," and has a design value below 7.65 ppm, the County used EPA's "Limited Maintenance Plan Option" in addressing Section 107(d)(3)(E)(iv). Additionally, because the area is "not classified," the SIP submittal requirements of the CAA, Section 187, do not apply. The CBD was designated CO attainment status with an effective date of January 13, 2003.

ACHD is submitting to the EPA a Supplemental SIP Submittal to the Revision of the Carbon Monoxide (CO) Limited Maintenance Plan. The supplemental submittal will incorporate the addition of a 2008 base year of typical winter day CO emissions. CO levels are expected to remain well below the NAAQS for the ten-year period ending 2022.

The Supplemental SIP Submittal to the Revision of the Carbon Monoxide Limited Maintenance Plan constitutes a change to the Allegheny County portion of the Pennsylvania State Implementation Plan.

1. Comment: The submittal should provide a justification for selecting the scaling factor that was applied to the highway source data to adjust for weekdays, and as necessary include references to support this.

Commenter: U.S. EPA Region III.

Response: ACHD will add justification for selecting the scaling factor that was applied to the highway source data to adjust to weekdays and the reference.

2. Comment: The projected emission inventories are not part of the attainment inventory requirement of the maintenance plan, but part of the attainment demonstration of the plan.

Commenter: U.S. EPA Region III.

Response: ACHD will move the section pertaining to the projected emission inventories to the beginning of section IV. Maintenance Demonstration.

3. Comment: Under the limited maintenance plan option, a maintenance demonstration is not required due to the assumption that the carbon monoxide ambient concentration is well below that standard, and therefore, the area should remain attaining the standard. Thus, EPA will likely not act on these projected inventories although they are included as part of this submittal.

Commenter: U.S. EPA Region III.

Response: ACHD acknowledges the comment and will retain the projected inventories.

4. Comment: In Appendix B, the tables should provide for each area source the seasonal adjustment factor used (from EPA's document "Procedures for the preparation of emission inventories for carbon monoxide and precursors of ozone: volume 1," EPA-450/4-91-016), as done for the point sources.

Commenter: U.S. EPA Region III.

Response: ACHD will add the seasonal adjustment factors used in the first table of Appendix B.

5. Comment: Titles should be added to Tables in Appendix B.

Commenter: U.S. EPA Region III.

Response: ACHD will add titles to the tables in Appendix B.

6. Comment: Plant thousands of trees, brush, and make all unused property for the city, green areas; this will help the CO problem and make the city look better. Running hovercrafts up and down all three rivers would cut down the CO by not using cars, buses, and etcetera.

Commenter: Paul Hochendoner.
