Enclosed are a paper copy, and an exact duplicate of this paper copy on a computer disk in searchable pdf file format, of a requested revision to Allegheny County's portion of the Pennsylvania State Implementation Plan for the Attainment and Maintenance of the National Ambient Air Quality Standards. The purpose of this revision request is to amend Article XXI, Air Pollution Control Rules and Regulations, and County Ordinance 16782, with respect to §2101.07.a, "Administration and Organization - Administration" and §2101.20, "Definitions." This SIP revision is being tracked as our internal Revision Tracking Number 81.

Along with the Article XXI changes described above, changes to §2101.07.c, "Air Pollution Control Advisory Committee," were also made concurrently and are shown in the submittal documentation, but only for information purposes. As described in the Technical Support Document of the attached submittal, although 40 CFR 52.2020 and 52.2063 c.192 list §2101.07.c (except paragraphs c.2 and c.8) as a part of the Allegheny County SIP, the current changes made to §2101.07.c are not being submitted here as a SIP revision because of specific past guidance provided by EPA indicating that EPA does not believe the provisions of Section 128 of the Clean Air Act apply to County provisions governing the Air Advisory Committee.

This SIP Revision was the subject of a public comment period from November 21, 2014 until December 29, 2014, with a public hearing held on December 23, 2014, during which comments were received. It was approved by the Board of Health on March 4, 2015, enacted by County Council on May 5, 2015, approved and signed by the Allegheny County Chief Executive on May 8, 2015, and became effective June 19, 2015.

§2101.07 ADMINISTRATION AND ORGANIZATION

{Subsection c amended May 7, 1998 effective May 15, 1998. Amended May 8, 2015, effective June 19, 2015.}

- Administration. This Article shall be administered and enforced by the Allegheny County Health Department Bureau of Environmental Quality <u>Health</u>, by the Director of the Allegheny County Health Department, and by the County of Allegheny pursuant to authority granted in the Local Health Administration Law, 1951, Aug. 24, P.L. 1304, 16 P.S. §§12001 et seq. and the Second Class County Code, 1953, July 28, P.L. 723, 16 P.S. §§3101 et seq.
- b. Amendments. Amendments to this Article shall be made in conformity with the Local Health Administration Law, 1951, Aug. 24, P.L. 1304, and the Second Class County Code, 1953, July 28, P.L. 723. A public hearing and a 30 day public comment period shall be conducted by the Board of Health prior to its consideration of any significant amendment or additions to this Article or any amendment or additions to this Article which constitute a proposed amendment to the County's portion of any SIP required under the Clean Air Act.
- c. Air Pollution Control Advisory Committee. There is hereby established an Air Pollution Control Advisory Committee which may recommend to the Board of Health additions and changes to this Article and advise the Bureau of Environmental Quality
 <u>Health</u> and the Board of Health on matters relative to the control of air pollution which are brought to its attention by any person.
 - The Air Pollution Control Advisory Committee shall consist of 19 at least 9 and up to 15 individuals appointed by the <u>County Executive Board of</u> <u>County Commissioners</u>. Each member may identify an alternate in writing to vote in his/her stead. The member shall provide the name, address, and phone number of the alternate to the Chair of the Advisory Committee. The term of the alternate shall be that of the member or until the member identifies another alternate.
 - All members of the Advisory Committee shall be appointed for a term of one (1)
 three (3) years or until the next appointment, whichever is longer.
 - The Director, and Deputy Director <u>Bureau of Environmental Health, and</u> <u>Air Program Manager</u> shall be ex-officio members of the Committee but shall not have the right to vote on matters before the Committee.

- 4. Advisory Committee members may include both residents of Allegheny County and non-residents who have been deemed by the <u>County Executive</u> County Commissioners to have pertinent expertise. At no time shall tThe Advisory Committee <u>shall</u> consist of more than five (5) members who are <u>a balance</u> <u>of</u> representatives of industry, <u>environmental organizations</u>, <u>academia, small business</u>, and general citizenry, who <u>maintain credentials in</u>, or experience in, or knowledge of the field of air pollution.
- 5. A member or his/her alternate is expected to be in attendance at all Advisory Committee meetings. If a member or his/her alternate is not in attendance at more than 3 out of any six (6) consecutive meetings, he/she will be notified by the County that his/her membership has been forfeited. A member may petition the Director for reinstatement at the next Advisory Committee meeting.
- 6. The Advisory Committee shall elect from its members a Chair and a Vice Chair of the Committee. The election shall be for one year terms and held at the first meeting after September 1 of each year.
- 7. The Advisory Committee shall meet at the call of the Chair, or at the request of the Director of the Allegheny County Health Department or the Board of Health, or upon the written request of any three (3) members of the Advisory Committee.
- 8. The Advisory Committee shall adopt such procedures as it deems necessary to conduct its business and shall adopt such provisions as are necessary in order to consider matters which are brought to its attention by any person or group.
- 9. A quorum shall be required to conduct the business of the Advisory Committee. A quorum shall consist of not less than a majority of the voting members of the Advisory Committee.

"County Executive" means the <u>County</u> <u>Chief</u> Executive of Allegheny County, Pennsylvania, <u>as</u> <u>defined in the Allegheny County Home Rule Charter</u>.

2. Technical Support Document

The regulation changes include the following portions of the Allegheny County Rules and Regulations, Article XXI, Air Pollution Control:

§2101.07.a, Administration and Organization – Administration;
§2101.07.c, Administration and Organization – Air Pollution Control Advisory Committee;
and
§2101.20, Definitions

Only §2101.07.a and §2101.20 are being submitted as SIP changes. The change to the former is being made to reflect the updated name of the Bureau of Environmental Health. The change to the latter is being made so that the definition of "County Executive" agrees with the description of that office found in the County Home Rule Charter.

Regarding the changes to §2101.07.c:

40 CFR 52.2020 and 52.2063 c.192 list §2101.07.c (except paragraphs c.2 and c.8), as a part of the Allegheny County SIP. However, the changes are not being submitted here as a SIP revision because of specific guidance provided by EPA in a public comment (see attached M. Spinks to R. Westman letter) during the 1998 change to this same Article XXI subsection.

"EPA has reviewed the proposed revisions to Article XXI, Section 2107C, governing the composition of the Air Pollution Control Advisory Committee. Section 128 of the Clean Air Act ("the ACT") requires that State and local Boards which have the authority to issue and enforce permits meet certain criteria regarding conflicts of interest and representation of the public's point of view. Such criteria are required to be incorporated into the applicable State SIP. Advisory boards which expressly do not have the authority to issue and enforce permits do not have to comply with these Section 128 requirements. It is EPA's understanding that the Air Pollution Control Advisory Committee does not have the authority to issue and enforce permits in Allegheny County. Therefore, EPA concludes that the provisions of Section 128 of the Act do not apply to County provisions governing this committee.

EPA further notes that the proposed regulations to Section 2107C govern internal County administrative procedures, and do not support any other statutory requirement of the Clean Air Act. Therefore, EPA concludes that Allegheny County does not need to submit these proposed provisions to EPA as a formal revision to the Allegheny County portion of the Pennsylvania SIP."

This change to Section 2101.07.c will:

- 1. Increase the appointment term from one year to three years. This will address a concern voiced by County Council, which historically has questioned the need to review appointments of the same members on a yearly basis.
- 2. Revise the number of individuals comprising the Committee from 19 to "at least nine (9) and up to 15." This will present a more attainable number of members to comprise a full committee.
- 3. Revise the language that mandated that no more than five members be representatives of industry, to instead require the Committee consist of a balance of representatives from industry, environmental organizations, academia, small business and general citizenry. This will better reflect the composition of the Committee currently, and as anticipated for the future.
- 4. Update the titles of various positions within the Health Department and County.

SUMMARY OF COMMENTS AND RESPONSES

for

SIP Revision 81

Article XXI, Section 2101.07.a, Administration (SIP Change) §2101.07.c, Air Pollution Control Advisory Committee (Non-SIP Change) and §2101.20, Definitions (SIP Change)

Public Comment Period: November 21 to December 29, 2014 Public Hearing: December 23, 2014

1. **Comment:** ...given the Committee's influence on ACHD's efforts to develop and implement air quality regulations that have a direct impact on public health in Allegheny County, the Council strongly recommends that ACHD require a public health professional be a member of the Committee in addition to the other amendments to § 2101.07(c)(4).

The effects of air pollution on public health are well known and thoroughly documented. Public health professionals serve a critical function for local communities by pursuing solutions to detrimental conditions and improving collective health. Public health professionals are also uniquely positioned to work with local communities and authorities to raise awareness of the health impacts of poor air quality and support initiatives to reduce pollution. Lastly, public health professionals provide decision-making bodies an important, objective perspective for developing and implementing air quality rules, regulations, and plans. For the reasons stated above, Clean Air Council recommends that ACHD require a public health professional to serve as a member of the Air Pollution Control Advisory Committee.

Commenter: Joseph Otis Minott, Esq., Executive Director, Clean Air Council.

Response: The Health Department appreciates the comment. However, the Department believes that it is not necessary to include language in the second sentence of Paragraph 2101.07.c.4: "The Advisory Committee shall consist of a balanced number of representatives of industry, environmental organizations, academia, small business, and general citizenry, who maintain credentials, or experience in, or knowledge of the field of air pollution," to add a requirement for representation of "public health professionals." Such specificity is no more necessary than adding a requirement for representation of the environmental legal profession or the environmental consultant profession. The Department believes that the existing language stated in the quotation above is wholly inclusive of professionals with experience in air quality as to include such health professionals

with the related experience and will achieve the goal of creating a balanced committee.

The Department also notes that the proposed revisions in this submittal were the subject of review by the Regulation Subcommittee at four separate meetings. During the third such meeting (August 7, 2014), a suggestion to add the same language proposed above by the commenter was made. The Regulation Subcommittee gave the suggestion significant consideration, but could not reach consensus on adding it. The meeting minutes reflect that the chief concern was over the impact this addition would have on the "balance" of the Committee makeup. The Department wishes to honor the deliberations on the issue made by the Subcommittee, by maintaining Paragraph c.4 as proposed in this submittal.

2. Comment: Given the strong connection between air quality and human health we believe it is important to explicitly add a public health and/or medical professional to the list of representatives outlined in 2101.07c.4. Thus the statement would change to, "The Advisory Committee shall consist of a balance of representatives of industry, <u>public health and/or the medical field</u>, environmental organizations, academia, small business, and general citizenry, who maintain credentials in, or experience in, or knowledge of the field of air pollution." Making certain that at least one member of the committee has a public health or medical background will help ensure that decisions are being made, at least in part, from a human health perspective and is in line with the fact that the Air Quality Program is housed at the Allegheny County Health Department.
