

### **2017 CAPITAL BUDGET**

The Department of Budget and Finance is pleased to present recommendations for the 2017 Capital Budget. This year's capital budget of \$105.95 million includes 83 infrastructure and capital improvement projects. The 2017 Capital Budget requires \$41.57 million in bond proceeds, \$35.50 million in federal and state bridge/road reimbursement funds, and \$28.89 million in other financing to support all projects planned for 2017.

Many of the projects in this 2017 budget represent continuation or additional phases of projects begun in previous years. The following summaries are an overview of some of the more prominent programs.

#### **BRIDGE PROGRAM**

Allegheny County is responsible for maintaining 521 bridges. The bridges are divided into three groupings: major structures from 20 ft. to 3,100 ft. (191 bridges fall within this group), minor structures from 8 ft. to 20 ft. (149 structures), and bridges and culverts less than 8 ft. (181 structures).

The 2017 Bridge Program Capital Budget is \$42.66 million. The capital allocation for bridges includes \$33.10 million in federal and state reimbursements for various bridge projects scheduled for engineering/design work or construction in 2017. Also included is \$2.25 million in Act 89 funding, which the county can use for bridge repair projects and \$1.65 million in Act 13 Highway Bridge funding from the state's Marcellus Shale Legacy Fund. These funds will be used to replace/repair any at-risk, deteriorated bridges within the county.

Construction continues in downtown Pittsburgh on the Warhol (7<sup>th</sup> Street) Bridge. The rehabilitation of the bridge includes structural steel repairs, concrete repairs, deck replacement, and blast-cleaning and painting of the superstructure over the Allegheny River. Construction work also continues on the rehabilitation of the Murray (South 10th Street) Bridge, crossing the Monongahela River in the City of Pittsburgh. The project involves inspecting and repairing the suspension cables, as well as the superstructure support steel, drainage and concrete repairs.

#### **ROADS PROGRAM**

The county is responsible for maintaining 408 miles of inter-municipal roads. Capital funds are spent for road design, repair, construction, and maintenance. The bulk of capital expenditures are made in support of the annual design and reconstruction of various roads. The 2017 Roads Program is budgeted at \$17.43 million. Funding will be directed toward county road reconstruction projects and lateral support projects, as well as the In-House Paving Program, which is budgeted at \$3.40 million for 2017.



#### **ROADS PROGRAM** (continued)

These projects will improve safety and ease traffic congestion by correcting alignment issues, reconstructing deteriorated roads, and milling and paving of various roads. Additionally, lateral support issues that affect county roads will also be addressed by improving drainage, stabilizing hillsides near roads, and rehabilitating and building new retaining walls where needed. Included again in the 2017 Roads Program is a plan for bike lane improvements and safety enhancements on various county roads as well as connecting new and existing bike lanes to existing trails.

#### PORT AUTHORITY PROGRAM

The 2017 Capital Budget provides a total of \$9.87 million in funding to the Allegheny County Port Authority for acquisition, construction and improvement of the public transportation system. For the most part, County funding represents 3 1/3% of the cost of a project and is matched by state funds (16 2/3%) and federal funds (80%).

The 2017 budget provides funding for improvements and upgrades to the Port Authority's fixed facilities and rolling fleet. These projects include Section 5307 Block Grants for Capital and Preventive Maintenance, Section 5339 Grants for Fleet Procurement, and Act 89 Funds. Combined, the match funding will allow the Port Authority to leverage an additional \$178.81 million in federal and state funds for its capital programs.

#### **PARKS PROGRAM**

The Parks program is budgeted at \$5.76 million in 2017. The county will continue its' program of upgrading facilities within the parks system. The 2017 budget provides continued funding for swimming pools, shelter and restroom renovations, as well as other park facilities. Also included are projects to provide improvements in all nine county parks, as well as a project to upgrade the maintenance equipment used throughout the county parks.

#### **BUILDINGS PROGRAM**

The majority of general government and court services provided by Allegheny County are housed in seven county-owned buildings located in downtown Pittsburgh. These buildings account for 1.6 million square feet of public and office space. Five of the buildings are historic landmarks of national or regional significance. The county is faced with the responsibility of maintaining the historical character of the facilities, while at the same time, meeting the ever-increasing demand for modern and efficient office and public space.



#### **BUILDINGS PROGRAM** (continued)

The Buildings Program is budgeted at \$17.15 million for 2017. The budget includes funding for the replacement of the Allegheny County Courthouse roof. The project is a comprehensive replacement of roofs on the Courthouse including the granite, tile, and metal surfaces. Another project allows for a major rehabilitation of Clack Building No. 1, which is occupied by the Health Department. Funding for this project will come from Clean Air and Title V funds.

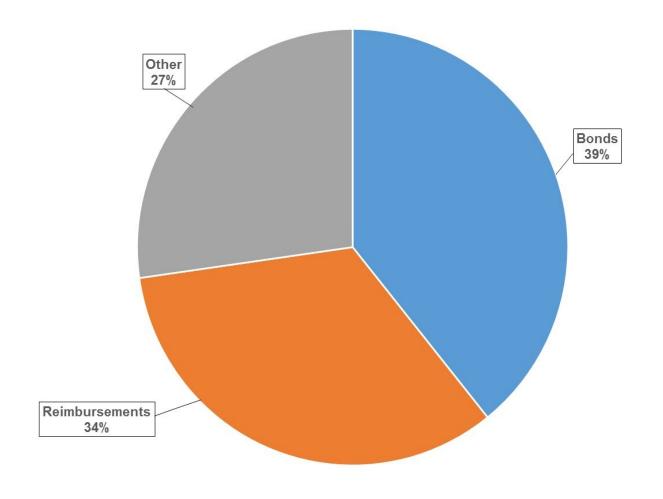
#### **EQUIPMENT PURCHASES**

The 2017, Capital Budget includes \$12.72 million in equipment purchases to upgrade outdated computer equipment in order to run new software operating systems, replace outdated and costly servers, continue the improvement of county operations, and replace equipment at the County Jail, Kane Regional Health Centers, and other departments throughout the county. The budget includes \$2.5 million for the scheduled replacement of heavy maintenance equipment and vehicles, as well as the county's over-the-road police, health, and public safety vehicle fleet. It also includes \$2.67 million for improvements to the 9-1-1 record management system. The new system will increase the efficiency and accuracy of the information collected and allow various municipalities to enter and share information.

#### **SUMMARY**

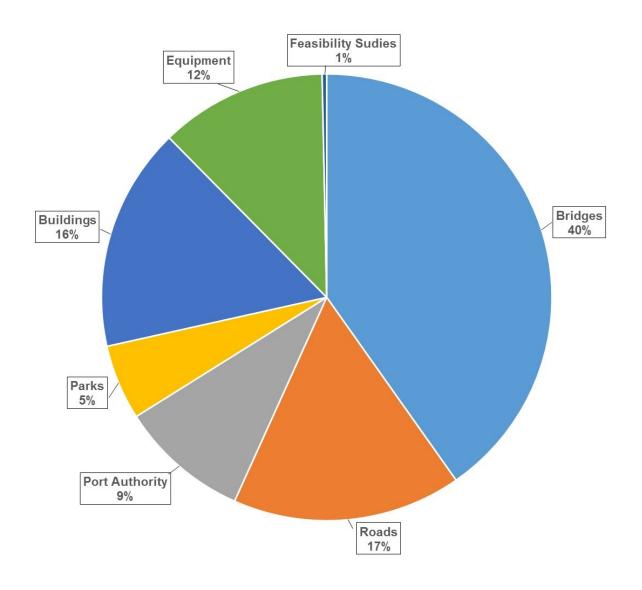

#### **Bridges**

#### PROJECT NAME: Murray (10th Street) Bridge

Project includes inspecting and repairing suspension cables as well as the superstructure support steel, drainage, and concrete repairs. This will be a significant upgrade to a major river crossing.

#### PROJECT NAME: Clemente (6th Street) Bridge

Rehabilitation of the Clemente (6th Street) Bridge, including structural steel repairs, deteriorated concrete repairs, deck replacement, and blast-cleaning and painting of the superstructure. This will be a significant upgrade to a major river crossing and historical landmark.

#### PROJECT NAME: Warhol (7th Street) Bridge

Rehabilitation of the Warhol (7th Street) Bridge, including structural steel repairs, deteriorated concrete repairs, deck replacement, and blast-cleaning and painting of the superstructure. This will be a significant upgrade to a major river crossing and historical landmark.

#### PROJECT NAME: Carson (9th Street) Bridge

Rehabilitation of the Carson (9th Street) Bridge, including structural steel repairs, deteriorated concrete repairs, deck replacement, and blast-cleaning and painting of the superstructure. This will be a significant upgrade to a major river crossing and historical landmark.

#### PROJECT NAME: Act 13 Highway Bridge Improvements

Act 13 of 2012 established a Marcellus Shale Legacy Fund. A portion of these funds are allocated and distributed to counties to fund the replacement/repair of locally owned at risk bridges. Act 13 requires PennDOT to approve a submitted "plan" to repair an at risk deteriorated bridge.

#### PROJECT NAME: Act 44 Highway Bridge Improvements

Act 44 established a transportation funding source for the improvement of structurally deficient bridges. A portion of these funds are allocated and distributed to counties to fund the replacement/repair of locally owned at risk bridges.

#### **Bridges** (continued)

#### **PROJECT NAME: Act 89 Highway Bridge Improvements**

Various structures have been identified for repair during 2017 and beyond. The repairs consist of emergency work, as well as work necessary to extend the useful life of the structures. Funding comes from Act 89 revenues distributed by the PA Department of Transportation based on Act 89 which was passed in 2013.

#### PROJECT NAME: Armstrong Tunnel Rehabilitation

Rehabilitation of tunnels that includes inspecting and repairing the concrete structure, replacing and upgrading all mechanical and electrical systems, drainage and concrete repairs, traffic analysis, and fire and life safety features upgrades.

#### PROJECT NAME: Bridge Preservation

This funding allows for the rehabilitation of eligible bridge structures through the use of Federal Preservation funds. The funding can be used for repairs that preserve existing structures by extending the useful life of eligible bridges.

#### PROJECT NAME: Dooker's Hollow Bridge Reconstruction

Rehabilitation of the Dooker's Hollow Bridge, including deck replacement, expansion dam replacement, deteriorated concrete repair, structural steel repair and painting.

#### PROJECT NAME: Kenmawr/Talbot Avenue Bridge Rehabilitation

Rehabilitation of the Kenmawr Ramp and Talbot Avenue Ramp bridges including structural steel, concrete repairs, and painting.

#### PROJECT NAME: Miscellaneous Bridge Construction

This request is for funding of various bridge repair and replacement projects that are eligible for 80% reimbursement from the Commonwealth of Pennsylvania.

#### **Buildings**

#### PROJECT NAME: Miscellaneous Bridge Design and Repair

Various structures and approaches are identified for repair including emergency work and work designed to extend the useful life of structures and approaches. These repairs are for projects that are not eligible for Act 44, Act 13, Act 89 or other alternative funding sources.

#### PROJECT NAME: Small Bridge Inspection

This is to fund bridge inspections of county owned structures that are under 20' in length. Inspections are done on a bi-annual basis as required to make sure there is not a public safety hazard.

#### PROJECT NAME: Clack Building No. 1

This project will provide funding the design and construction for the renovation of the Allegheny County Health Department Clack Building No. 1. Funding from this project will be provided by Title V and Clean Air funds.

#### PROJECT NAME: County Office Building (COB) Fire Alarm

Project allows for continued funding for the replacement of the current fire alarm panel and detection system with a system that is compliant with current codes and safety standards. This will provide a significant safety upgrade to the employees and public that use the COB every day.

#### PROJECT NAME: Controller's Office Accounting Division Cubicles

Project will allow for replacement of cubicles and other office furniture for room 221.

#### **PROJECT NAME: County Elevator Upgrades and Repairs**

The project will fund the maintenance of the elevators at county facilities. This funding will be used to modernize and repair the elevators as needed to ensure accessibility in county facilities.

#### **PROJECT NAME: County Facility Building Improvement Projects**

Project will provide improvements and repairs at the county's facilities as needed. Project will include electrical, plumbing, and mechanical issues throughput the county.

#### **Buildings** (continued)

#### **PROJECT NAME: County Roof Repair and Replacement Projects**

Various county facilities have roofs that are in need of repair or replacement. Roof repairs are needed to avoid the possibility of water damage to county facilities.

#### **PROJECT NAME: Courthouse Roof Replacement**

After completion of the Courthouse facility plan, it was evident that the existing roofs have outlived their 100-year lifespan. This project is a comprehensive roof replacement for the various roofs on the Courthouse which include granite, tile, and metal roofing.

#### **PROJECT NAME: Courtroom Improvement Projects**

Project will fund improvements including flooring, window shades, heat pumps, and wiring in Court facilities.

#### **PROJECT NAME: In-House Capital Construction**

Project will fund the cost of material, supplies, and labor to be used throughout the county to upgrade restrooms, renovate offices, perform structural repairs, and replace fixtures as needed.

#### **PROJECT NAME: Jail Improvement Projects**

Project will provide improvements and repairs at the Jail including electrical, plumbing, and mechanical issues as needed.

#### PROJECT NAME: Jail Roof Replacement Phase 2

The Jail roof is nearing the end of its useful life. Phase 2 will further prioritize sections that are in need of replacement.

#### **PROJECT NAME: Kane Improvement Projects**

Project will provide improvements and repairs at the Kane centers including electrical, plumbing, and mechanical issues as needed.

#### **Buildings** (continued)

#### **PROJECT NAME: Kane McKeesport Secure Unit**

Project will allow for renovations at Kane McKeesport to create a secure Behavioral Specialty Unit.

#### **PROJECT NAME: Open Ended Architectural Services**

Funds will be used for an open end architectural agreement to allow Facilities Management, Parks, and Public Works to secure architectural services on an "as needed" basis for various county projects.

#### **PROJECT NAME: Shuman Improvement Projects**

Funding for repairs and renovations to the Shuman Juvenile Detention Center as needed including electrical, plumbing, and mechanical issues that occur throughout the year.

#### PROJECT NAME: ACES 9-1-1 Record Management System (RMS)

Upgrade RMS that is used by Emergency Services to increase efficiency and accuracy of information.

#### PROJECT NAME: ACES Fire Academy Equipment

Project will allow for equipment purchases needed to contact hands-on and classroom training at the fire academy.

#### PROJECT NAME: Allegheny County Jail (ACJ) Medical Unit Electronic Health Records

Project is to improve safety for bicycles throughout the county as biking becomes more prominent in the region. The project also includes the long term goal to connect existing and new bike lines with existing trails.

Funding provides construction management, inspection, and testing services on an "as needed" basis on various county roadway, bridge, building, and parks projects.

#### **PROJECT NAME: Geotechnical Investigations**

Funds will be used to perform investigations of geotechnical hazards that affect county roads and facilities and also to prepare designs for remedial measures.

#### **PROJECT NAME: Guiderail Repair and Improvements**

Allegheny County is responsible for over 400 miles of roads and must maintain the guide rails on the roadway when damaged and needs replaced as well as install new guide rails where needed.

#### PROJECT NAME: In-House Paving Program

Funding for the annual program of upgrading existing roadways and parking lots with new wearing surfaces using in-house forces. With maintenance responsibility for over 400 miles of roadway it is necessary to have a comprehensive annual program of pavement rehabilitation and replacement.

#### **PROJECT NAME: Lateral Support Projects for County Roads**

Funds will be used to address lateral support issues throughout the county. This includes building new and rehabilitating existing retaining walls, stabilizing slopes adjacent to county roads, and realigning roads when necessary.

Funding provides supplemental engineering services that allow for immediate response to emergency and critical needs as they arise. This contract expedites projects and provides engineering services for needs that require the department's timely reaction to unforeseen conditions.



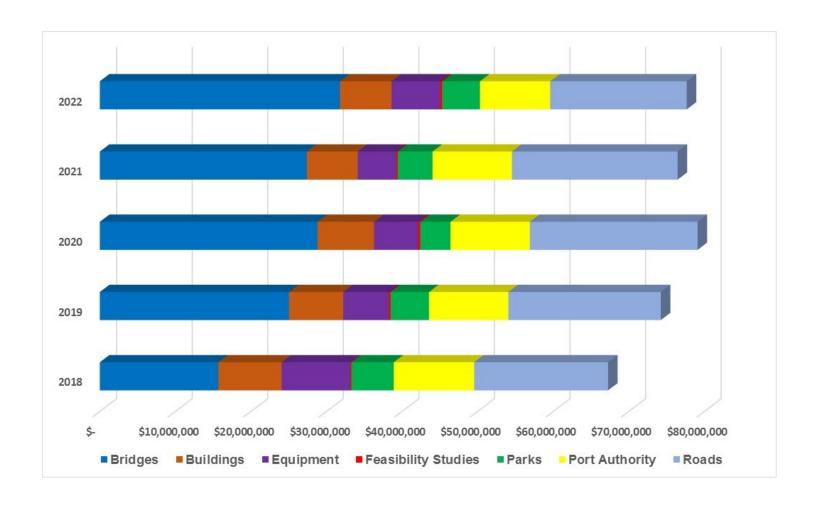
### FIVE-YEAR CAPITAL IMPROVEMENT PLAN

The document that follows is the Five-Year Capital Improvement Plan for Allegheny County. The Capital Improvement Plan is a five-year strategic planning instrument utilized by Allegheny County government to identify and plan for capital projects. It is also used to coordinate the financing of capital projects in order to maximize the benefits to the public.

The Capital Improvement Plan is a guide for expenditure decisions and not necessarily a firm commitment, as priorities and needs may change from year to year. This document has been prepared based on the priority of identified projects and the funding available. The mix of projects in the Capital Improvement Plan is evaluated annually. Projects are added or subtracted based on priority and available funding.

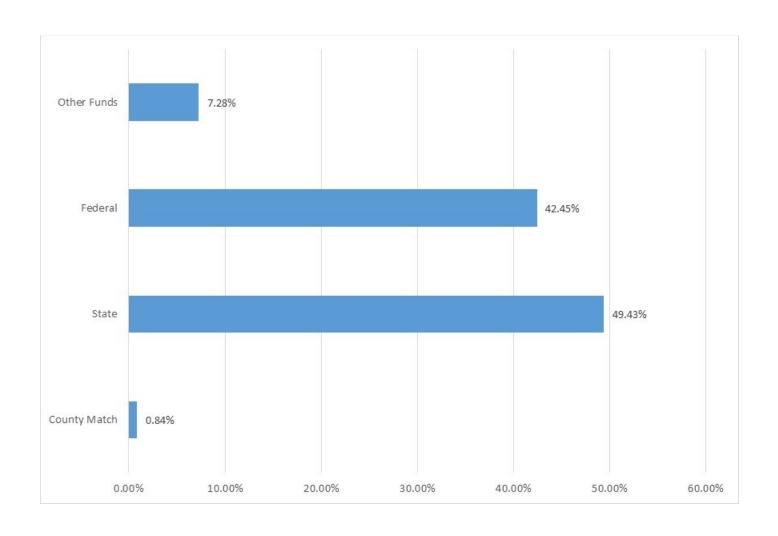
## 2017 GRANTS BUDGET SUMMARY

The 2017 Grants Budget is separate and in addition to the Allegheny County operating budget. Grants are the vehicle through which Allegheny County secures special purpose federal, state and private agency funding to implement programs which enhance services to the public. The grants are distinct from the operating budget and based on a contract or agreement with a specific sponsor that defines required activities. The grant is given a unique identification number in the county accounting system that enables grant tracking and reporting to sponsor agencies. The appropriation for expenditures is based on the grant agreement and/or the Notice of Grant Award (NoA), and is limited by the funding revenue and any match requirements. The grants presented in this document have individually defined performance periods determined by the sponsoring agency. These performance periods are often not concurrent with the county's fiscal year. The 2017 grant budget appropriation represents funding for calendar year 2017 period of activity. In the case of multiple year grants, the 2017 budget is an estimate of the 2017 expenditures only. The goal of this presentation is to show the breadth and scope of the resources available to the citizens of Allegheny County in 2017.

#### **PROCESS**

The individual departments, including county departments, Court related offices and row offices submitted their active grant requests to the Department of Budget and Finance through September 23, 2016. Each submission captured all pertinent individual grant information including funding source, total grant award, expenditure categories and a brief project description of grant activities.

This grant from the State Justice Institute will involve the Allegheny County JPO and the Juvenile Judges Commission working with consultants from the National Center of State Courts (NCSC) to implement at least two of the NCSC CourTools.

The Criminal Justice Assistance Fund is for contributions of funding from Allegheny County departments and/or agencies that will be used by the Sheriff's Office for law enforcement purposes. The establishment of this fund is at the recommendation of the Controller's Office.

The Law Enforcement Services Fund is for contributions of funding from governmental departments and/or agencies, or other public or private funding that will be used by the Sheriff's Office for law enforcement purposes.

### **73-District Attorney**

PROJECT TITLE: Automobile Theft Prosecution

PROJECT #: 73010134

The Automobile Theft Prosecution Unit is comprised of one Assistant District Attorney and one paralegal who work in cooperation with the PA State Police and Pittsburgh Auto Squad and are dedicated to aggressively prosecuting and assisting in the investigation of cases of vehicle theft in Allegheny County.

### PROJECT TITLE: Automobile Theft Task Force

PROJECT #: 73010133

Two detectives are assigned to the Municipal Automobile Theft/Motor Vehicle Insurance Fraud Task Force Program of the PA State Police. This task force coordinates statewide law enforcement activities related to automobile theft and motor vehicle insurance fraud prevention, investigation and enforcement. Grant funds reimburse County for salaries, fringes, vehicles and training and education for detectives assigned to the task force.

#### **PROJECT TITLE: Insurance Fraud**

PROJECT #: 73010135

Grant funds expenses including salaries and fringe benefits of the Insurance Fraud Prosecution Unit. This unit is comprised of one Assistant District Attorney, two detectives and one paralegal dedicated to aggressively investigating and prosecuting cases of insurance fraud in Allegheny County.

#### PROJECT TITLE: STOP Grant

PROJECT #: 73010128

Through PA Commission on Crime and Delinquency (PCCD), a portion of state funding is used toward the salary and fringe benefits for one Assistant District Attorney (ADA) in the Domestic Violence Prosecution unit and the remainder is provided to five victim service agencies which provide services to victims of domestic violence and training to law enforcement on domestic violence. The remaining salary and fringe benefits of the ADA is funded through operating. The Violence Against Women Act mandates the dollar amount of PCCD funds to allocate to each initiative under the grant: \$35,000 prosecution, \$60,000 victim services and \$30,000 law enforcement.

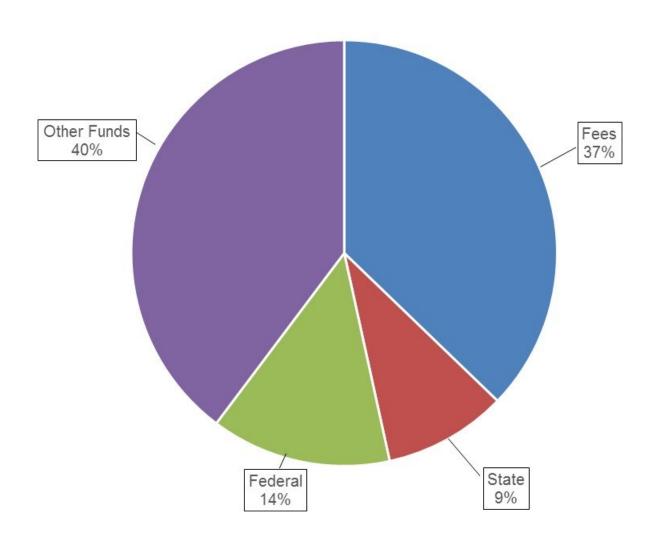




# **2017 SPECIAL ACCOUNTS SUMMARY**

#### AGENCY FUND BUDGET

The Allegheny County Administrative Code requires the preparation and approval of an Agency Fund Budget. The Agency Fund Budget, classified as Fiduciary Funds, is used to account for assets held by the county in a trustee capacity and is collected from fees, fines, taxes and miscellaneous items held by the County on behalf of, or as an agent for, individuals, private organizations and other governmental units.

As of December 31, 2015 the Agency Fund had total assets of \$47.94 million dollars. Forty accounts comprise the current Agency Fund. The Agency Fund includes the Pittsburgh Convention and Visitors Bureau Room Tax account, Municipal Waste Landfills account, the Air Pollution Clean Air account and custody accounts for Kane Hospital patients, just to name a few. A complete listing is provided.

#### **HOTEL ROOM RENTAL TAX**

This tax is used primarily for debt service related to the David L. Lawrence Convention Center, managed by the Sports and Exhibition Authority, and operating support for the Pittsburgh Convention and Visitors Bureau. The following is a brief description of the Hotel Room Rental Tax:

The Hotel Room Rental Tax is a tax not to exceed 7% which is imposed on the consideration received by each operator of a Hotel within Allegheny County from each transaction of renting rooms or rooms to accommodate transients. The tax collected by the Hotel operator is paid over to the County in accordance with rules and regulations concerning the collection of the tax established by the County's Treasurer. The County Treasurer shall collect the tax and deposit the revenues received in a special fund.

#### 2017-2021 FIVE YEAR FORECAST

Since the Hotel Room Rental Tax is the most prominent Agency Fund, we have included a five-year forecast of revenues and expenditures. Recipients and their allocation of the funds are statutorily defined. Allocations are made for debt service on the convention center bonds, funding for the Pittsburgh Convention and Visitors Bureau, the Borough of Monroeville for the Expo Mart successor, an administration fee to Allegheny County, and a convention center subsidy to the Sports and Exhibition Authority.
