MS. BYRD-SMITH: Thank you.

MS. MEANS: Then you're up.

MS. BYRD-SMITH: I'd like to thank, first of all, my boss, County Manager William McKain, the county executive and naturally, county council and Councilwoman Means.

This means a lot. This gentleman, if you've ever ridden on the long-term shuttle at the airport, he owns the long-term shuttles. And if you can imagine the amount of money and the amount of angst you had to have over a 30 year period in doing that job, you don't know business.

So I would like to just say this, and I was a young girl when this happened. Just keep that in mind. I did the original write-up for this gentleman to become a certified firm with Allegheny County, so --- but I was a young girl.

MR. EVERETT: Thank you so much and you make me sound so old.

Yes, I'm the best kept secret in Allegheny County. You ever see those shuttle buses at the airport? That's me, seven days a week, 24 hours a day and I have stories. People want me to write a book --- and I won't.

I had to work somewhere else to feed the family. Twelve (12) years, no family vacation. Can't tell you how many Thanksgiving dinners I missed. I can't tell you --- Christmas morning, you get up to open gifts. I get up to make sure we're running, because Christmas morning is busy --- flights. That's what I mean. Hard work, sacrifice. But I love it. When I'm behind a microphone, I want to share some wisdom with you.

You liked the shoebox story?

MS. MEANS: Yeah.

MR. EVERETT: All right. I'm going to tell you the shoebox story. This is for everybody in the room, so pay attention.

My mom taught me how to save. All right? So I go into business. I'm a hotshot out of college. I think I know everything. But it's --- we managed the unknown. All right? You can get a text message, an e-mail. You can open up an envelope --- just a piece of mail, and it ruins your day, your week, your year.

Well, my mom taught me how to save. It was the old Christmas club saving. So I would save \$20 a week in a shoebox and hid it. Nobody knew where it was. But every holiday season, you had \$1,000. So if you had an unexpected car repair, you know, the gas bill came in too high or whatever, one of the kids needed something, I would go to that shoebox.

And let me tell you what, everybody. You will go to that shoebox and you will be thankful of this story. I want everybody here, starting this week, save \$20 a week, but don't tell anybody. Okay?

And that's the wisdom I have to share with you today, and I want to thank you all so, so much.

MR. DEMARCO: Thank you, Mr. President (adjusts microphone).

We're here today to ask all of our citizens on Veterans Day to acknowledge the courage and fortitude of our veterans and realize the importance of keeping their legacy engraved through time.

Representing Michael Palarino, the Executive Assistant of Veterans' Services today, is Jerry Tyskiewicz, Director of Administrative Affairs.

MR. TYSKIEWICZ: Yes, sir.

MR. DEMARCO: Or services, I apologize.

As everyone knows, on Saturday, November 11th, it's Veterans Day. And this proclamation we've prepared of behalf of council says ---

WHEREAS, valor is stability, not of legs and arms, but of courage and the soul. That quote by an ancient philosopher demonstrates the resolute spirit and unmatched selflessness that our nation's brave men and women of our Army, Navy, Air Force and Marine Corps and Coast Guard embody; and

WHEREAS, on Veterans Day, we reflect upon the immense burden so many took upon themselves when they decided to wear America's uniform and the families who stood alongside them. We salute those men and women for their service, and we express our perpetual gratitude; and

WHEREAS, more than 1,200,000 Pennsylvanians are veterans, comprising 14 percent of the state's population, and a great percentage of those veterans reside here in Allegheny County; and

WHEREAS, our nation and Allegheny County understand the true significance in taking care of our veterans when they return home. It is important that we are committed to ensuring that when our heroes return home, that they have every opportunity to experience the American dream that they risk their lives to defend; and

MR. ELLENBOGEN: Mr. President, point of personal privilege?

PRESIDENT DEFAZIO: Yeah, what's your point?
MR. ELLENBOGEN: I just wanted to say that those of us who have been on council for a number of years remember that every Veterans Day, a contingent of combat World War II veterans would come and accept a proclamation.

And over the years, as --- as --- as many of them have passed and dwindled, and this year, there are none, there's like a sadness about it. And they were the greatest generation, so just --- you know, thank you.

MR. DEMARCO: Thank you very much, Councilman Ellenbogen, for mentioning that.

Right now, a large number of the veterans are down in Washington, DC where they traveled because there's a ceremony commemorating the 50th anniversary of the Vietnam War, and they're down there to celebrate and have a celebration there --- a ceremony on the wall.

MR. ELLENBOGEN: I appreciate you carrying it on there, Councilman.

MR. DEMARCO: Thank you very much, Councilman. Thank you, Mr. President.

Jerry, do you want to say anything?

MR. TYSKIEWICZ: As Councilman DeMarco said, Michael Palarino couldn't be here. He had a family emergency, so I am kind of pinch hitting in an emergency. So I promise you that my remarks will be brief.

On behalf of the county executive Department of Administrative Service and the Division of Veterans Service, we'd like to thank you for the proclamation. We also want to thank all the veterans for their services to the country and to ensure the Department of Veterans

Services will continue to serve both you and your families.

I believe Veterans Day can best be summed up by the words of then candidate Calvin Coolidge in 1920 when he said the nation which forgets its defenders will be itself, forgotten. Thank you.

PRESIDENT DEFAZIO: Thank you.

We now have public comment on agenda items. Want to read them?

MR. BARKER: First up is Ray Firth.

PRESIDENT DEFAZIO: Give --- give the --- go ahead.

MR. FIRTH: Good evening. I'd like to speak this evening on lead poisoning.

PRESIDENT DEFAZIO: Would you give your name and ---?

MR. FIRTH: Sure.

My name --- my name is Ray Firth.

PRESIDENT DEFAZIO: And your address?

MR. FIRTH: 816 Sweetleaf Drive, Monroeville,
Pennsylvania.

PRESIDENT DEFAZIO: Thank you.

MR. FIRTH: I'm a constituent of Dr. Martoni's, and my wife said I can't do this under three minutes but I'm going to show her I can.

Lead poisoning can and should be prevented. Infants and toddlers take in lead from multiple sources, dust from paint, water and soil. In the first three years of life, young children's brains, their neurons and brain cells are in an amazing period of growth and forming new connections.

It's at this critical stage of development that the neuron responsible for learning and emotional development can be permanently damaged by the presence of even minute amounts of lead. Lead is a neurotoxin. It kills cells and damages nerves. There are no effective treatments to reverse the loss of these cells and nerves in a child's brain.

It's been well known for many years, even back to Herb Needleman's work here in Pittsburgh, that if we wait to remove the source of lead from the windows in the family's dining room or the water at the childcare center, and if we wait until after young children have been poisoned and then wait for a blood test to confirm they've been poisoned, it's too late. The damage has been done. Cells are dead, nerves are damaged.

We need to remove the lead from a child's environment before they put the paint dust from the window in their mouth or drink the baby formula made with water containing lead. If we wait and the toddler ingests the lead, a few years later when they start elementary school, they're more likely to fail third grade math and reading proficiency tests. And we wonder why there's an achievement gap. And they're more likely to be suspended from school.

If a young girl has been poisoned as a toddler, years later when she marries and becomes pregnant, the lead will pass to her baby through the fetus and harm their infant's development.

In school districts with a large number of children enrolled who had elevated blood lead levels as a toddler, the school district will have more children in

special education and more children being suspended, but it won't be linked to their lead poisoning.

The county can prevent lead poisoning. The Pennsylvania local health administration law has empowered Allegheny County with both the responsibility and the authority to prevent lead poisoning and to remove lead hazards. In the 2018 county budget that you're now considering, please add funding for primary prevention of lead poisoning so the county executive can eliminate lead hazards before they damage the developing brains of the next generation of infants and toddlers in Allegheny County.

Thank you for listening.

PRESIDENT DEFAZIO: Thank you.

(Applause.)

MR. FIRTH: It was close --- it was close.

Thank you.

MR. BARKER: Next up is Jacob Mirra.

MS. FYOCK: I'm helping you.

MR. MIRRA: You have your work cut out of you.

MS. FYOCK: I know. Good luck. Right? Is it

in order?

MR. MIRRA: Yep, they sure are.

MS. FYOCK: Okay.

MR. MIRRA: So if you could just show the room the --- there you go. Great. Just hold up the first one.

MS. FYOCK: Okay.

MR. MIRRA: Hello. Thanks for taking the time to listen. My name is Jacob Mirra. I'm a citizen and resident of Shadyside. I believe that makes me District 11, so thanks for representing me on the council. I believe that's Mr. Klein, Shadyside?

MR. KLEIN: Yes.

MR. MIRRA: Thank you, and thanks to all the council.

For anyone in this room who isn't completely up to date on the issue of gerrymandering, I have a few graphics I'd like to share. My friend Deborah is holding up the congressional map of Pennsylvania. We have 18 seats in the House of Representatives.

I drew this map myself. It was --- it was --- it was --- it was challenging. The --- it's --- it's a bit of a mess, especially like trying to get a good picture of Goofy kicking Donald Duck in District Seven.

That's kind of --- it's hard to see from where you are, but the districts have these funny shapes.

But the --- they're not just meaningless Rorschach tests. Actually, the shapes of these districts have consequences. For example, in that district I just referred to, there are 367,000 people who voted, but they only get one representative.

Deborah, if you'd hold up the next graphic --this next graphic is the same congressional map colored by
popular vote. I tried to color code it as best I could.
So most of Pennsylvania's pretty purple. There are
islands of blue, some red. Some of those red districts,
people ran unopposed, I should mention. So I --- I was
only coloring the vote for the Pennsylvania House.

And --- but you see, it doesn't matter whether you win by a hair or a landslide, you see. This dividing line between bluish purple and reddish purple, that's what decides who gets that seat.

So Deborah, if you'd hold up the next graphic ---

MS. FYOCK: Yep.

MR. MIRRA: --- this one --- this is the result of that election in the House of Representatives, you see. So it's --- it's just 13 red districts and five blue, which is vastly out of proportion with the popular vote. I hope everyone got a look at that because I have a pie chart of the --- our Pennsylvania House of Representatives.

There you are. Thanks, Deborah.

MS. FYOCK: Uh-huh (yes).

MR. MIRRA: And although the popular vote was just about evenly split 50/50 in 2016, that's not what happened with our representation which ended up being, as just mentioned, 5 blue, 13 red. This is caused by gerrymandering. However, it's not so simple. You --- you can't just draw district lines and --- and get an advantage. It's a complex process.

But one thing we do ask for is that an independent commission be --- exist to --- apologies --- an independent commission exist to pass --- to draw the district maps rather than having a conflict of interest of having out legislators doing it for themselves. Thank you.

(Applause.)

PRESIDENT DEFAZIO: Okay. Okay. Next.

MR. BARKER: Next is Deborah Fyock.

MS. FYOCK: Thank you. My name is Deborah Fyock. I'm in County Council District 11. I don't know if you need my address as you did with the other gentleman, ---

PRESIDENT DEFAZIO: Yeah.

MS. FYOCK: --- 502 Cathedral Avenue,

Pittsburgh.

PRESIDENT DEFAZIO: Okay.

MS. FYOCK: Thank you for hearing us and acting on this issue. I'm asking for you to unanimously pass tonight's motion in support of the goal of redistricting reform. I have two points to make --- to explain why I think this is so important for each of us, our state and our nation.

One, the claim has been made that continuing to perform the same action expecting a different outcome is the definition of insanity. Yet a majority --- a majority of Pennsylvania voters have, in the past eight years, continued to go to their polling places with the knowledge that their active voting will likely not produce a different out --- different outcome. That due to gerrymandering, their vote is effectively been rendered ineffective.

One could say these voters are even crazier than the definition. They continue to vote with the almost certain knowledge that it will change nothing. These voters are far from crazy, and there are a lot of them. They're disenfranchised and they know it. Where is the incentive to participate in the democratic process? You'd almost have to be crazy; wouldn't you?

Number two, the manipulation of electoral district lines is not only an effort made by state politicians to favor a particular party, but as strong support from the national party in question.

Once a majority of the districts have been secured in a given state, our state, the national party in --- the national party, who has their own vested interest, not necessarily Pennsylvania voters' interest, can take its eyes off the super secure districts that they have helped secure and target dollars and effort toward the few remaining unsecure state districts to help produce an even more favorable outcome.

In this case, they're happy to expect the same action and --- that will indeed produce the same super

secure outcome. They can move on in efforts to actually produce different outcomes in districts where they will now have the time and dollars to initiate such a new action. They can also call the shots and call in favors with the legislators that they have been helping all along.

Not so crazy, and not representation that in any way reflects our state, our districts, our people and our parties --- all of our parties. I'm asking county council to help stop the insanity, take action to support the resolution in support of redistricting reform and help us get a new outcome that everyone can get behind. Thank you.

(Applause.)

PRESIDENT DEFAZIO: Okay.

MR. BARKER: Last up is William Anderson.

MR. ANDERSON: Hello, my name is William

Anderson. I live at 7035 Chaucer Street. I'm in Councilman DeWitt Walton's district.

And I'm here today speaking on behalf of Fair Districts PA. I'm also a member of B-PEP, the Black Political Empowerment Project. And our Chairman, Tim Stevens, has sent the letter in support of the issue of fair districting to council, which all of you should have --- should have received by now.

And I'm here to ask and thank you for the motion that is on your agenda today and ask that there is --- as our --- the speaker before me said, there is a unanimous, you know, passage of this resolution because this is and should be a nonpartisan issue. And we are asking that the state legislature and the Senate pass the Senate Bill 22 and House Bill 722.

And as it was spoken earlier, this Bill would essentially take the politics out of our redistricting in the Commonwealth of Pennsylvania. Because as --- as it sits now, there are five members of a redistricting committee, two democrat, two republican and the fifth is usually decided by the Pennsylvania Supreme Court. And which ends up --- after they draw the lines, it ends up right back to the Supreme Court.

So we want to take the politics completely out of our redistricting so that the districts are drawn concurrently and they are in representation of the people that live in the district, so that someone that lives on the western part of the state isn't represented by someone

that has no knowledge or any connection with that community.

And as we have seen what's going on in our district where we've lost Senator Ferlo because of redistricting, that the people in the district are neglected. And those that need the most services aren't given those services because the person that is selected by a party does not represent the interest of that community or that person or the constituent.

So we're here to ask that you unanimously, you know, pass that --- pass this motion, I guess it is, not a resolution --- to ask that and encourage all of our elected officials that statewide, that they press --- press forward on this issue.

And we would like to applaud, you know, Councilman Klein for coming up with this motion and being in full support and out in front of this issue. And we need all of our councilmen to --- and councilwomen to represent the constituents of their districts which all unanimously, you know, are for an independent appointed committee that will be appointed by the people, and it will take politics out of our redistricting and the redistricting of our communities across the Commonwealth of Pennsylvania.

So as we are all, you know, registered voters, we saw that the turnout of the election yesterday, which nobody --- you know, of course people won offices, but nobody won based on the turnout of 23 percent in our county. And a lot of this is because people are discouraged of the system. They aren't confident.

And this --- it's just one thing that will restore the confidence of the people in the electorate and your elected office. So again, I thank you and ask for your full support.

(Applause.)

PRESIDENT DEFAZIO: That's all the speakers?

MR. BARKER: That's it.

PRESIDENT DEFAZIO: That's it. We have no approval of minutes?

MR. BAKER: None. Correct.

PRESIDENT DEFAZIO: All right. We go to 10381-

17.

PRESIDENT DEFAZIO: That'll go to Appointment Review Committee. 10382-17.

MR. BARKER: Approving the reappointment of Austin Davis to serve as a member of the Minority Business Enterprise Advisory Committee for a term to expire on December 31st, 2020. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll go to the Appointment Review Committee. 10383-17.

MR. BARKER: Approving the appointment of Marianne Malloy to serve as a member of the Personnel Board for a term to expire on December 31st, 2018. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll go to Appointment Review Committee.

Unfinished business, 10321-17.

MR. BARKER: Approving the reappointment of Ed Sperling to serve as a member of the Allegheny County Board of Property Assessment Appeals and Review for a term to expire on January 1st, 2021. Sponsored by Council Member Baker.

PRESIDENT DEFAZIO: Representative Palmiere, did you chair the meetings?

MR. PALMIERE: Yes, I did.

PRESIDENT DEFAZIO: Go ahead.

MR. PALMIERE: Mr. President, thank you. First of all, I'd just like to say I was honored to be able to fill in for Ed that particular evening. And the quality of people that are being appointed to these various boards are --- are just outstanding. And once you have an opportunity like we've had to interview them and get to know them, it's really been a --- an eye opener for us and it's --- it really helps us to know that Allegheny County and all these various committees are being served very well.

So I move for approval, Mr. President.

MR. MACEY: Second.

PRESIDENT DEFAZIO: Under remarks? Seeing none, all those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT DEFAZIO: Opposed? The ayes have it. Let's see --- 10323-17.

MR. BARKER: Approving the reappointment of William Brooks to serve as a member of the Redevelopment

Authority of Allegheny County for a term to expire on May 23rd, 2022. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: Representative Palmiere?
MR. PALMIERE: Thank you, Mr. President and --and members of Council. Again, the same thing applies
here. Mr. Brooks is very qualified to serve on this
committee and I move for approval.

MR. MACEY: Second.

PRESIDENT DEFAZIO: Under remarks?

Seeing none, all those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT DEFAZIO: Opposed? The ayes have it. 102 --- 10325-17.

MR. BARKER: Approving the reappointment of Barbara Parees to serve as a member of the Minority Business Enterprise Advisory Committee for a term to expire on December 31st, 2020. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: Representative Palmiere?

MR. PALMIERE: Thank you, Mr. President and
members of Council. Again, same thing applies here.
Barbara Parees is very --- very competent, very qualified
to serve on this and I move for approval.

MR. MACEY: Second.

PRESIDENT DEFAZIO: Under remarks? Seeing none, all those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT DEFAZIO: Opposed? The ayes have it. 10325-17.

MR. BARKER: I'm sorry, 10326?

PRESIDENT DEFAZIO: I'm sorry, 10326-17.

MR. BARKER: Approving the reappointment of Abass Kamara to serve as a member of the Minority Business Enterprise Advisory Committee for a term to expire on December 31st, 2020. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: Representative Palmiere?

MR. PALMIERE: Thank you, Mr. President and members of Council. Again, Mr. Kamara is one of the outstanding people getting ready to serve on this board here and I move for approval.

MR. MACEY: Second.

PRESIDENT DEFAZIO: Under remarks? Seeing none, all those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT DEFAZIO: Opposed? The ayes have it. 10300-17.

MR. BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing Allegheny County Budo-Kai to use a structure on Brownsville Road in the County's South Park. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: Representative Palmiere?
MR. PALMIERE: Mr. President, members of
Council, Mr. Baechle, I'd like you to come up please and
explain to the council people that weren't here for that
--- these committee meetings to --- just give a brief
synopsis of what's going on here, please.

MR. BAECHLE: Thank you, Councilman. Budo-Kai has been in South Park for 31 years. They provide a site for patrons to participate in martial-arts related activities, separate classes for youth and adults. Instruction is in Jiu-jitsu, Karate Okinawa style. The instructors are internationally certified.

Benefits of martial arts are physical and mental. They provide adaptations for special needs participants. They're very low cost and again, they've been in the fairgrounds for 31 years. \$200 a month rent is what they pay.

MR. PALMIERE: Mr. President, this also met with an affirmative recommendation.

PRESIDENT DEFAZIO: Okay.

MS. MEANS: I'd like to make a motion to accept.

MR. MACEY: Second.

PRESIDENT DEFAZIO: Under remarks? Seeing none,

I guess we will take the --- take the vote?

MR. BARKER: Mr. Baker?

PRESIDENT DEFAZIO: Yes.

MR. BARKER: Ayes 14, nos zero. The bill

PRESIDENT DEFAZIO: Was that 10300?

MR. BARKER: That was double zero, correct.

PRESIDENT DEFAZIO: Okay. Go on to the next

page, we will have 10301-17.

MR. BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing Mon Valley Express Drum and Bugle Corps, also known as Mon Valley Express, Incorporated, to use a structure on Brownsville Road in the County's South Park. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: Representative Palmiere?

MR. PALMIERE: Mr. President, again, Mr. Baechle will explain this. This also was met with an affirmative recommendation.

MR. BAECHLE: This is another three year contract. They pay \$200 a month. It's in one of the exhibit buildings in South Park. They've been there for 11 years. They provide a training site for music related activities. The only competitive drum corps in Western Pennsylvania, it provides an opportunity for local patrons and participants in various marching band activities and competitions. They assist surrounding high schools in providing equipment and additional training for school competitions. They provide adaptations for handicapped band participants, are frequent visitors to parades sponsored by local municipalities.

MR. MACEY: Make a motion to approve.

(Chorus of seconds.)

PRESIDENT DEFAZIO: Under remarks? Seeing none,

we'll have the roll.

MR. BARKER: Mr. Baker?

MR. BAKER: Yes.

MR. BARKER: Mr. Catena?

PRESIDENT DEFAZIO: 10338-17.

MR. BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing OTB Bikeworks to use a structure on Pearce Mill Road in the County's North Park known as the North Park Boathouse. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: Representative Palmiere?

MR. PALMIERE: Thank you, Mr. President and members of council.

This --- this one here is relatively new and --- and much more --- it's much more beneficial to the county and I --- I want Mr. Baechle to please explain it. Thank you.

MR. MCKAIN: And Andy and I are going to double team this one. So as Mr. Palmiere said, this has been a wonderful partnership with OTB the last five years. Andy will tell you about the operational type of things that they do, but --- a couple things.

One is if you go there now, it is vibrant. It complements the park so well. It helps make North Park a destination --- a place to visit. Prior to them coming in, Andy and his team put out RFPs and there just wasn't a match. That place was storage area for the boats out there.

And now when you go to North Park, you can park in that parking lot, rent a bike, 5.2 miles around the lake. Perhaps kayak, perhaps do the zip line, perhaps enjoy the other amenities in the park. And come back to that restaurant and have a meal and look over that wonderful lake. So they've been a wonderful partner.

Some of the numbers that Andy has negotiated with them, remember that they were a new entity. They didn't know how they were going to do. So the first five years, they paid us about --- they paid us \$240,000. What they've asked is for an extension of 11 years, because that brings them to 16 years, which is the loan that they have with their financer --- with their bank. It also gives their employees the confidence that they are going to have employment there.

The next five years out of the 11, they are going to pay us \$585,000. And the next six years after that, they're going to give us even more. So just to give some perspective, the first year that they were in existence, they gave us \$36,000. At the end of this lease, if council approves this, they'll be paying us \$144,000 a year.

Some other numbers --- the first five years, \$240,000. If you approve this, over the next 11 years they will be paying us \$1,400,000. In addition to the revenues, just to give you a little bit of flavor of the type of partner that they are, they also donate to Trail Pittsburgh. Trail Pittsburgh helps coordinate Andy --- efforts with his team for the trails and the parks.

They also --- every year under this leaf will

--- lease will donate \$6,000 a year to our Parks Foundation that I know that you all know works so hard and closely with us.

And they're also going to make some capital improvements outside of their facility to make it more enjoyable for people that visit there and they're waiting for restaurants.

That building was dilapidated. It was a partnership between them and the county to restore it. We still get revenue upstairs. We rent that. We rent that upstairs. It's air conditioned and people enjoy it and it's really something that we strongly recommend. I --- I really think it's a model for government and private public type of partnerships.

But I'd like Andy to maybe tell you a little bit more about the operations and --- and his relationships with them.

MR. BAECHLE: Okay.

So they're so successful, we had to build two more parking lots across the street from the boathouse. They fit well in the parks. It's created a hub with Go Ape, the --- the restaurant there, the tennis courts. They pay all the utilities. They pay for the insurance and they're good partners to work with.

PRESIDENT DEFAZIO: John, did you make a motion?

MR. PALMIERE: Move for approval, ---

MS. MEANS: Second.

MR. PALMIERE: --- Mr. President.

PRESIDENT DEFAZIO: Someone second it?

(Chorus of seconds.)

none ---

MS. MEANS: Oh ---

PRESIDENT DEFAZIO: You have one ---?

MS. MEANS: --- yes ---.

PRESIDENT DEFAZIO: Representative Means?

MS. MEANS: I'm sorry. I wanted to congratulate the Friends of South Park because this last Saturday on November the 4th, they hosted a wine and cheese event called Savor the Flavor and they --- I wanted to congratulate Jason and Bernadette Fincke for their --- all their work. And they raised over \$6,000 for South Park.

So thank you, Mr. Chairman ---

PRESIDENT DEFAZIO: Okay.

MS. MEANS: --- and congratulations again, to the Friends of South Park.

PRESIDENT DEFAZIO: Seeing no other hands, we will move on. Move on to new business, 10384-17.

MR. BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, amending Ordinance Number 07-06 and subsequent amendments, which establish the existing schedule of facility and recreational rates and fees for the use of County recreational and park facilities. Sponsored by Council Member Futules, and I believe Mr. Palmiere wished to be added to this one and the next bill as well.

MR. PALMIERE: Yes, thank you.

PRESIDENT DEFAZIO: Okay. That'll go to the Parks Committee. 10385-17.

MR. BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, amending Ordinance Number 07-06 and subsequent amendments, which establish the existing schedule of facility and recreational rates and fees for the use of County recreational and park facilities. Sponsored by Council Members Catena and Palmiere.

PRESIDENT DEFAZIO: Mr. Catena, Representative, do you want to say anything?

MR. CATENA: Yeah. Thank you, Mr. President. When we were working --- or when the original ordinance was written, I believe we excluded a small piece of the sheriff's reserve deputies that are volunteers and would benefit from this program. And I wanted to get those people included in this program, Mr. President. So since they do --- it's a dedicated public service they provide to the community.

PRESIDENT DEFAZIO: Okay. We will put that into the Committee on Parks. 10386-17.

MR. BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing South Park Boxing, Incorporated to use a structure on Hundred Acres Drive in the County's South Park. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll go to the Parks Committee. 10387-17.

MR. BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing the Western Pennsylvania Police Athletic League to use a structure on Center Road, also known as Monroeville Trestle Road, in the County's Boyce Park. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll go to the Parks Committee. 10388-17.

MR. BARKER: A Resolution of the County of Allegheny, Commonwealth of Pennsylvania, adopting an Operating Budget pursuant to Article IV, §2 and Article VII, §4 of the Home Rule Charter, by setting forth appropriations to pay the expenses of conducting the public business of Allegheny County and for meeting debt charges for the fiscal year beginning January 1st, 2018

and ending December 31st, 2018. Sponsored by Council Member Klein.

PRESIDENT DEFAZIO: Representative Klein, do you want to say anything?

MR. KLEIN: Maybe we could do all three of them and then I'll say something, because there are two more.

PRESIDENT DEFAZIO: Yeah.

MR. KLEIN: Let's do the other --- let's do all three and then I'll say something.

MR. BARKER: Okay.

PRESIDENT DEFAZIO: Okay. We'll go on to do the next two then?

MR. KLEIN: Next two, yeah. PRESIDENT DEFAZIO: 10389-17.

MR. BARKER: Resolution of the County of Allegheny, Commonwealth of Pennsylvania, adopting a Capital Budget pursuant to Article IV, Section 2 and Article VII, Section 4 of the Home Rule Charter by setting forth appropriations to pay the expenses for capital expenditures during the fiscal year beginning January 1st, 2018 and ending December 31st, 2018. Sponsored by Council Member Klein.

PRESIDENT DEFAZIO: Okay. We're going to move on then and go 10390-17.

MR. BARKER: Resolution of the County of Allegheny, Commonwealth of Pennsylvania, adopting the Grants Budget, Special Accounts Budget, and Agency Fund Budget, by setting forth appropriations to pay said expenses during the fiscal year beginning January 1st, 2018 and ending December 31st, 2018. Sponsored by Council Member Klein.

PRESIDENT DEFAZIO: Representative Klein?

MR. KLEIN: Thank you, Mr. President. We're in the midst of budget season and beginning next week on Tuesday, Wednesday and Thursday, budget hearings will be held here in the gold room beginning at 5:00. So this is all pursuant to our efforts to create a new budget for 2018. So we'll look forward to seeing all of you there.

Thank you, Mr. President.

PRESIDENT DEFAZIO: Okay. That'll go to budget and finance. 10391-17.

MR. BARKER: Motion of the Council of Allegheny County urging the General Assembly to undertake public hearings on Senate Bill 22 and House Bill 722, bills which would initiate the process of amending the Commonwealth's

Constitution in an attempt to establish a fair, fully transparent, impartial and depoliticized process of the decennial drawing of state legislative and congressional districts, with all deliberate speed. Sponsored by Council Member Klein.

PRESIDENT DEFAZIO: Representative Klein?
MR. KLEIN: Thank you, Mr. President. At this point, I'd like to introduce an amendment to this motion that we are considering this evening. And Mr. Barker, can you distribute the ---?

MR. BARKER: Actually, Ms. Roka has ---

MR. KLEIN: Oh, okay.

MR. BARKER: --- the copies ---

MR. KLEIN: Great.

MR. BARKER: --- with her.

MR. KLEIN: Great. Great. Thank you very much.

This is being distributed to council members right now and then I will talk about the purpose of the amendment to the motion that we're considering this evening.

The --- the purpose of this amendment is to --- is to remove from the initial motion any reference to Senate Bill 722 and House Bill 22 that are being considered by the --- in the state legislature. And so rather than particularize the motion, we are making a motion that is broader in that respect, you might say.

So what I'm seeking right now is I'm seeking to amend the original motion and I'm looking for a second on ---

MR. MACEY: Second.

MR. KLEIN: --- that amendment.

PRESIDENT DEFAZIO: Under remarks? Seeing none, we'll take the vote on the motion. All those in favor signify by saying aye.

(Chorus of ayes.)

MS. MEANS: Shouldn't we take a voice ---? PRESIDENT DEFAZIO: Yeah. Opposed?

MS. MEANS: Mr. Chairman, would it be possible to take a --- a --- not a voice vote, but --- a roll call vote, Mr. Chairman?

PRESIDENT DEFAZIO: Well, if you --- MS. MEANS: Mr. President, --- PRESIDENT DEFAZIO: --- if --- if ---

Now we'll vote on the motion on that --- with the amendment.

MR. KLEIN: Yes.

PRESIDENT DEFAZIO: Okay. You want to make ---

MR. ELLENBOGEN: For discussion?

MR. DEMARCO: --- discussion?

PRESIDENT DEFAZIO: Yeah, we can --- yeah. You want to make the motion for ---?

MR. KLEIN: Yeah, I'd --- I'd like to offer the motion ---

MR. MACEY: Second.

MR. KLEIN: --- for consideration by the ---

PRESIDENT DEFAZIO: With the ---.

MR. KLEIN: --- entire council with the amendment.

PRESIDENT DEFAZIO: Okay. He seconded it, Representative Macey. Okay. Under remarks, go ahead.

MR. ELLENBOGEN: It's him (indicating).

MR. DEMARCO: Mr. President, I have a couple concerns here.

One, I appreciate the folks from Fair Districts and the other folks who are coming forth to say we want to try to propose a solution to what they see as gerrymandering and unfair districts. But the --- when I look at those bills and I look at the solutions that have been presented, I have some concerns.

I mean, we're talking about --- they're saying to give it back to the people. Well, the people have it today because they elect their representatives. And I'm afraid when we talk about an independent commission, who's going to appoint those people that they talk about being appointed? And how do we know that those people that are appointed --- because it says that they will be appointed from the folks who submit requests, that those folks will indeed actually represent the district.

If you look at both major political parties today, whether it be the republicans or whether the democrats, the parties are split. You have folks to the extreme on both sides and folks that are more centrist. Just because you put four of a particular party on there doesn't mean that you'll have that same sort of balance or that that will reflect the district.

Then we also heard that some of the folks believe that it doesn't represent it from a population

perspective. Well, no kidding, because it's based upon the actual geographic boundaries of a district ---

MR. KLEIN: Uh-uh (no).

MR. DEMARCO: --- where the folks are taken ---

MR. KLEIN: Uh-uh (no),

MR. DEMARCO: --- and where they're located.

MR. KLEIN: No, it doesn't.

MR. DEMARCO: So they're predominantly in urban areas that they're looking at.

Secondly, we heard from someone else who said that it --- the folks are disappointed because when they go to the polls, their vote doesn't matter. Well, to the folks who elected their representatives and those folks who were successful, their votes definitely mattered and I believe that they're --- they're happy here.

So it --- the --- from a --- try to --- fixing a district, something that I could support, I've seen stuff in the newspaper where you have professors from like CMU and the University of Pittsburgh that have talked about using computers to draw boundaries based upon parameters where they say, hey, or every congressional district, we want 705,000 people in there. Has to be contiguous boundaries. We don't want to take and cut up municipalities, I could support something like that.

But I have a concern where we're talking about folks will submit names. People will pick these names. No one comes to this without a bias. Who are the people picking those folks or appointing them? Do they have a bias?

Okay? I don't believe that you can absolutely talk politics, you know, out of this. So for that reason, I have some significant concerns about this proposed motion and I can't support it.

PRESIDENT DEFAZIO: Representative Ellenbogen, and then we'll go down this way.

MR. ELLENBOGEN: I just want to say that I --- I don't disagree with anything that Councilman DeMarco said. You know --- God, I can't believe how many years.

I was first appointed a committee man 45 years ago and these kind of things were the price of doing business. That's just the way it was, and we accepted it as, again, the price of doing business.

Can you take the bias out of it by appointments? That's delusional. Anybody that knows this game and has

been in it as long as some of us know that somebody is going to appoint somebody that has bias.

I never liked it when I was young. I don't like it now. Perhaps the best way to do it would be instead of people being appointed, people being elected out of the district the same as you would state committee people or whatnot.

But the point is although I agree with what Councilman DeMarco said, he's looking at this as a realistic point. And those of us that have played inside baseball and know the game, know that there's nothing that he's said that's wrong.

However, the discussion needs to take place. At some point, the discussion needs to start. Maybe this isn't perfect, but it's the beginning of a discussion that is very long overdue. And because of that, I will support it in spite of the realities of it, ---

(Applause.)

MR. ELLENBOGEN: --- the discussion needs to be done. Thank you, Mr. President.

PRESIDENT DEFAZIO: Yeah. okay.

Representative, I think, DeWitt Walton was next and we'll come down ---.

MR. WALTON: Thank you, Mr. President. I, too, only have some concerns. I recognize that no system is perfect, but I recognize the damage that is being done on a daily basis by what's occurring today.

As the gentleman who spoke earlier talked about the --- describing the imbalance of 13 to 5, if that were truly because of the will of the people, then I could live with that, although it may not favor my interests politically. Personally, I could live with that.

But far too often across this country, when you look at --- when you look at what has transpired in North Carolina and was recently ruled by the Supreme Court to be just patently wrong. When you --- when you look at what has occurred in Texas and being forced to redraw maps because of the horrendous efforts to disenfranchise communities, to disenfranchise people, we have to take some steps.

Look, everyone has trepidation. Everyone has concern. But to sit idly by and allow it to continue is a disservice to the people that I represent every day, to the things that I believe in, and the justice that I'm committed to in our society, and I have to support this.

(Applause.)

PRESIDENT DEFAZIO: Okay. Next was

Representative Palmiere.

MR. PALMIERE: No, Ms. --- Ms. Means had her --- her hand ---.

PRESIDENT DEFAZIO: Did she? Okay. Well, Representative Means.

MR. PALMIERE: I'll defer to Ms. Means.

MS. MEANS: Thank you, Mr. President, for recognizing me.

I agree wholeheartedly with the comments made by Councilman DeMarco. I do also agree that it's unacceptable that the city of Monroeville have three different congressmen. I agree that our present system is flawed.

And I voted against removing the reference to Senate Bill 22 because, as my colleagues know, I mean I wanted to talk about this bill and why it's flawed and why it's unconstitutional. As my colleagues know, I'm the one that always reads and studies these pieces of legislation. There's sections of it that are just --- like I said, unenforceable and unconstitutional.

And I wanted to --- and I --- I reached out to my state representative. I reached out to my state senator because that's where SB22 and --- and House Bill 722 are. They're in the legislator (sic) --- and they're there, but they're kind of stalled. And they're stalled because at least I'm told at the senate, it's because they're waiting for the legal challenges that are going to take place in front of the U.S. Supreme Court.

So they're waiting for the challenge. There's a <u>Wisconsin</u> case. And yesterday, the Supreme Court announced it was going to accept the --- the League of Women Voters' challenge from the Pennsylvania --- from Pennsylvania. So I think it's too soon to have that discussion until we get these legal rulings and the precedents set by the Supreme Court. So thank you for recognizing me.

PRESIDENT DEFAZIO: Representative Palmiere?

MR. PALMIERE: Thank you, Mr. President. Number one, I cosponsored this with the --- with Councilman Klein because I fully believe that gerrymandering is a cancer that's eating away at this country.

(Applause.)

MR. PALMIERE: And you know what --- you know what the physicians recommend when you have cancer. You either cure it with chemo or cut it out. Since chemo is not going to work there, let's just cut the darn thing out.

(Applause.)

MR. PALMIERE: You know it's a shame, when 17 percent of the people voted in the primary and 23 percent voted yesterday --- and the reason --- one of the key reasons why people don't come to vote is because they feel like their vote doesn't count because it was gerrymandering.

(Applause.)

 $$\operatorname{MR}.$$ PALMIERE: Those are the --- those are the facts.

PRESIDENT DEFAZIO: Hold up ---.

MR. PALMIERE: That's all I heard at the polls. I'm sick and tired of hearing it, and it's time to do something. I don't want to wait any longer. Let's get it done.

(Applause.)

PRESIDENT DEFAZIO: Representative Macey.

MR. MACEY: Thank you, Mr. President and members of council and the audience that's here today.

What we're voting on is a motion. It clearly has taken --- we've taken out SR22 and HR722 (sic). So this is a motion. This is a motion from us, how we feel about this gerrymandering and how it needs to be addressed.

And as my colleague, Jim, said, Mr. Ellenbogen, we've got to start somewhere, and let's start it here. I think that I'm going to support this. I was on the original motion from Councilman Klein and I'm not turning my back on it.

(Applause.)

PRESIDENT DEFAZIO: Okay. Let's take ---

MR. KRESS: No, I ---.

PRESIDENT DEFAZIO: --- you --- you ---?

MR. KRESS: I have a question.

PRESIDENT DEFAZIO: Go ahead, Representative, then I'll get you.

MR. KRESS: Thank you, Mr. President.

I have a question, maybe to the parliamentarian or if somebody can answer this. How does the county

council --- how --- who draws the boundary lines for county council?

MR. BARKER: The last time we went down the path was after the 2010 decennial census. A special committee was formed by the president. I believe it was Dr. Martoni at the time. It was comprised of, I believe, Ms. Danko, Mr. Gastgeb and some others, and those lines were drawn internally.

MR. KRESS: Okay. So all those seats that drew the lines --- they was --- county council people.

Is that correct?

MR. BARKER: For council, correct.

MR. KRESS: Well, okay. But who's --- okay. I want to make sure so I understand. So what are they proposing here with the state? Are they proposing to pick congressional people? They pick --- trying --- they're proposing to pick people outside congress or state? I want --- just explain to me, what are we trying to do here at the state level?

Does anybody --- can you --- go ahead, Mr. Klein (indicating).

MR. KLEIN: What --- what we're trying to do is we're trying to take it out of the hands of the legislature.

MR. KRESS: Right.

MR. KLEIN: It would ultimately require that the constitution be amended, but we're trying to open up the process so that a bipartisan, nonpartisan panel could be created, could be formed to draw district lines for legislative --- state legislative and --- and congressional districts that would reflect the realities of the populations in these parts of the states.

MR. KRESS: So you're going to get some people outside? They're like a bipartisan --- this be like a non-politician? Just a --- a regular individual.

MR. KLEIN: Yeah, nonpartisan. I mean, in terms of the details, I mean, the game plan is to --- to impanel a nonpartisan group, a nonpartisan panel to oversee that process.

MR. KRESS: Okay. So ---.

MR. KLEIN: And --- and with a good deal of input from people who actually have the knowledge, the expertise to do that.

MR. KRESS: Well --- well, then my question is why not adopt it also for the county council --- for here?

MR. KLEIN: Well, that's not what we're considering tonight and ---.

MR. KRESS: I'm just saying you get more bang for your buck. Is that something we could actually do here if we adopt it?

MR. KLEIN: Yeah.

MR. KRESS: I'm just saying, it's a --- it's a real thing. I mean, we're just asking somebody. I'm just talking about this is something real that you can put your hands on and make a change.

MR. KLEIN: Yeah --- yeah. I think we would probably have to go back to the drawing board to do that, and that is another matter that, you know, I would certainly welcome you or anyone who's interested in doing that to consider and put on the table ---.

MR. KRESS: Well, maybe we should make an amendment to this thing.

AUDIENCE MEMBER: I --- I don't care ---.

MR. KRESS: Maybe I do.

MR. KLEIN: Maybe some point of order here.

I ---.

PRESIDENT DEFAZIO: Go ahead. What's your point?

MR. KLEIN: Yeah. I think that we --- we are called upon right now. There's a motion on the floor.

PRESIDENT DEFAZIO: Right.

MR. KLEIN: It has been seconded to --- to allow us to amend the original motion, and it's on the floor. We're putting it up to a vote at this point.

MR. KRESS: Okay.

But I'm just saying, I would maybe like to amend and maybe put --- and include the county in this, too, Allegheny County, or all counties who have a council.

MR. KLEIN: All right. I think that that ---. PRESIDENT DEFAZIO: We could do that later.

MR. KLEIN: That is something that we could segregate, treat separately from what we're considering tonight. We're taking a look at the state tonight and how the laws --- lines are drawn statewide.

And I think that that could certainly be the subject of another motion and you know, while --- you know, you're certainly welcome to make that motion going forward.

MR. WALTON: Mr. President? PRESIDENT DEFAZIO: Yeah?

MR. WALTON: I think from my perspective, the idea that my colleague has raised is an interesting perspective and has merit. However, what I'd like to --- I'd like to suggest to him, if he would, is that immediately following this meeting and this vote, that we --- that we create --- that we --- we develop an additional motion to address the concerns that he raised to ensure that his concerns are addressed in a constructive way.

But in the meantime, we have an amendment that's been --- that's been approved by the body and a motion that has been properly moved and seconded on the floor. And absent his effort to successfully amend the motion, then I would hope that we'd go forward with the motion that's on the floor that's been properly moved and seconded.

I concur that we need --- that we need to make as many actions and as many efforts to legitimize and to bring equity as we can. But in the effort and the --- and --- and the spirit of trying to move the process that we're currently debating and addressing, that we move forward in that manner that we --- that we so moved at this point.

(Applause.)

PRESIDENT DEFAZIO: Okay.

DR. MARTONI: I think we should just call the vote. We have a motion and a second.

MR. KRESS: I just wanted to say one thing. I'll present this other motion for the county, but I would like to see your support. I'm --- I'm going to --- I'll vote for this, but I want to see your vote --- positive vote from the next thing coming up. I'm saying ---.

PRESIDENT DEFAZIO: Well, we got to wait ---.

MR. KRESS: I'm saying I'd like it to be

something that's, you know ---.

PRESIDENT DEFAZIO: Yeah, but ---.

MR. KRESS: Can we --- can --- can we --- let's just say, let's be consistent. That's all.

MR. KLEIN: We can have this conversation, but not right now.

PRESIDENT DEFAZIO: You have to bring it up at the next ---.

MR. KRESS: I just wanted to say --- okay.

We'll see what happens when we do that.

MR. KLEIN: Okay. Okay.

PRESIDENT DEFAZIO: Yes, do it --- yeah ---.

 ${\tt DR.\ MARTONI:}\ {\tt We\ ought\ to\ do\ one\ thing\ at\ a}$

time. It might work out a lot better.

PRESIDENT DEFAZIO: All right.

Let's --- all right. Let's move on.

MR. KLEIN: Okay.

PRESIDENT DEFAZIO: Let's take a voice vote.

MR. KLEIN: Let me just ---.

PRESIDENT DEFAZIO: Go ahead.

MR. KLEIN: I --- and before --- before we push ahead, just a couple of things that I'd like to --- I'd like to share. And I would like to thank those who have been interested enough to come to these meetings and do the legwork of getting behind a motion that suggests that we need to do --- we need to do something. We need to pay attention.

This evening, I'm joined by nine of my colleagues who have signed on as cosponsors of this measure, and this measure is intended in --- in some small but important way, to address concerns regarding the integrity of our electoral system.

The infrastructure of democracy needs our attention. Just as the physical infrastructure of a society must be tended to, the infrastructure of our democratic system needs that kind of attention as well.

We all understand that when we are not attentive to the physical foundation that sustains our communities, things tend not to get better. And in fact, they tend to get much worse over time. And they also become more expensive if we don't make the necessary repairs sooner, rather than later. We can expect that the same holds true for the political --- this political process of ours as well.

There is no mystery --- there's no mystery as to the damaging effects of gerrymandering. It stands before us in the form of a government that is often immobilized, even calcified, by partisanship producing the greatest threat to a functioning democracy, and that is permanent gridlock.

For those among us who understand that democracy is fragile and does not do well when we set it on auto drive, this is a small step in tending to our democracy. After all, democracy is an experiment that we all hope to continue and improve upon.

I find it hard to make any remarks on virtually any subject without speaking of my good friend, that Frenchmen Alexis de Tocqueville, an immigrant who wrote this in his book Democracy in America in 1801. He said the greatness of America is not in being more enlightened than any other nation, but rather in her ability to repair her faults.

So let's take a step forward this evening. Imperfect as our efforts might be, let's take a step forward this evening toward repairing some of those faults and making those first steps. So thank you very much for your agreeing to sign on.

PRESIDENT DEFAZIO: Let's ---.

(Applause.)

PRESIDENT DEFAZIO: Let's go --- let's go with

the roll call vote, as amended.

MR. BARKER: On the motion as amended, Mr.

Baker?

MR. BAKER: No.

MR. BARKER: Mr. Catena?

MR. CATENA: Yes.

MR. BARKER: Mr. DeMarco?

MR. DEMARCO: No.

MR. BARKER: Mr. Ellenbogen?

MR. ELLENBOGEN: Aye.

MR. BARKER: Mr. Futules?

(No response.)

MR. BARKER: Ms. Kirk?

MS. KIRK: No.

MR. BARKER: Mr. Klein?

MR. KLEIN: Yes.

MR. BARKER: Mr. Kress?

MR. KRESS: Yes.

MR. BARKER: Mr. Macey?

MR. MACEY: Yes.

MR. BARKER: Mr. Martoni?

DR. MARTONI: Yes.

MR. BARKER: Ms. Means?

MS. MEANS: No.

MR. BARKER: Mr. Palmiere?

MR. PALMIERE: Yes.

PRESIDENT DEFAZIO: All those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT DEFAZIO: Opposed? The ayes have it. Does someone want to make a motion to adjourn?

MR. MACEY: I make a motion to adjourn.

PRESIDENT DEFAZIO: All those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT DEFAZIO: Opposed? Motion, adjourned.
