MS. PRIZIO: Thank you so much for coming. Allegheny County is fortunate to have a number of teachers, community volunteers and individuals who support the mentoring movement and work selflessly to improve our children's odds for success in overcoming adversity.

Each year, Big Brothers and Big Sisters selects a deserving Big Sister who exemplifies the best of one-to-one mentoring; and

WHEREAS, Big Brothers and Big Sisters has selected Mrs. Nancy Griffith as the 2018 Big Sister of the Year. Mrs. Griffith is a retired nurse from Aspenwall and has served as big sister to little sister Cameron for six years.

WHEREAS, she --- they have enjoyed a variety of fun and worthwhile experiences while creating a lifetime of memories.

NOW, THEREFORE, BE IT RESOLVED, that I, Allegheny Council Member Anita Prizio, do hereby congratulate Mrs. Nancy Griffith for being named the 2018 Big Sister of the Year. And we commend her for her continued dedication towards serving as a positive role model, supporting vulnerable children and helping them succeed. Thank you very much for your service. We appreciate it.

(Applause.)

MS. GRIFFITH: I just want to say thank you. This has been a very unexpected and a very lovely honor. And my little sister and I have been together, like they said, for six years. And as well as her having a lot of new experiences, it's been a great experience for me. And I think this kid is just destined to do really, really well. She has a mother who is spectacular, but I've also helped her experience new things around the city and a lot of things that otherwise she probably never would have had the opportunity to try.

So I just want to say for the program in general, it's amazed me the amount of people that are involved in this and the time that they give to help out so many kids. That has just been an unbelievable eye opener for me. So I just want to say it's a tremendous organization and we've seen just unbelievable, wonderfully good success stories come from it. Thank you.

MS. PRIZIO: Thank you. Thank you so much. (Applause.)

MR. BAKER: All right. So we'll ask Ms. Nancy to stay up here as well, and here's your proclamation, Ms. Nancy. So this is a big deal. So out of 1,512 volunteers here in Pittsburgh and Greater Pittsburgh --- that's Allegheny, Washington and Greene --- Nancy Griffith and Art Hazen were named the Top Big of the year for the Pittsburgh program. And then they went to the state level and they got selected as the Big Brother of the Year in Pennsylvania for Art and the Big Sister of the Year in Pennsylvania for Nancy.

So we're really proud of both of them. It is --- I know we're here at the County Council. It's their day in the City of Pittsburgh, too, which is pretty fun. And especially for our young leaders that are here, our college leaders that we'll get to know a little bit later in the meeting. I think this is what you aspire to be, to be the Big of the Year, to just be a Big, be a mentor to somebody and make a difference in their life.

MR. DEMARCO: Thank you, Mr. President. On

MS. MEANS: Second.

PRESIDENT DEFAZIO: Under remarks? Seeing none, all those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT DEFAZIO: Opposed? The ayes have it. Under Liaison Reports, Representative Baker?

MR. BAKER: Thanks, Mr. President. I just first wanted to welcome our student government leaders that are here. Danielle Wicklund from Robert Morris University is the President of the Pittsburgh Student Government Council, and she has a couple of her colleagues and friends with her. We'll doing a Q and A afterwards so that they can learn a little bit about the local government.

I will promise you that it is not always this quick, that the meetings are not always this quick, but I'm glad that you could be here tonight to learn a little bit more about how County Council works. And all my colleagues are, of course, very welcome to join us afterwards for the Q and A. There will be snacks, there will be questions, there will be learning. It should be a great time. So we're glad to have the --- have you with us here tonight.

A couple other quick District 1 updates. We had a really nice coffee with your elected officials event in Ben Avon at Anchor & Anvil. Councilman Catena are very good mutual friends. Representative Anita Kulik and I did that event together. It was a real big success with a good turnout. Went right from there to Aleppo Earth day, and there was a fantastic set of folks that were at Aleppo Earth day.

So Great Gala was this last weekend. Congratulations to the city theatre for an excellent Gala which was --- which was terrific. And then Councilwoman Kirk and I had a real nice time on Saturday night at the Northland Garden Gala at Northland Library in McCandless, which was great.

Last night we had a terrific joint government meeting and event. The county manager was there, Willie McKain, the County Executive, in Coraopolis and --- and it might be the best practice of best practices. I think the chance for our county leaders to be able to get into a room with the local mayor or the local council members and

just talk about what's going on, how can we help, how can we collaborate, how can we work together? I --- just driving away last night, Manager McKain, I was so proud of the collaborative efforts that were going on between the county and Coraopolis.

And I got probably about four or five messages from them in the last 24 hours saying how happy they were that the --- that the administration came out to meet with them and it was really great. So that's it, Mr. President. Thank you.

PRESIDENT DEFAZIO: Representative Catena?
MR. CATENA: Thank you, Mr. President. I'd just like to take the time to say yesterday, in my son's actual school, Carnegie Elementary School, there was an unfortunate incident. I mean, you never know what's going to happen on a day-to-day basis with, unfortunately, with the violence that's occurring everywhere. But it --- it hit really close to home yesterday when the call came in with a male with a rifle trying to get into the --- trying to get into the school.

And the school obviously had to go on lockdown. And the response from the teachers to the staff to the administration of Carlynton School District, obviously, all of the first responders, the Carnegie Police Department, the Collier Police Department, the Heidelberg Police Department, the Scott Police Department, the County Sheriff's, the on-scene presence that was there was truly incredible and they were able to secure the school and ---without incident.

And they were able to take --- it was a juvenile they were able to take into custody, and it turned out that it was a BB gun. But I was just amazed at how professional and how well executed everything was and how all of the law enforcement agencies in Carlynton School District came together to keep all of our children safe. So a big thank you to each and every one of those people that took part in yesterday. So thank you, Mr. President.

PRESIDENT DEFAZIO: Who else had their hand up? Go ahead, Representative DeMarco?

MR. DEMARCO: Thank you, Mr. President. I was just going to --- again, many of the folks may know about this, but last Thursday out at the airport, the Airport Authority CEO, Christina Cassotis, signed a Memorandum of Understanding with Carnegie Mellon University. So very exciting times here in Allegheny County. We've talked

about the airport project as it is, but any time you can get a world renowned university together with a world renowned airport --- we were Airport of the Year in 2017 --- come together in partnership, collaboration, to try to spur innovation, it affirms for the people of Allegheny County that they're living in the right place at the right time. And it's sort of a beacon to the rest of the world that Pittsburgh is the place they want to be.

So hopefully Amazon was paying attention to what was taking place out there. Part of this is going to be we're going to provide space for students and faculty to come out and work at the airport to try to take and create innovative technologies related to air travel and things of the future.

So I'm very excited about the partnership, and this is the type of thing that we need to be doing as a county body, working with our universities, our foundations and private enterprise to move this region forward. So it was great that I was able to attend there and I want to thank the County Executive and his team for that. Thank you.

PRESIDENT DEFAZIO: Any other liaison reports? Okay. Representative Cindy Kirk?

MS. KIRK: I just want to take a quick moment to thank the County Manager's office, William McKain, for making the parking area a very safe --- much safer area now than it was just a week or two ago. So thank you. It's noticed.

PRESIDENT DEFAZIO: Representative Palmiere?
MR. PALMIERE: Thank you, Mr. President. Yeah.
Thank you. That was very nice. You know, the last time I was down there I felt like I was in quicksand and I was starting to disappear down there. Thank you very much for that.

Mr. President and Members of Council, I just wanted to mention a couple things. I had a group down here from Brentwood a few years ago, the Drop the Puck Campaign, where these young men and women play that deck hockey, and they raised another \$71,000 for cancer victims.

And Brentwood, every year they select so many people from the --- from Brentwood that are in trouble with that terrible disease and they --- they help with the expense and so on. It's over \$400,000 they've raised in the last several years. And I went up the other --- I

went up Saturday a week ago to see it. I want to tell you they --- they actually change lines like the --- like the regular hockey. I mean, it's unbelievable what I witnessed there, and I just wanted to commend that group. They just did a wonderful job and they're helping a lot of people.

And the other thing I wanted to mention I was --- also, I had the pleasure of going to see the spring play at Baldwin-Whitehall and they did a wonderful job. In the past couple of years, they've won the Gene Kelly Award for the best musical. And I'll tell you, this one that they had this year I think --- I can't see them missing again. It was just absolutely wonderful. And I wanted to congratulate all of the people involved there.

And at South Park, too, I got a chance to go over to South Park and see their --- their play also and they did a great job. And I --- I wanted to just give those people a shout out because they deserve it. I had no idea how hard it is to put these plays on and so on until I got involved a little bit. Those young men and women really, really pour their hearts out and I just wanted --- just thought they deserved some recognition. Thank you, Mr. President.

PRESIDENT DEFAZIO: Oh, go ahead.

MR. MACEY: Received and filed, please.

MS. MEANS: Received and filed.

PRESIDENT DEFAZIO: Okay. Well, that was going

to Budget and Finance. He's talking about the next one.
MR. BARKER: Right. Actually, we have no

notifications of contracts at this time, so ---.

PRESIDENT DEFAZIO: Okay.

MR. BARKER: We're good.

PRESIDENT DEFAZIO: Well, he wants it received and filed. All right. New Business? Notification of Contracts?

MR. BARKER: None.

PRESIDENT DEFAZIO: None. Public Comment, none?

MR. BARKER: Also none.

PRESIDENT DEFAZIO: Does someone want to make a motion to adjourn?

MR. WALTON: Motion to adjourn.

MR. CATENA: Second.

PRESIDENT DEFAZIO: All those in favor signify by saying aye.
