PRESIDENT DEFAZIO: Okay. 11314-19. MR. BARKER: A proclamation congratulating Chief Information Officer of the Division of Computer Services Joe Gavlik upon the occasion of receiving the Frank J. Lucchino Distinguished Service Award, sponsored by Councilmember Macey and all other members of council.

MR. MACEY: I'd like to introduce Mr. Joe and Mrs. Gavlik to the crowd here. And one of the things I --- I really appreciate doing as a county councilperson, besides getting hollered at and picked on, is being able to share people's accomplishments and their attainments and their milestones. And I think that Joe has certainly done that. He just mentioned to me that he was here for 49 years. There's not too many people that can say that in any occupation.

So with that being said, whereas Chief Information Officer Joe Gavlik of the Division of Computer Services was selected as the 2019 recipient of the Frank J. Lucchino Distinguished Service Award. Whereas, during the summer of 1969 Joe worked for the county as a temporary laborer and became a full time employee on November 16th, 1970, as a messenger with the County's Bureau of Systems and Computer Services. Today Joe is Chief Information Officer, CIO, for the county, serving as division manager of the Computer Services. And whereas Joe began working for the county before the county had purchased the first computer. However, whenever the county did, he became a computer operator. He was extremely self-motivated and read all the manuals to learn a lot of --- many of the tasks and was eventually promoted to the shift supervisor. And whereas, after numerous promotions with increasing responsibility, Joe was eventually named CIO of the Division of Computer Services in 2013. And, whereas, Joe's impressive history with the county and knowledge of computer information technology truly makes him an invaluable source of information for the county.

Over the years, Joe was influential in ensuring the services in the county were consolidation so that the systems talked to each other, which also saved money, increased services and made employees more efficient. He was also involved in the installation of high speed fiberoptic networks, guided the upgrades, and preparation before Y2K, and has overseen the creation of new data centers, and whereas, after graduating from Duquesne High School, Joe studied computer programming operations and --- and accounting at the School of Computer Technology. This led him on the path to eventually become CIO of the Division of Computer Services.

WHEREAS, Joe's time with the county was only

interrupted by six months --- it was a leave in 1971 where he was on active duty with the U.S. Marines. Thank you for your service, sir.

WHEREAS, Allegheny County is grateful for the service and dedication of Chief Information Officer Joe Gavlik and his determination to provide superior computer service to the county.

NOW, THEREFORE, BE IT RESOLVED that I and all the county council do hereby recognize and congratulate Chief Information Officer Joe Gavlik of the Division of Computer Sciences upon the occasion of receiving the Frank J. Lucchino Distinguished Service Award. And on behalf of Allegheny County Council, I commend him for all that he has done for the county each and every day. Congratulations.

PRESIDENT DEFAZIO: Representative Klein?

MR. KLEIN: Thank you, Mr. President. And I wonder if at this time, Mr. Willie, just for purposes of clarification or the edification of people in the room, if he could talk a bit about this resolution.

MR. MCKAIN: Sure. When we went to the Budget and Finance Committee, the way that we talked about it is that capital projects by definition are longer than one year. So when the council approves that, we have the appropriations to finish the project. Roads, bridges, buildings, facilities, parks, just by its nature sometimes take longer than one year. So periodically what we'll do is we'll sit down with the budget office and the departments and see if any projects are closed or if there's any balances that we can then ask council to repurpose them back to projects that come to our attention or council's attention years later.

The majority of these, even though they're over multiple years, are bridge projects that we got reimbursed by either the Commonwealth or the federal government and that there's still balances. So when we accumulated all these balances --- and we haven't done this for --- for many years. It was \$6.8 million. And our recommendation to council and what's in front of the full body right now is to move dollars for public works road equipment so they can continue the Roads Program with a widener and some other equipment. In-house paving, we're asking for half a million dollars.

You just mentioned Joe Gavlik and Jason's taking his spot. Council has approved in the previous agenda creating a new Information and Technology Department. We'd like to give them another \$1 million to help them implement a lot of their strategies and innovations.

County facilities we're recommending to get \$1.5 million. We have a lot of work to do and all of our capital buildings, the courtrooms, and --- and throughout the county government. County rehabilitation is \$1.5 million. That's in this transfer. And the last one is almost \$1.8 million, like \$1,760,000, and that's landslides. And every council member at one point or another has told me their district has been impacted by landslides.

So this is us asking your permission to take money that is left over in projects that have been completed and transferred in to complement the budget that

you just approved a couple minutes ago in capital to have a robust --- an even more robust Roads Program, facilities program, improvements and landslides. And that's what we're asking permission to do today, Mr. Klein. MR. KLEIN: Thank you very much, Mr. McKain. Appreciate the --- the clarification. Continuing a --- at its meeting on November 26th, the Committee of Budget and Finance considered this resolution, and it is brought before this council at this time with affirmative recommendation. And I so move for approval. MS. MEANS: Second. PRESIDENT DEFAZIO: Under remarks? Seeing none, we'll have the roll call. MR. BARKER: On the motion to approve, Mr. Baker? MR. BAKER: Yes. MR. It was --- it was good working with everyone. We did certify the elections that took place in November, so everything became official --- officially at that meeting last Monday and the certificates have already gone out. I've seen a lot of people posting their pictures of their certificates on social media, so it's all definitely official now.

But Manager McKain, I just want to thank you and your team for a wonderful experience. Julie's here, Julie Zavon. And I --- I've mentioned this to Ron Bandes and Jill Diskin and some of the other folks that were involved in the process, and I think a process like that is only as good as the people on --- I want to say both sides, but people that are --- that are sharing issues, sharing thoughts on both sides of an issue, and making sure the government is accountable, and I just really am thankful to --- to Julie and all of her friends that we got to know throughout the course of the year. It was a pleasure to work with Councilmembers DeFazio and Palmosina through the process, and also Judge Hens-Greco.

With that, I would just mention that our Sixth Annual District I holiday party is December 18th. All members of councils are cordially invited. It's at Stoke's Grill in Ross Township. And we always have a nice time. We usually get somebody from all 14 communities in District I there. So it should be a good time. Back to you, Mr. President.

BARKER: An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing the acquisition of certain rights-of-way and temporary easements to facilitate the replacement of the existing structure of the McRobert's Run Bridge No. 2 located in the Borough of Jefferson Hills, and to take such further action as may be necessary under applicable law, including the Eminent Domain Code. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll be referred to the Committee on Public Works. 11324-19.

MR. BARKER: An Ordinance authorizing the County of Allegheny to acquire by condemnation a temporary construction easement on a parcel of vacant, not assessed, land situated along the southern side of Township Road 373, Naylor Avenue, in order to facilitate the elimination of Gourdhead Run Bridge Number One located in Hampton Township, and to take such further action as may be necessary under applicable law, including the Eminent Domain Code. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll be referred to the Committee on Public Works. 11325-19.

MR. BARKER: An ordinance authorizing the Department of Public Works to take certain actions on behalf of County Council with respect to the issuance of highway occupancy permits, the grant of certain licenses, rights of entry and easements, and the amicable acquisition of certain real estate affecting county public work projects and other matters for calendar years 2020 and 2021. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: 11326-19.

MR. BARKER: Sorry. For 11325, refer to the Committee on Public Works again?

PRESIDENT DEFAZIO: Twenty-five (25)?

MR. BARKER: Yes.

PRESIDENT DEFAZIO: Okay. Yeah.

MR. BARKER: Thank you.

PRESIDENT DEFAZIO: 11325-19.

MR. BARKER: That one was referred to Public Works. Correct?

PRESIDENT DEFAZIO: Yeah.

MR. BARKER: Okay. 11326-19. An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing the acceptance of ownership of the Kenmawr Bridge following its reconstruction and authorizing the transfer of certain right-of-way and easement areas and facilities, to be constructed by Pennsylvania Department of Transportation, along South Braddock Avenue to Swissvale Borough, and to accept and maintain a portion of Kenmawr Avenue from Rankin Borough and to transfer certain right-of-way and easement areas on Jackson Street and on the relocated Sixth Avenue and such facilities to be constructed by PennDOT to Rankin Borough. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll be referred to the Public Works Committee. 11327-19.

MR. BARKER: A Resolution providing for a program of temporary exemption from County real property taxes for improvements, including repairs, construction, or reconstruction, made on industrial, commercial, or business property in a deteriorated area in the City of Pittsburgh, County of Allegheny, Commonwealth of Pennsylvania, pursuant to the Local Economic Revitalization Tax Assistance Act. Sponsored by the Chief Executive.

PRESIDENT DEFAZIO: That'll be referred to the Committee on Economic Development and Housing. New business. 11328-19.

MR. BARKER: A motion of the Council of Allegheny County reestablishing the Budget Transfer Committee in accordance with Section 805.03 of the Administrative Code. Sponsored by Councilmember Klein.

PRESIDENT DEFAZIO: Representative Klein? MR. KLEIN: I am offering a motion to reestablish the Budget Transfer Committee in accordance

with Section 805.03 of the Administrative Code. And I offer that motion at this time.

PRESIDENT DEFAZIO: Someone second it? MR. CATENA: Second. MS. MEANS: Second. MR. MACEY: Second. PRESIDENT DEFAZIO: Second. Okay. Under remarks? Seeing none, we will take a voice vote. All those in favor, signify by saying aye. (Chorus of ayes.) PRESIDENT DEFAZIO: Those opposed? Ayes have it. Notification of contracts. MR. BARKER: We have none. PRESIDENT DEFAZIO: Public comment on general items? MR. BARKER: We have a pair. PRESIDENT DEFAZIO: We have what? MR. BARKER: Two. First up is Ron Werkmeister.

MR. WERKMEISTER: Do I give my name and address, all that? Right? Okay. Yeah. So Ron Werkmeister, 4750 Robert Drive, Bethel Park, PA, 15102. I have lived in Allegheny County my whole life and have raised two children and personally know of how vulnerable children are and the many risks that they face in the world. In particular, with drugs, doctors, hospitals, and making bad or irrational decisions. They are to not even treat taking an aspirin or Tylenol as a trivial action. We know that we adults, parents, have the responsibility of keeping our children safe from life altering events like smoking, alcohol or drugs until they are of sound, developed mind and barely --- and body. Basically 18 years old. Heck, they even want to raise the legal age for cigarettes to 21 unless in the military.

We also know how naïve and easily influenced a child is, and the countless studies show that they are continually molding, changing and trying to find themselves for many years. We know that having sex at an early age, prior to 18, is even bad and forbidden, because they again are not mature enough to really know the consequences of such actions. Being a school director, I have learned that we have the responsibility to ensure our students do not engage in harmful activities like in sexual activity of sexting and making out on school property. So why would we take lightly that this proposed life altering event of sex reassignment on an innocent, developing child is logical and in their best interest?

There are numerous studies that confirm actions similar to this have had devastating results, besides the usual dangers that come from most surgeries, like bad reactions to anesthesia, necrosis, blood clots, infections, et cetera, loss of nerve functioning, scarring, adhesions, bowel damage, urine and bladder injuries and an increase in UTIs are all real risk. And we all know what effect hormones have on the health of people, let alone children. And the mental relapse from such drastic, life altering destruction is unbelievably devastating in many cases. As conscientious adults, knowing the obvious risk, we do not want to protect minors from physically harmful therapeutic practices, but we must also allow minors with some parental involvement to seek counseling and information to help deal with these unwanted attractions. Getting a pierced ear is not even close to this level of life altering results.

Also, after reading an article in the Trib paper, I learned that there is a 2018 Supreme Court decision in NIFLA versus Becerra where Justice Clarence Thomas says that the bans on professional speech, including nonharmful therapy treatments, violates the first amendment on free speech. We would not want to subject our county to wasteful spending on trying to defend such action. Therefore, preventing the harmful therapy practice, we must allow for the common sense therapy and counseling. So please pass Ordinance Number 11223-19 that gives the child an option to allow them to seek the help of a counselor to work through unwanted same sex attraction, feelings or behaviors. If you do not agree on this bill, please tell me why. Thank you for giving me this opportunity to speak.

PRESIDENT DEFAZIO: Next?

MR. BARKER: Next up is Juliet Zavon.

MS. ZAVON: New voting equipment. What's the county's plan for a successful transition? The county has selected new voting equipment, but we have no news since that decision was announced. According to the timeline at the Election's Division website, as of yesterday, the contract with the vendor has yet to be signed, and the new equipment has not yet been ordered. Is that true? Or has the county failed to update progress on the timeline it created to keep the public informed? Either case reflects poorly on the county. We'll use the new voting equipment in the 2020 elections in less than a year.

How is the county planning to implement this? What steps are involved? What's the timeline? What are best practices in changing voting equipment? Does the Election Assistance Commission have guidelines for this? This commission is an independent bipartisan organization. Among its functions, it's a national clearinghouse for information on election administration. Are there third party organizations that will monitor the process and do quality control? How is the vendor ES&S involved? Unfortunately, ES&S has a history of election security problems, illegal campaign contributions and lavish gifts to elected officials. Their reputation really doesn't inspire public confidence.

Is there a formal or informal activity or mechanism in place to learn from the experiences of other counties and states so we can avoid the pitfalls and use methods that have worked well? And what about the all important poll worker training? In previous public comments, I documented problems. My comments are in the public record. Poll worker training, even with the old equipment, left much to be desired. These are common sense questions that deserve answers. Without answers and information, what is there to give citizens confidence? People are jittery about problems in the 2020 elections. You and council can play a positive role.

I would like county council to request that updates and news on these issues be posted regularly on the Election's Division website, not just once, not just limply, but firmly and continuously. Providing useful and pertinent information like this is the bedrock of transparency and accountability. It will build confidence in the citizens of this county. I bring this to your attention because your help is needed. I hope you will act.

MR. BARKER: That's it. PRESIDENT DEFAZIO: Someone want to make a motion? MR. CATENA: Motion to adjourn. MR. BAKER: Second. PRESIDENT DEFAZIO: All those in favor, signify by saying aye? (Chorus of ayes). PRESIDENT DEFAZIO: Opposed? The ayes have it. Meeting adjourned. MEETING CONCLUDED AT 5:45 P.M.
