I'd like to call this meeting of Allegheny County Council to order. Please rise for the pledge of allegiance.

(Pledge of Allegiance.)

PRESIDENT CATENA: Please remain standing.

(Silent prayer or reflection.)

PRESIDENT CATENA: Thank you. Everyone, please be seated. Jared, please take roll.

MR. BARKER: Mr. Baker?

PRESIDENT CATENA: Thank you. This evening I'd like to welcome County Executive Rich Fitzgerald on his 2021 Comprehensive Fiscal Plan and Budget Address. Welcome, Mr. Executive.

(Applause.)

COUNTY EXECUTIVE FITZGERALD: Thank you, Mr. President and members of Council. Before I get started I'd like to present this to the Clerk, The legislation asked this be placed on the agenda. This will be the operating budget, the capital budget and the grants and special accounts budgets, to place those on.

First of all, thank you. Thank you for those of you who are here and those of you remotely. Obviously, these are very challenging times.

Before we get started, I really want to single out the folks who have been coming to work literally every day.

And I want to thank my Chief of Staff, Jennifer Liptack, Willie McCain, Amy Downs, Darla Crovatama, Alissa Way, Jessica Mooney, and Patricia in my office, who literally every day are keeping the --- and among many other people. And I want to thank Mary Cirocca, a budget director, for really doing a yeoman's job throughout this entire time, dealing with obviously the CARES Budget and then the budget that's being presented tonight. You know, there have been a lot of people doing a lot of good work, and you see Dr. Bogan every week and Director Brown and so many others who have just really stepped up during this very, very difficult time.

But let me present the budget. And then we'll open it up for any questions. The budget I'm going to be presenting to you this evening has no millage increase. This will be the 19th time in the last 20 years that we're presenting a budget for the residents of Allegheny County, for your consideration, that their millage will not increase. And again, in most years that would actually be a little bit of a decrease, because it doesn't even adjust for the cost of living. This year, again, being a little bit differently, we're not sure where that will go.

The operating budget that we're going to present to you tonight is actually a little bit of a decrease from last year's budget that you passed. That'll be a 942.5 operating budget, which is about \$17 million less than the budget you approved for 2020, almost a two percent decrease. And you will see that many of our revenues did decrease over this year, and understandably so during the COVID pandemic. Our pour drink tax revenues are down. Our car rental tax is down. The casino tax is down. The hotel/motel tax is down. And our court fee collections are also down. Relatively stable, and surprisingly so,

are the RAD sales tax numbers, have been relatively stable. And also our property tax has actually seen a little bit of new construction, which has continued, which it talks a lot about this region right now that people have continued to invest, continued to work, continue to move forward in this region.

There's going to be a few items that will be increased. Probably you'd be expecting that health and human services, we're going to --- introducing a slight increase for that. We will also be increasing slightly administrative services. As you can imagine, running elections right now is extremely expensive. We've been given an unfunded mandate, all 67 counties in the Commonwealth have been given an unfunded mandate by the legislature to run mail-in balloting as well as keeping all the polling places open. It's very labor-intensive, very expensive, so we had to put a little more money in the administrative services budget for next year.

You will see some decreases along the lines of things like court records, arcanes, jail, public works, facilities, miscellaneous and Shuman. And one of the biggest decreases you'll see, and it's a good one, is our debt service. And I want to thank all of you for passing the refunding, the bond financing that you did a couple of months ago. With interest rates being as low as they are it was a real opportunity for us to save money on our interest and our carrying charges. So that was something that was very helpful.

I also want to thank our congressional leadership in the County, Congressman Doyle and Congressman Lamb for delivering the CARES money to us earlier this year. It allowed us to increase spending, investing in health, contact tracers, PPEs, testing equipment, et cetera, et cetera. Also, we were able to invest in some technology for our workers to work remotely and then try to keep our facilities, obviously, as safe as we can during this time.

The County Manager had instituted a hiring freeze when the pandemic hit, and we're going to be proposing that --- that hiring freeze remain in effect for the first six months of 2021. We're not anticipating at this point that we'll be needing any layoffs. Nobody had gotten laid off through this time. And again, we're hopeful that that can continue on through next year, at least the first six months of next year.

We're going to be asking for a new department called Children Initiatives. You may recall a couple of years ago that the residents put a referendum question on the ballot to increase the millage to fund some pre-K and some early childhood initiatives. While it narrowly failed, I think there's a lot of interest in trying to help and provide services to have our kids --- all kids, all of our children in Allegheny County ready for school when they hit kindergarten and first grade. So we are going to be asking for a creation of a couple of positions, and the County Manager will be able to discuss that more in detail during the budget process. And I do note during the process, after the failure, we did put a committee together, and I know Councilman Walton and Councilman Baker participated and were very active in some of the recommendations that you're going to see as we move forward on those areas.

We're going to continue on our capital budget. We're actually going to see a little bit of an increase, a little over \$127 million on our capital budget. Again, being able to fund capital projects with low interest rate bonds that we were able to go out --- again, thank you for the work that you did. It's very fiscally responsible for us to get this work done now when the money is as low cost as it is for us to be able to borrow. So we're going to continue to invest in our infrastructure, our roads, our bridges, our parks, our technology, our buildings to make our services that we provide to the customers, our taxpayers, as efficiently as we can.

We're going to continue to be investing in our parks. I think I might've mentioned this at one of my previous meetings, but we're going to have two parks next year that will go net zero. Deer Lakes and White Oak Park, two of our nine county parks, will actually be able to produce more energy through the solar and wind and the other sustainable energy generations that they have to be able to put more --- put energy on the grid. We're also going to be doing some LED lighting and some more solar in South Park for --- along Corrigan Drive. The new maintenance facility that's going to be off of Corrigan up off of Maple Springs will also have solar panels up on the roof.

The grants and special accounts budget will be about \$1.5 billion. Again, you know, we just heard today that the talks at the federal government with the stimulus

and the next run of CARES are off the table, I guess, at this point. We're certainly hopeful that they get back to the table and provide some of the funding, because as the year comes to an end that funding comes to an end. And I think a lot of not just our government but state government and municipal governments are going to continue to need help until the pandemic is coming to an end.

With that I was going to open it up to any questions. As we present this budget the County Manager and Director Soroka and our team will certainly be available to answer any questions as you go through the budget process. As you go through your hearings and committee meetings we'll be there to assist.

But again, I want to thank you for the cooperation you've given throughout this year to present this budget, to get our bond rating as high as it is. It's one of the highest, I think, in almost 40 years. And it's keeping our costs down.

So with that, Mr. President, I open it up to any questions.

PRESIDENT CATENA: Thank you, Mr. Executive. Are there any general questions? Please hold any specific questions until, obviously, when we hold the budget hearings.

So are there any general questions this evening for the Executive?

COUNCILWOMAN: I have a couple, Councilman Catena.

PRESIDENT CATENA: Go ahead.

COUNCILWOMAN: General question from --- first of all thank you, Executive Fitzgerald for giving this opportunity to speak, it is appreciated.

My first question is you mentioned that the budget was bound for, you know, obvious revenue shortage reasons.

Can you speak to where funding is planning to be cut from?

COUNTY EXECUTIVE FITZGERALD: Well, I as I indicated, Councilwoman, I think you're going to see not very many significant cuts, but I think you're going to see, for example, court records. The courts aren't running as many operations, trials, et cetera, as they did before. Our census is down in the canes, so there will be a corresponding reduction in spending that would go on there. We've seen a reduction in jail population, so for

the first time that I can remember we're actually going to have a decrease in the jail budget. We're able to make some cuts in facilities without necessarily hurting what we need to do, moving some of that onto capital budget. The reduction in Shuman, again, on population, we've seen less of a need there because the population has been down. And then, again, debt service, about \$13 million in savings on our interest carrying charges next year because of the bond refinancing that this Council approved a few months ago.

COUNCILWOMAN: Thank you. And then my second and last question, we on Council received about 15 emails ahead of your address tonight, and they were all about one issue. And it was about increasing funding into the health department's air program to take on the legal representation of the major polluters here in Allegheny County.

Is there any plan in the budget to increase funding there?

COUNTY EXECUTIVE FITZGERALD: Well, actually we've been increasing that funding for many years, including this year. And that'll be done again next year. They have really ramped up the amount of legal defense and legal services, I guess, if you will, to make sure that that's done. And you know, really, to be honest with you, they've been doing a pretty good job, and I think you're going to see continued improvement. And quite frankly, I think the 88 percent reduction we've seen in PM2.5 over the last decade, I think we're going to continue to see improvement in that. It's a priority of mine, and we'll continue to do so.

PRESIDENT CATENA: Thank you. COUNCILWOMAN: Thank you.

PRESIDENT CATENA: Are there any other questions?

Hearing no other questions, I'll ask for a motion to, basically, introduce the ordinance the millage ordinance for 2021 and the resolutions containing the operating, capital and grants and special accounts budget for 2021.

Because I was going to ask if anyone had a problem with asking, since they're all on the same subject, if we could group them together and summarize based upon the 17 individuals, basically, submitting similar type comments or similar type emails. If anyone has a problem with that in the sake of time since the jail oversight committee, obviously, does something similar when they have the same type of email situation.

Hearing no objections to that, then, Mr. Varhola, if you could summarize each of those we'd appreciate it.

MR. VARHOLA: Yes, Mr. President. Most of them are --- or all of them are dealing with the air quality in

Allegheny County. They're supporting the funding of the Clean Air Program. The poor air quality in our County has been a scandal for decades seriously hampering Pittsburgh's resurgence by scaring aware top flight companies from our area. Wanting the County to put more money into the Clean Air Fund and fund programs that can be supported through that program.

PRESIDENT CATENA: And that's the general synopsis of all 17 of them?

MR. VARHOLA: Yes.

PRESIDENT CATENA: Okay. Thank you.

And to remind everyone, these are, if you haven't read all 17 of them yet, they've been coming in over the past week or so into all of our emails. So they are out there, so please take the time to read each one of them. Because they are, obviously, very important regarding the air quality issues.

So at this point in time we need a motion to adjourn.

MR. WALTON: So moved.

PRESIDENT CATENA: Motion has been made.

MR. MACEY: Second.

PRESIDENT CATENA: And seconded. All those in favor signify by saying aye.

(Chorus of ayes.)

PRESIDENT CATENA: All those opposed?

Motion carries. Thank you, everyone. Have a nice evening.
