While the second is from the UPMC and totals \$3,000 to be purchased for technology for the use --- of use in the juvenile justice system, primarily for the purpose of remote participation in treatment and educational programs. I move for approval.

PRESIDENT CATENA: Thank you. Mr. Futules --or Councilman Futules. MR. FUTULES: I'm here. Last week the Government Reform meeting met, and we discussed the Allegheny County Human Relations Commission. And it was approved unanimously as a positive to go to the full Council for consideration. I make a motion ---. PRESIDENT CATENA: Thank you. MR. FUTULES: --- to approve. MEMBER: Second. PRESIDENT CATENA: Motion has been made and Is there any discussion? seconded. Seeing and hearing no discussion, Jared, would you please take a roll call vote? MR. BARKER: On the motion to approve, Mr. Baker? MR. BAKER: Yes. MR. BARKER: Ms. Bennett? MS. BENNETT: Yes. MR. BARKER: Mr. DeMarco? MR. DEMARCO: Yes. MR. BARKER: Mr. Duerr? MR. DUERR: Yes. MR. MS. KIRK: Yes. Yes.

PRESIDENT CATENA: Go ahead.

MS. KIRK: I'd like to just remind everyone and inform everyone that the Health Department has started their flu vaccine clinic from 9:00 to 3:00, Monday through Friday. It's a walk-in. Just bring ID, wear a mask. No appointment needed. They do have Thursday evening hours also. You can always check the website. But the vaccines are available now, and we should start getting our flu shots. Thank you.

PRESIDENT CATENA: Thank you. Councilman Walton?

MR. WALTON: Thank you. I think that on what has occurred --- what occurred last week with the Elections Board vote that they took to establish satellite voting in the multiple locations around the County and then particularly the African-American community is to be commended. I had multiple conversations with the Executive, and he has been --- he was absolutely responsive and looked at this issue through multiple lenses and understanding the impact of creating opportunity for --- to ensure that the greatest possible opportunity for residents of Allegheny County to cast votes was considered. And I'm really pleased --- I'm really pleased and really proud to be part of that effort. And hopefully, we will have an unprecedented turnout in this November election. Great work by everyone involved, and the residents of Allegheny County won on this one completely.

PRESIDENT CATENA: Thank you. Is there anyone else? MR. MACEY: Mr. President, Bob Macey. PRESIDENT CATENA: Go ahead, Councilman Macey. MR. MACEY: Okay. In these unprecedented times we've all had problems, especially the nonprofits trying to raise money. And a lot of our volunteer fire companies are suffering. And one of the things that we do at the West Mifflin Number 3 Fire Hall is that we have a car

cruise every Wednesday. Some of that has been taken away

from us, because of the Corona 19. But those --- I just want people to know that on this Saturday, and it's going to be one beautiful day, at 3722 Rodeo Drive, West Mifflin Number 3 Volunteer Fire Company is having a super cruise. So all those people like Mr. Futules who has those fancy cars, come on out and join us in a day of festivities as well as door prizes and super prizes for those with the nicest cars. And you can get yourself a meal, a total meal, for like \$7. So we're at 3722 Rodeo Drive, West Mifflin 15122.

And I want to commend Councilman DeWitt Walton for his efforts in --- in the voting efforts. Thank you so much.

PRESIDENT CATENA: Thank you. Is there anyone else this evening?

Hearing no one else ---.

MEMBER: Don't profile, Mr. Futules, about cars. PRESIDENT CATENA: Thank you. Hearing no one

else, we'll move on to new business, ordinances and resolutions, 11615-20.

MR. BARKER: A resolution of the County of Allegheny amending the Grants and Special Accounts Budget for 2020, submission number 08-20. Sponsored by the Chief Executive.

PRESIDENT CATENA: That will go to budget and finance.

We now have new business, motions. We have two non-agenda items. Per the rules of Council, these may be introduced by their respective sponsors without a motion to add them to the agenda. Ms. Bennett, I believe you have the first one.

MS. BENNETT: Thank you, President Catena. So yes, I have a motion that I am wanting to introduce and have voted on tonight. Today is National Voter Registration Day. I just wanted to make a motion around it, and I think that we all, as much as we disagree, that we can all come to an agreement here that it's very important that we get everybody engaged in the voter's process --- in the voting process. It is the most basic civic duty that one can do, so I just thank all my colleagues for entertaining this last-minute motion and ask for your support in acknowledging this important day.

MR. MACEY: Second, Bob Macey.

PRESIDENT CATENA: Motion has been made and seconded. Before we take the vote on this, does everyone

have a --- has everyone seen a --- does everyone have a copy of it?

MR. ZAVARELLA: Yes. President Catena, I'd like to be added as a sponsor to that as well.

PRESIDENT CATENA: Let me ask this question, is there anyone that does not want to be a sponsor on this?

Hearing no one, we'll add everyone then, Jared. The motion has been made and seconded. Is there any discussion?

Hearing none, all those in favor, signify by saying aye.

(Chorus of ayes.)

PRESIDENT CATENA: All those opposed? Motion carried.

Mr. Futules, you have the second motion this evening.

MR. FUTULES: Yes. My motion is --- it started, I'd say, back in June of this year when DeWitt Walton had mentioned to me about Juneteen Day. And quite frankly, I was unaware of what that day was. I'm almost embarrassed to say that. It was a significant day in the history of this Country, and I had further discussions with our staff and realized that there is no national holiday or national observance day for this. And I think it's important that we send a motion to the --- to Congress to recognize this. And I want to send it to Committee, because it's also in our Committee right now about Juneteen giving as a holiday for the County. And --- and I certainly am supportive of that as well. But I want to bring these two together, not necessarily in the same motion or bill, but have that discussion next week at a Committee meeting. And then we will bring it to the full Council for consideration. So at this time I will not ask for a vote.

PRESIDENT CATENA: Thank you, Mr. Futules. I'll be sending that actually to Government Reform, your committee, then, so you can discuss it for the next meeting.

MR. FUTULES: Thank you. Thank you. PRESIDENT CATENA: You're welcome. We'll now have notification of contracts. MR. BARKER: We have none. PRESIDENT CATENA: Is there any public comment on any of the general items? MR. BARKER: We have two individuals who signed up. First up is Daniel Welch.

Who is evidently not here. PRESIDENT CATENA: Okay. MR. BARKER: Second up is Marie Norman. Who also is evidently not here. PRESIDENT CATENA: Okay. And I believe we have a speaker that didn't sign up in time, but does anyone have a problem with having him present tonight? MR. ZAVARELLA: No. MR. WALTON: No. PRESIDENT CATENA: Okay. Step forward, sir. MR. JOHNSTONBAUGH: Thank you, President Catena. PRESIDENT CATENA: You're welcome. MR. JOHNSTONBAUGH: Where would you ---? PRESIDENT CATENA: At the podium, please. MR. JOHNSTONBAUGH: Thank you, sir.

My name is Steve Johnstonbaugh, and I'm a member of the North Park Council of Friends, appointed by Councilwoman Prizio on May 19th of 2022 --- I'm sorry, that would be my expiration date, 2022. I've written a correspondence here, and I'll just simply read it.

Subject is the Council of Friends adopted 10/22/02 by ordinance number 54-02. The ordinance stipulates that the agency shall be comprised of a minimum of seven members per county park. Simple math indicates that we should expect a minimum of 63 appointees to the Council of Friends agency at any given time. A roster of appointments was prepared and submitted to me on August 31, 2020 by Jared E. Barker and John Daley for the period beginning 7/02 to the present. My analysis of the records indicate the unexpired census to be 17 appointees representing 4 parks. Based on these facts, I am presenting to Council a question as to the ongoing relevance of the mission of the Council of Friends.

Personally, I am highly supportive of an initiative to reinvigorate the advisory agency. It is my belief that the park rangers and naturalists should act as a constant source of candidates, as they spend all of their time on the ground in the parks interfacing with citizens. They know which citizens are engaged, and it would seem an easy task to identify those willing to serve. Further, it seems prudent that a division responsible for a \$22 million operating budget that directly serves individual citizens of Allegheny County should have some formal entity agency that communicates directly with the citizens served, and that entity in turn should report directly to County Council to avoid potential conflicts of interest.

However, the current metrics gives some indication that the Council of Friends is no longer relevant to Council. Now that this matter has been brought to your attention, my question to Council this evening is, what is your vision for the future of the Council of Friends going forward? Do you wish to fully populate and reinvigorate the Council of Friends, or do you intend to sunset this ordinance in the next round of administrative review?

I look forward to learning your thoughts and forward-thinking direction on this matter. You're also welcome to join the North Park Council of Friends, Pittsburgh, PA. Thank you for your time this evening.

PRESIDENT CATENA: Thank you.

MS. HALLAM: President Catena, personal privilege?

PRESIDENT CATENA: Go ahead.

MS. HALLAM: Yes. For the folks who aren't there at the meeting, do you forward a copy of those comments along to all of us? It was a little difficult to hear.

PRESIDENT CATENA: Yes. We'll do that this evening.

MS. HALLAM: Thank you. MR. VARHOLA: They're in text. PRESIDENT CATENA: I'm sorry. MR. VARHOLA: I forwarded them in a text. PRESIDENT CATENA: We --- it's in a text, Councilwoman Hallam. So it should --- you should be seeing it, so ---. MS. HALLAM: Thank you, Ken. Thank you, President Catena. PRESIDENT CATENA: You're welcome. Is there anything else this evening? If there's nothing else, we'll have a motion to adjourn? MR. WALTON: So moved. MEMBER: Second. PRESIDENT CATENA: Motion has been made and seconded. All those in favor, signify by saying aye. (Chorus of ayes.) PRESIDENT CATENA: All those opposed?

Motion carries. Thank you, everyone. Have a nice evening.
