MS. KIRK: Thank you, President Catena. I just want to point out that the Friends of the Park North Park will have their initial reorganization meeting this Monday at 8:00. It will be at the cabin at North Park on Babcock and Ingomar where that building is and there will also be a Zoom option. It's a public meeting. It will mainly be

reviewing the new appointees all for them to get to know each other and also for them to choose officers.

PRESIDENT CATENA: Thank you. Anyone else this evening? Hearing no one else new business ordinances and resolutions.

MR. BARKER: We have none.

PRESIDENT CATENA: New business motions?

MR. BARKER: Also none.

PRESIDENT CATENA: Notification of contracts?

MR. BARKER: Also none.

PRESIDENT CATENA: Public comment on general

items.

MR. BARKER: We did have four people sign up. First up is Paul Brown of City of Pittsburgh. I write this in support of the bill introduced by Council Members Hallam, Bennett and Prizio that will prevent any new fracking development in Allegheny County parks. I have been a user and supporter of our county parks for many years and was a close friend of the late Joseph Grom who was park naturalist at North Park for many years. Many of our county parks are surrounded by development. Some of this development was done without good land use planning and resulted in sprawl and water pollution. What the parks and surrounding communities do not need is fracking, oil and gas related development. Please support a ban on fracking. I also urge that this bill be brought up for a vote before the parks committee. Thank you.

Next up is Dana Sighler also City of Pittsburgh. My name is Dana Sighler and I live in the Squirrel Hill neighborhood of Pittsburgh. I am contacting you to voice my strong support for bill number 11084-21 which would ban fracking and other industrial activities in our public lands. This is common sense legislation which should have already been the law of the land for decades. Our parks exist for public recreation and enjoyment. Our parks do not exist to create profits for out of state chemical companies. The impacts of fracking on public health are well-documented and fracking does not create lasting jobs or economic benefits. When fracking moved into 22 counties throughout Ohio, Pennsylvania and West Virginia their residents experienced a decline in jobs, average personal income and overall population according to a non-partisan think tank. Fracking is toxic for air quality, water quality and our economy. It should not be allowed in our parks. Please move bill number 11804-21

out of committee and pass it into law immediately. Thank you for your time.

Next up is Shane Chessire from Natrona Heights. He listed two topics for conversation, Allegheny County vaccine policy and Allegheny County Parks but listed no comment.

Last up is Harry Hawkhizer of the City of Pittsburgh. My name is Harry Hawkhizer, and I live in Pittsburgh. I am voicing my strong support for bill number 11084-21 which would ban fracking and other industrial activities on our public lands. This is common sense legislation which should have already been the law of the land for decades. Our parks exist for public recreation and enjoyment. Fracking and other extractive activities can do immeasurable harm to our valuable parks. The impacts of fracking on public health are well-documented and the economic benefits are questionable When fracking moved into 22 counties across at best. Ohio, Pennsylvania and West Virginia their residents experienced a decline in jobs, average personal income and overall population. Fracking is toxic for air quality, water quality and our economy. It should not be allowed in our parks. Please move bill number 11804-21 out of committee and pass it into law immediately. Thank you for your time.
