PRESIDENT CATENA: We'll now have liaison reports. Are there any liaison reports? MR. DEMARCO: Mr. President. PRESIDENT CATENA: Go ahead.

MR. DEMARCO: Board of Elections met yesterday. I want to give folks an update as far as election preparations for the November 8th general election. Approximately 936,763 voters are registered to vote here in Allegheny County. We have received 175,378 applications for mail and/or absentee ballots. Of those that have been applications processed and ballots sent out. 95,284 have been returned already. We had the, roles went in and they cleaned. They took and removed 9,865 deceased voters from the roles this year. Okay?

In Allegheny County, typically we lose about 13,500 people each year pass away. So they were able to take the data we got from the state, and over the last year, they removed that number of voters. Thirty-eight (38) polling places were changed. Of the 1,323 precincts, 38 were changed. All of the voters in those precincts, anyone affected will receive a postcard, giving them a new address, telling them where to go, they have to go to vote on election day. In regards to the number of poll workers, they've - they're focusing on making sure that each precinct has at least four poll workers. So they talked about 5,450 poll workers recruited. They feel confident they're going to hit that number, and today we have 13 more days until the election.

I urge all Allegheny County residents and registered voters to go out to vote. Thank you, Mr. President.

PRESIDENT CATENA: Thank you. Anyone else this evening?

MR. FUTULES: Yeah. PRESIDENT CATENA: Go ahead.

MR. FUTULES: Just recently on the Sports and Exhibition Authority - well, actually that wasn't recent. They went out on a nationwide search for a new executive director, and that process probably took about three to four months and we brought in a man from Washington DC by the name of Aaron Wallace, a very exceptional person for this position. And he's going to be taking the sports and exhibition authority into a very new direction and members of the board are very excited to have him aboard. Thank you.

PRESIDENT CATENA: Thank you. Anyone else this evening? I just have two things this evening. Obviously there's a new gentleman sitting in our solicitor's seat. His name is Frederick Frank, so I would be remiss if I didn't welcome him to serving all of council. Thank you, Solicitor Frank. We look forward to working with you.

PRESIDENT CATENA: As a matter of housekeeping, as my colleagues will no doubt recall, on September 13th, we approved motion 12438-22 authorizing Council to enter into agreement with legal services with the law firm of GRB. Unfortunately, the motion did not establish the start or end date of the contract. I would therefore like to take this opportunity to clarify the start date for the contract is December 3rd, 2021 and the end date is June 30th, 2023. Thank you. That's just a housekeeping matter for our records. We'll now go into new business ordinances and resolutions.

MR. BARKER: An ordinance to the county of Allegheny, Commonwealth of Pennsylvania, authorizing the acceptance of three parcels of land located contiguous to the county's North Park, sponsored by the Chief Executive.

PRESIDENT CATENA: That will go to the Committee on Parks. Do we have any new business?

MR. BARKER: No motions.

PRESIDENT CATENA: Notification of contracts? MR. BARKER: None.

PRESIDENT CATENA: Public comment on general items.

MR. BARKER: We had one. Mr. Gary English signed up.

MR. ENGLISH: My name's Gary English. This is a history lesson going back over a quarter - nearly a quarter of a century. In 1998, the citizens adopted the home rule charter, followed by electing a new form of governance with the county executive and county council. The charter included a resigned to run provision as a citizen's loathe career politicians, which council wants to change.

The citizens also had the right to a ballot questions. What followed was the new council was an administrative code which stripped the Allegheny County citizen's right of a ballot question to repeal the county sales tax. That's more monkey business. In 2003, County Council attempted to amend the home rule charter to strike the resign to run posting campaign signs encouraging a yes vote.

The devil was in the details. The disclaimer was paid for by Democrat and Republican Councilmembers. I look up the council's campaign committee to see how much money was raised, who were the contributors, what the money was spent on, but no campaign filing was ever made. Thus, the signs were illegally posted to influence the outcome of a ballot question.

I pursued this crime for nearly a year, which finally resulted in two wrist slaps of \$250 each. The scapegoats were Councilman Dave Fawcett and Jim Fenton. Councilman Macey was quoted in the <u>Post Gazette</u> saying, all we want to do is get it on the ballot. What it does is give the people an opportunity to run for other offices.

I clearly understand why you want it on the ballot to bolster career politicians. This illustrates contempt for the citizens of Allegheny County. Mr. Macey said he thinks the council may have an opportunity to market this better than before. Well, we saw what before was. Remember council's previous opportunity of marketing that violated election law.

Shame on county council. Shame on this monkey business. I recommend a no vote.

MR. DEMARCO: Folks, this proclamation that I'm doing tonight is - I don't have a pink shirt on because I forgot about this as I'm filling in for our former king of proclamations, Tom Baker. Tom was the usual sponsor for this proclamation, but I can't think of a better cause, you know, two women who I personally dated, contracted breast cancer and passed away. So this issue is very near and - and dear to my heart, and you can't pick a better cause.

So I appreciate the folks that are here tonight for coming in here to receive this proclamation as we recognize Breast Cancer Awareness Month and - and these folks for what they're doing here. So whereas one in eight women will be diagnosed with breast cancer during their lifetime, a group of men here from the greater Pittsburgh area are joining together to show their support to those facing a breast cancer diagnosis by serving as ambassadors for the seventh annual Real Men Wear Pink campaign. And whereas Real Men Wear Pink as a distinguished group of community leaders who are determined to raise awareness of and money to support the American Cancer Society mission to save more lives than ever from breast cancer. Now in its seventh year, the Real Men Wear Pink of Greater Pittsburgh campaign has raised nearly \$940,000 to date.

And whereas cancer touches each of us in different ways, I shared how it has touched me and our real men ambassadors each have personal reasons for participating in the campaign, and whereas this class of ambassadors and the reasons for involvement are listed below, what I'm going to do is recognize the individuals that are serving as ambassadors, but I won't read their bios, but they will be entered into the record. And all of you have been given a copy, so you have the ability to see that.

I want to recognize Joe Beatty of Cranberry Township, Joe Ferrante of Fox Chapel, Rob Freed of Prospect, Wyatt Geller of Sewickley, Adam Gunnett of Monroeville, Ray McShane of Bridgeville, Dr. Matt Miller of Sewickley, Paul Powell of Shaler, Paul Purdy of Bloomfield, Nick Reiser of Freeport, Rick Satcho of Coraopolis, Jeff Smercani of Brentwood, Bill Stull of Wexford, Dr. John Vargo of Canonsburg, and Troy Witt of Bloomfield.

All of these folks have stepped forward to serve as ambassadors in this program here to bring awareness to breast cancer and the - the diagnosis of it - of women to support them and to raise money for this cause. I want to thank you all, I can't thank you enough.

Now therefore be it resolved that I, Sam DeMarco and all members of Allegheny County Council do hereby recognize the American Cancer Society of the 2022 Real Men Wear Pink of Pittsburgh ambassadors, for helping create a world free from the pain and suffering of breast cancer. In witness thereof by hereto unto for cause the seal of the County of Allegheny to be affixed this 25th day of October 2022.

How about a round of applause for these wonderful ambassadors?

Let's go get pictures, guys. Or wait - wait a minute. Hey, does anybody want to say anything here? Well, let's go get pictures then.
