



President Catena named Councilman John Palmiere to serve as the new Vice-President. New Members of Council

We would like to take a moment to especially welcome the two new members of County Council, Jack Betkowski and Michelle Naccarati-Chapkis . Both were sworn in at the January 3rd Regular Meeting of Council for a four year term.



A life-long resident of Allegheny County, Jack is currently retired after a 34-year career with the Federal Reserve Bank of Cleveland. During his professional career, he was trained as a project manager and worked extensively in payments processing. He received his MBA and B.S.B.A. with a concentration in Information Systems from Robert Morris University.

Prior to being elected to Allegheny County Council in November 2021, Jack was twice elected to the Ross Township Board of Commissioners, serving from January 2016 through December 2021. As a member of the Board, he served on the Public Safety and the Finance Committees. While on the Ross Township Board, he served as the township representative to CONNECT and the North Hills Council of Governments (NHCOG). Jack also served as a Director for the Allegheny County and Western Pennsylvania Association of Township Commissioners (AC&WPATC). Prior to being elected commissioner, Jack served as a member of the Ross Township Zoning Hearing Board.

New Members of Council



Michelle Naccarati-Chapkis was born and raised in Allegheny County. As executive director of a regional nonprofit, Michelle has spent the last 12 years providing educational programming and technical assistance that focuses on environmental health and addresses the myriad of social determinants of health. Her emphasis is working with and in environmental justice communities. Michelle has used this expertise to work closely with several Allegheny County departments. Prior to that role, she worked for 14 years for a regional land trust acquiring properties for the protection of the environment and the public's benefit, including additions to North Park and South Park. Michelle is married to David Chapkis and they have three children: Sofia, Dominic and Julia. She was part of the first graduating class at Woodland Hills High School and received her bachelor's degree from the University of Pittsburgh, as well as attended Leadership Pittsburgh. Michelle has lived in Plum Borough since 1999 and participated on the borough's comprehensive planning and zoning ordinance committees. She currently gives back to her community by serving on the Plum Zoning Hearing Board.

FireVEST

Allegheny County is home to more than 200 volunteer fire companies. Volunteer firefighters protect over 910,000 people and save the taxpayers of the county an estimated \$60 million dollars a year.

To ensure the safety and well-being of our communities, in 2008, the Allegheny County Fire Volunteer Education, Service & Training Scholarship Program (FireVEST) was established through a partnership between the Allegheny County Fire Academy and the Community College of Allegheny County (through the CCAC-Allegheny County Workforce Alliance); and

200 FireVEST scholarships, covering tuition, fees and books, are offered each year – 150 for new recruits in exchange for five years of volunteer service and 50 for existing volunteer firefighters in exchange for an additional five years of service in Allegheny County. Over the years, FireVEST scholarship recipients have majored in programs such as Fire Science Administration, Criminal Justice & Criminology, Business Management, Nursing, and more.

A founding member of the FireVEST program, Conncil Member Bob Macey was recently appointed as a board member to FireVEST by CCAC. Congratulations Council Member Macey!



HOW TO APPLY

Annual Application Deadlines:
postmarked by May 15 for Fall term start postmarked by November 15 for Spring term start

Applicants must join or be a current member in good standing of an eligible volunteer fire company, complete CCAC's admissions process, including filing for financial aid and be accepted for enrollment into the college.

1. Submit a CCAC Admissions Application to CCAC.

2. File FAFSA on www.fasfa.ed.gov

Applicants must also complete the electronic FireVEST application process, emailing all materials using the email address on the first page of the application. These materials include the scholarship application packet, volunteer service commitment agreement (signed by the sponsoring agency), application check-list and training timeline, and a letter of reference.


