- Complete a short application via Allegheny County's online grant portal (link available on the ACED website).
- Clearly define project scope, goals, community benefits, budget, and timeline.
- Provide documentation of any other funding sources if applicable.

# **Public Comment Highlights**

#### Comment 1:

• Ask if there were any restrictions that were not listed.

#### Comment 2:

- Underscored the importance of spotlighting communities that have historically been overburdened by pollution and other environmental hazards.
- Spoke about the easy application process
- Dr. Vann noted the need to broadly disseminate these data tools to ensure stakeholders at all levels—community groups, public agencies, and policymakers—have access to timely, accurate information. Widespread awareness and shared understanding of air quality issues foster stronger collaboration and more effective solutions.
- Dr. Vann highlighted the critical role of transparent air quality data in informing both immediate
  actions and long-term planning. The 2023 Air Quality Index Map and the latest Air Quality
  Report serve as key resources for local organizations, healthcare providers, and residents.

## Comment 3:

- Clarify U.S. Steel's Actions Clearly outline what U.S. Steel has done and its impact on the community.
- Address Ineffective Communication Highlight the vague or misleading language that has been used to discuss these issues.
- **Provide Historical Context** Walk through the history of U.S. Steel's actions in the region and their consequences.
- **Ensure Transparency** Clearly communicate how the Mon Valley Public Health Funds are being used to address these challenges.

### Comment 4:

- Wanda expressed gratitude for the program and the air quality projects receiving funding.
- She also raised concerns about schools and municipalities being ineligible for funding.
- Jenn Saks responded, explaining that the requirement for organizations to be 501(c)(3) was outlined in the consent decree.
- Dr. Vann suggested that these organizations could collaborate with smaller groups, such as the AIU, to access funding opportunities.

#### Comment 5:

- Discussed a project called **Storybrook** and its objectives.
- Provided updates on **RDIC investments** and the development of new programs.
- Lauren C. acknowledged her familiarity with the project and stated she would follow up.
