A. ALLEGHENY COUNTY ECONOMIC DEVELOPMENT, COMMUNITY INFRASTRUCTURE & TOURISM FUND (CITF)- O'CONNOR'S CORNER-SCOPE CHANGE

Request Authorization to: (i) change the scope of work to include the purchase of benches to be installed along Murray Ave. and Forbes Ave. in Squirrel Hill; (ii) revise the budget to transfer \$12,889.78 from New Construction to New Equipment; and (iii) allow the Director to execute the necessary documents with Solicitor approval.
