D. BRILLIANT LINE ACQUISITION

Request authorization to execute an option assignment agreement with Allegheny RiverTrail Park (ARP); compensate ARP\$160,795 for holding costs associated with their option agreement with Allegheny Valley Railroad (AVRR); maintain and exercise the option with AVRR by making required option payments and executing sales agreement with AVRR for a price to be determined by the Director; allow for site stabilization, site security and fencing, studies, planning, design, engineering and construction associated with the Brilliant Line; and allow the Director to execute necessary documents with Solicitor approval.
