Good evening,

My name is Dustin Pierce. I'm a resident of Springdale and serve as the Judge of Elections for Springdale Borough District 4, and have done so for the past five years. I served as a Judge of Elections for the February 7 special election, serving in Penn Hills Ward 5, District 6. Overall, it was a wonderful experience. The teams of dedicated poll workers who normally call this precinct and the neighboring one their home were welcoming, diligent, and knowledgeable, boWHAT th of election procedures and their local community. The county election employees and the county employees serving as rovers, leads, and returns staff made the day go smoothly. Please consider the following feedback- what went well, what could improve, and some suggestions to make things go more smoothly.

WHAT WENT WELL:

- -Provisional ballot envelope now longer has the line that refers to the old practice of the county providing blank provisional ballots
- -There was a really good and easy to reference handout provided to election boards about poll watchers, voter intimidation, challenges, etc
- -This may not be new, but I never noticed before. At the bottom corner of each page of the poll book, there was a notation of the first three letters of the first and last name on the page- for example Smi-Sno. This made finding voters a bit easier.
- -The privacy screens all had instructions on how to correctly fill out circles on ballots. This was good but wasn't at every precinct. We made copies for ours which was good, as rovers looked for them.

WHAT COULD IMPROVE:

- -One of the regular board members showed, but indicated she wasn't called to work. She wanted to show in case she was needed. One person had to bow out that morning so it worked out for us anyway.
- -February" was misspelled on the poll book cover. Voters would likely never see this but easy catches not being caught is a personal pet peeve.
- -Info about sites is desperately needed. No info was communicated about parking, which entrance to use, etc. with no signs at the polling place I had to guess, and guessed wrong a few times.

-Beginning/End of day checklist is two sided with paperwork team on one side and machine team on the other. Should be one-sided so each team can have one.
-There's nothing to attach the surrendered absentee declaration to the actual ballot and envelope. Good staplers would be ideal.
SUGGESTIONS:
-My board was fully staffed. I was able to get a list of members and contact info by asking, but this might be more helpful if provided without request- it could be sent with training reminder emails and/or the supply pickup letter.
-Maps are good, but small and not easy to read for oddly shaped districts. There should also be a list of streets and numbers- for example, 400-699 Chestnut, 400-698 Freeport even numbers only, etc.
-Training should include some info on media interactions. Another judge at my site talked to a reporter who was there, and attempted to engage me in answering the reporter's questions, which I avoided.
-The stickers identifying board members aren't great- these are mailing labels with the name of the role printed in plain text, which would be easy to replicate for bad actors. This should look better and more official. The attached from another county is better.
