I. CALL TO ORDER –Meeting called to order by Assistant Solicitor Opsitnick at 11:30 AM. Roll was taken by Mr. Opsitnick. All members present, in person.

Mr. Opsitnick noted that, as this is the first meeting of the Board of Elections under its current membership, there is no Chair and nominations for Chair are required.

Member Hallam nominates Chief Executive Innamorato. Seconded by Chief Executive Innamorato. No other nominations for Chair.

Vote taken. Member Hallam, yes. Chief Executive Innamorato, yes. Member DeMarco, abstain.

Point of order by Member Hallam asking Member DeMarco to explain abstention. Member DeMarco cited litigation as reason for his abstention.

### II. APPROVAL OF BOARD MINUTES OF NOVEMBER 27, 2023, MEETING

Mr. Opsitnick then requested approval of Minutes of November 27, 2023 Board meeting certifying the results of the November, 2023 Election, explaining that, while none of the current Board members we on the Board in November, their obligation is to review and approve prior meeting minutes.

Moved by Chair Innamorato. seconded by Member Hallam. Comment by Member DeMarco that at the November 2023 Election over 1,000 ballots were not able to be counted as they were delivered by the Post Office after the Election Day deadline. Vote to approve 3-0.

#### IV. GENERAL PRIMARY PREPARATIONS

Question by Member DeMarco about modifying website to permit easier sign up to participate in BOE meetings. Ms. Garofolo, that will be done promptly.

Question by Member Hallam requesting to posting the legal procedures to remove voters from rolls and to canvass ballots. Ms. Garofolo, the FAQs can be updated.

Mr. Voye addressed Primary Election preparations:

- 1. Approx. 903,000 registered voters. Increase of approximately 3,000 from November;
- 2. Absentee and mail in ballot applications. 106,000. 88,000 Dem. 18,000 Rep.;
- 3. 57 polling places to be moved. 52 settled, 5 yet settled. 16 moved because of Passover;
- 4. Poll workers 6753 confirmed. Doing very well;
- 5. 2 Supreme Court cases pending affecting ability to print and mail ballots. Once cases are decided Logic and accuracy notice and testing can begin.

Member DeMarco commented to no ballot yet set and asked Mr. Voye to explain. Mr. Voye explains the testing, printing and mailing process and timeline. Elections prefers mailing 30 days beforehand. Law requires 14 days beforehand, so the legal requirement shall be met.

Member Hallam asked about whether the number of poll workers is actually confirmed. Mr. Voye said that poll worker number is confirmed. Indicated that poll worker lists change up until Election Day and Elections continues to recruit poll workers and has persons ready to step in at the last minute.

Ms. Garofolo said that poll workers are needed in Moon, Pittsburgh in certain areas, Baldwin and Brentwood.

All polls have at least 4 poll workers.

#### V. DISCUSSION OF RESOLUTION REGARDING BALLOT RETURN SITES

Mr. Opsitnick requests consideration of Resolution. Moved by Chair Innamorato. Seconded by Member DeMarco.

Comment by Ms. Hallam, that she favors ballot return sites and satellite voting locations, but big hole in the Mon Valley, so the Resolution adds a ballot return site in McKeesport, location to be determined and reads part of the Resolution. Urges to use ballot return sites at every location.

Discussion. Mr. DeMarco. Differentiates ballot return sites from drop boxes, with 3 county staff and county police officer present, with access to disable. Boxes shown to be open, then sealed and locked with custody before transmission to Elections Warehouse, by site supervisor and County Police officer. Ballots in locked cage under 24-hour surveillance. Mr. Voye confirms those arrangements.

Ms. Hallam inquired as to police officers present. Ms. Garofolo stated that police officers will be outside of the ballot return site to ensure access and safety. Police officer signs off on chain of custody form as well. Similar protocols as used in 2020.

Mr. DeMarco commented that people are torn regarding ballot return sites. But he votes by mail and the ballot return sites are open to all voters and as a result he supports the Resolution.

Chair Innamorato stated her appreciation for the various County offices and persons that helped prepare the ballot return site plan.

Resolution approved by 3-0 vote.

#### VI. NEW BUSINESS

Next meeting set for April 9, 3:00 PM.

Member Hallam does not feel that voter registration efforts at jail fall short and requests that someone go pod to pod at the jail.

Member DeMarco objects to County involvement in registration efforts and thinks that a third party need to conduct this effort and mentioned League of Women Voters.

Member Hallam would prefer a third party provide this effort.

Chair Innamorato pledges all tools available to assist in jail registration and voting.

## VII. ADJOURNMENT

Motion to adjourn. Moved by Chair Innamorato, seconded by Member DeMarco passed 3-0. Meeting adjourned at approximately 12:45 P.
