Please see my request below to *submit written comments, and speak in person* at the Monday, April 25th BOE meeting.

Written Comments for Submission:

Approximately half of the counties in Pennsylvania allow for male or female to fill the position of "ELECTED COMMITTEEMAN", verses demanding one man and one woman. Allegheny County should not be trailing in this legislation which limits our ability to fill these critical positions most efficiently and effectively. Below is an example of the Bylaws from Luzerne County:

"BY-LAWS REPUBLICAN PARTY

Bylaws from II. LEGISLATIVE DISTRICT COMMITTEE Each Legislative District Committee shall be composed of two (2) qualified Republican Electors, male or female, from each voting precinct in that Legislative District and a District Chairman to be elected as hereby provided.

"Committeeman" shall include both male and female gender, shall be elected at the Spring Primaries in the even number years by the Republican Voters of his voting precinct to serve a term of two (4) years."

My question to the BOE is: When can we expect Allegheny County to step-up to the plate and make this change? Can we do this before this May 17th Primary? If not, please explain why?
