Leroy Irvis (KLI) Building. If no one is registered to give testimony at the hearing by Thursday, December 12 the hearing will be canceled. If the hearing is canceled, the Department will provide public notice on the webpage or through the contact information listed above. When making comments on previously issued installation or operating permits being modified, please consider the modified language only.

INTENT TO ISSUE OR MODIFY INSTALLATION PERMITS

ARDENT DATA CENTER (0819-1002), 615 McMichael Road, Pittsburgh, PA 15205 for the installation of six diesel fueled emergency generators. The installation will result in the following potential increase in emissions: 0.23 tons/yr of particulate matter (PM), 0.23 tons/yr of particulate matter less than 10 microns (PM₁₀), 1.04 tons/yr of sulfur oxides (SOx), 65.58 tons/yr of nitrogen oxides (NOx), 2.93 tons/yr of carbon monoxide (CO), and 3.61 tons/yr of volatile organic compounds (VOCs).
