The Allegheny County Health Department (ACHD) hereby submits, using the U.S. Environmental Protection Agency (EPA) State Planning Electronic Collaboration System (SPeCS) State Implementation Plan (SIP) submission system, a requested revision to Allegheny County's portion of the Pennsylvania State Implementation Plan for the Attainment and Maintenance of the National Ambient Air Quality Standards. This revision request amends the sections of Article XXI, Air Pollution Control Rules and Regulations, and County Ordinance 16782, listed below, as they relate to public notice provisions for permits, and permit applications: This SIP Revision Request is being tracked as our internal Revision Tracking Number 95.

§2101.20, "Definitions"
§2102.03, "Permits Generally," Subsections b, j, and m, but excluding Subsection "l."
§2102.04, "Installation Permits"
§2102.05, "Installation Permits for New and Modified Major Sources"
§2103.11, "Operating Permits (All Major and Minor Permits) - Applications"
§2103.14, "Operating Permits (All Major and Minor Permits) - Revisions, Amendments, Modifications"

This revision was the subject of a public comment period from October 4, 2021, through and including November 3, 2021, with a public hearing held on November 3, 2021. The Board of Health approved it on January 5, 2022. County Council enacted it on September 13, 2022, it was signed by the Allegheny County Chief Executive on September 16, 2022, and it became effective September 26, 2022.

{ACHD notes that it will also be submitting under a separate transmittal letter, a related, but separate Title V Partial Operating Permit Program revision request that is comprised of the sections of Article XXI listed above and several others. That submittal will be tracked by our internal Revision Tracking Number 95A.}

ACHD followed all the applicable procedural requirements of the Commonwealth's laws and constitution in conducting and completing the adoption/issuance of the SIP revision. ACHD also publishes the proposed SIP Revision on its website at <https://alleghenycounty.us/Health-Department/Programs/Air-Quality/Regulations-and-SIPs.aspx> in accordance with PA State Act 27
