Below is a list of facilities in Allegheny County required to obtain a Title V Operating Permit under the Clean Air Act, Part 70. Once a permit is drafted, there is a minimum 30-day public comment period, followed by a 45-day EPA review period. Permits are issued for a 5-year term (although the conditions will remain in effect until a new permit is issued). Title V Operating Permits incorporate the conditions of all existing operating and installation permits, as well as any other conditions necessary to demonstrate compliance with the Clean Air Act and Allegheny County's Article XXI. The issued permit includes the Operating Permit , the Technical Support Document, and the Comment/Response Document.
