# **Article XXI Air Pollution Control**

## Air Quality Permit Fee Amount and Regulation Changes

Board of Health March 8, 2021





Request the Allegheny County Board of Health to approve minor changes to Permit Fee regulations to accommodate new affective dates and correct reassignment of certain fees to the Title V Air Quality Fund.

Request the Allegheny County Board of Health to approve the proposed Air Quality fee amounts.



## **Air Quality Fee Regulation Changes - State**

- Pennsylvania approved state-wide (outside of Allegheny County) change in fees effective January 16, 2021.
- > New application fees applicable January 17, 2021.
- Invoices for 2021 annual fees mailed to sources in late January or early February; payments due in March.
- Allegheny County proposed fees are set the same as the state, modified only to accommodate small differences in permitting procedures.



## Air Quality Fee Regulation Changes

- > Board of Health approval of regulations May 4, 2020.
- Setting of fee levels deferred until the state fees became final.
- Since state fees delayed until 2021, implementation dates have changed.



## **Proposed Changes since May 2020 Board**

**2103.40c.** Annual Operating Permit Maintenance Fee. Beginning for calendar year 2021, an owner or operator of a source that has submitted an application for an operating permit under this Part shall pay an annual operating permit maintenance fee in the amount set by the Board of Health. For calendar year 2021, the annual operating permit maintenance fee is due on or before December 31, 2020 blank [Editor's Note: THE **BLANK REFERS TO THE DATE 60 DAYS AFTER THE EFFECTIVE DATE OF ADOPTION OF THIS PROPOSED RULEMAKING**]. For subsequent years, the annual operating permit maintenance fee is due on or before December 31 of each year for the next calendar year. The owner or operator shall pay the fee while such application is being reviewed and then during the term of any permit subsequently issued.

Explanation: to reset a deadline that has already passed.



## **Proposed Changes since May 2020 Board**

2109.07b. Disposition of Monies Collected.

1. All interest received by the County under this Article as a result of emissions fees under SECTIONS 2102.10.h, 2103.40.i, AND §2103.41.a.1 of this Article shall be paid into the Allegheny County Air Quality Fund for the major operating permit program.

All interest received by the County under this Article as a result of fees, other than the emissions fees under SECTIONS 2102.10.h, 2103.40.i, AND §2103.41.a.1 of this Article, shall be paid into the Allegheny County Air Pollution Control Fund.

Explanation: to allow major source fees other than emission fees to be deposited into the Title V Air Quality Fund.



## **Proposed Changes since May 2020 Board**

2109.08e. There is hereby established the "Allegheny County Air Quality" Fund" for the major operating permit program which is specifically for the deposit of all emission fees, and related interest, and only such fees and interest, required to be collected by the County UNDER THIS ARTICLE TO IMPLEMENT THE REQUIREMENTS OF by Title V of the Clean Air Act, and the disbursement of such funds, and only such funds, solely to cover all of the costs of the County's air pollution control program required by Title V of the Clean Air Act. All funds received by the County under this Article as a result of major source emissions fees, and related interest, COLLECTED FROM SOURCES THAT REQUIRE A **MAJOR OPERATING PERMIT**, and only such funds, shall be paid into the Allegheny County Air Quality Fund for the major operating permit program.

Explanation: to allow major source fees other than emission fees to be deposited into the Title V Air Quality Fund.




## Need for Fee Change

- Inflation costs (31% since fees last set 2005)
- Increased staff (7 in last 2 years)
- Federal requirement that major sources pay costs to enforce major sources
- Fulfill needs "to be consistent with state"
- Emission fees for major sources increased each year to adjust for inflation (CPI)
- Decreasing emission fees while work increases



# Need for Fee Change



Emission fees have been going down while the number of source remain the same, and work increases

- Method 303 inspections

### ACHD fees to be consistent with PA DEP

- Title V permitting implementation agreement between ACHD, PA DEP and EPA states that "[a]s necessary, ACHD shall modify the [Title V] permit fee schedule to be consistent with the DEP fees."
- Emission Fees are set by the state and increased each year by the consumer price index.



## **Comparison with the State Fee Needs**

### Pennsylvania

DEP prepared "Fiscal Analysis and Fee Report." only reviewed staff time directly with permitting, but did not include compliance & enforcement actions, regulation development, air quality monitoring, fixed and operating costs.

### **Allegheny County**

ACHD performed a workforce analysis of permitting section. Next year ACHD performed a workforce analysis of the remainder of the program.

Though difficult to compare precisely, the time and efforts to complete the work are very similar between the county and the state.

# "Small" Minor source

Not in regulation, but in the fee table.

A "Small" minor source is a subset of sources that would <u>not</u> have been charged an annual fee under the state schedule, but rather paid a fee under the state general permit program.

These include sources that consist only of small boilers, emergency generators, and crematories.
