**RE:** Notice of Violation #ASB-21-0305 – Violations of Article XXI ("Air Pollution Control") at property 243 W. 8<sup>th</sup> Ave., Tarentum, PA 15084

Dear Mr. Allen.

On July 15, 2020, the Allegheny County Health Department (ACHD) was requested by DJ Demo Company to perform a final clearance inspection for the address 243 W. 8<sup>th</sup> Ave, Tarentum, PA 15084. An ACHD Representative was unable to perform this final clearance inspection due to Allen Demolition commencing the demolition of the structure prior to this inspection. The final clearance paperwork details, "Containment could not be inspected due to demolition contractor starting prior to final clearance inspection." Allen Demolition removed the containment barriers prior to the final clearance inspection.

The above condition is a violation of Allegheny County Health Department Rules and Regulations, Article XXI ("Air Pollution Control"), Section 2105.63.k.1, which states:

No person shall remove containment barriers, fail to continue to maintain negative air pressure at a project work area, or reopen the work area to the public, or allow any such removal, failure, or reopening, until such time as the Department has accepted the results of a final clearance inspection or reinspection for such work area.
