RE: Notice of Violation #ASB-21-0602 – Violations of Article XXI (“Air Pollution Control”) at property 4724 Baum Blvd. Pittsburgh, PA 15213

Dear Sir or Madam,

On March 30, 2021, a final clearance inspection for permit PAA21-0130 was performed at 4724 Baum Blvd. by the ACHD to reopen the work area to the public. Upon inspection by the ACHD, the containment was determined to be cut prior to the final clearance inspection by the General Contractor on site, Waller Corporation.

Please allow this correspondence serve as notice to Carnegie Library of Pittsburgh and Waller Corporation of the following violations of the Allegheny County Health Department Rules and Regulations, Article XXI (“Air Pollution Control”):

- a. **Article XXI § 2105.63.k.1:** The unauthorized removal of containment barriers or reopening of the work area to the public and/or failure to maintain negative air pressure until the final clearance inspection results were deemed acceptable.

This Notice of Violation is neither an order nor any other final action of the Allegheny County Health Department. It neither imposes nor waives any enforcement action available to the Department under any of its statutes. If the ACHD determines that an enforcement action is appropriate, you will be notified of the action. Please be aware that any violation

of the Article XXI regulations subjects a person to a variety of enforcement actions, including a civil penalty of up to \$25,000 per violation per day.

If a meeting is not requested, the ACHD will proceed with further enforcement action.
