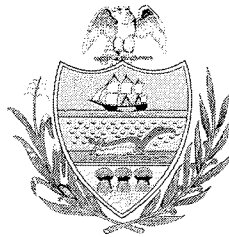

RE: Harsco Natrona Facility, Federal St. Gate #10, Natrona, PA, 15065 – Written demand for stipulated penalties under Section IV of the Consent Order and Agreement

Dear Ms. Calderazzo and Mr. Ramsey:

The Allegheny County Health Department (hereinafter “ACHD”) determined two violations of Article XXI, §§2105.49 and 2101.11, for the period from January 1, 2021 through March 31, 2021. The ACHD received residential deposition complaints on March 9, and March 10, 2021. An ACHD representative observed dust on residents’ vehicles during complaint response investigations on March 9, and March 10, 2021. The dust observed on residents’ vehicles was consistent with slag fugitive emissions from Harsco and ATI operations. Based on the ACHD representative’s observations, Harsco and ATI are found to be in violation of Article XXI, §§ 2105.49 and 2101.11.

Section IV.B. of the Consent Order and Agreement dated January 7, 2020 states that Harsco and ATI are liable for stipulated penalties of \$1,500 per deposition episode for violations 1 through 20. Two deposition episodes were confirmed, totaling **\$3,000.00** in stipulated penalties.
