**RE: Notice of Violation # 220802** – Violations of Article XXI (“Air Pollution Control”) at property 150 Ferry Street, Creighton, PA 15030.

Dear Sir or Madam,

On June 29, 2021, the Allegheny County Health Department (ACHD) received a complaint regarding fugitive emissions for 150 Ferry Street, Creighton, PA 15030. On June 29, 2021, ACHD representatives met with Pittsburgh Brewing Company representatives at 150 Ferry Street, Creighton, PA 15030 to perform an inspection. There was no active blasting occurring during the inspection. Previously blasted and painted metal beams were observed. A pallet of abrasive blasting sand and blasting pot were observed during the inspection. Pittsburgh Brewing Company did not hold an ACHD permit or submit a notification at the time of the inspection. Pittsburgh Brewing Company representatives voluntarily stopped work. On July 1, 2021, Pittsburgh Brewing Company responded to the inspection by sending in an abrasive blasting notification with all required documentation. ACHD approved the abrasive blasting notification.

Please allow this correspondence to serve as notice to Pittsburgh Brewing Company of the following violation (s) of the Allegheny County Health Department Rules and Regulations, Article XXI (“Air Pollution Control”):

- a. **Article XXI § 2105.51.a:** Failure to submit an Abrasive Blasting Notification Form prior to abrasive blasting work starting on a project which has a total area greater than 1,000 square feet.
