### PART 1: DESCRIPTION OF INSPECTION(s)

On May 2, 2022, via email, an ACHD Representative informed PPG Paints Arena Representatives that their permit was expired and requested that, no later than May 10, 2022, PPG Paints Arena submit a minor source renewal permit application and fee for the Minor Source Operating Permit that had expired on October 24, 2018. PPG Paints Arena representatives did not respond to ACHD's request.

On September 29, 2022, via email, an ACHD Representative again requested that PPG Paints Arena Representatives submit a minor source renewal permit application for the PPG Paints Arena Minor Source Operating Permit that had expired on October 24, 2018. ACHD also requested semiannual reports and certifications of compliance from 2018 to 2022. PPG Paints Arena Representatives again failed to submit any of the requested documentation.

An inspection of the facility occurred on October 14, 2022, during which an ACHD Representative informed PPG Paints Arena representatives in person of the delinquent application and reports.

On December 15, 2022, via email, an ACHD Representative again requested from PPG Paints Arena Representatives required documentation. The documentation requested from PPG Paints Arena Representatives included: 1) a minor source permit renewal application; 2) certificates of compliance for April 1, 2021 – March 31, 2022; 3) semi-annual reports for Jan 1, 2021- June 30, 2021, July 1, 2021 – December 31, 2021, and Jan 1, 2022 – June 30, 2022; 4) building natural gas meter readings for the last 12 months; 5) fuel usage logs; 6) boiler adjustment records; 7) emergency generator operations and maintenance logs for the last 18 months; 8) fuel rating certificates for the last 2 deliveries; 9) Bill of Lading (BOL) of the last 2 diesel deliveries; 10) Cold Start information; 11) and Total Dissolved Solids (TDS) reports for the cooling tower. PPG Paints Arena Representatives were to provide the documentation by Friday, January 6, 2023. As of January 13, 2023, ACHD has not received any of the requested documentation.

PPG Paints Arena Representatives have failed to respond to four requests to submit their minor source renewal permit application. Additionally, PPG Paints Arena Representatives have failed to respond to two requests for required reports and other documentation. Furthermore, PPG Paints Arena Representatives are required to submit the requested application, reports, and documentation, regardless of whether ACHD Representatives requested them.

	Submit Certificate of Compliance for the period of April 1, 2021 – March 31, 2022; and Semiannual Reports for the periods of January 1, 2021 – June 30, 2021, July 1, 2021 – December 31, 2021, and January 1, 2022 – June 30, 2022.		
	Submit: 1) natural gas meter readings for the last 12 months; 2) fuel usage logs; 3) boiler adjustment/maintenance records; 4) emergency generator operation and maintenance logs (last 18 months); 5) fuel rating certificates (CFAs) for the last two diesel fuel deliveries; 6) Bill of Lading (BOL) of the last two diesel fuel deliveries; 7) cold start information; and TDS 8) reports for the cooling tower.		

The Order(s) in this Part is enforceable upon issuance and any appeal shall not act as a stay. The Order(s) shall remain in effect until you are notified in writing by the Department. Please contact the ACHD Air Quality Program at (412) 578-8103 to arrange for a reinspection or to request that the Order(s) be rescinded.

Please be advised that failure to comply with this Order within the times specified herein is a violation of Article XXI giving rise to the remedies provided by Article XXI § 2109.02, including civil penalties of up to \$25,000 per violation per day.

#### PART 5: REQUEST FOR ADMINISTRATIVE HEARING

Pursuant to Article XI, § 1104.A ("Hearings and Appeals"), of the Allegheny County Health Department Rules and Regulations, you are notified that if you are aggrieved by this Order, a Notice of Appeal shall be filed no later than thirty (30) days after receipt of written notice or issuance of this Order. Such a Notice of Appeal shall be filed in the Office of the Director at 542 Fourth Avenue, Pittsburgh, PA 15219.

This Order is enforceable upon issuance and any appeal of this Order shall not act as a stay unless the Director of the ACHD so orders. In the absence of a timely appeal, the terms of this Order shall become final.

Please be aware that if you wish to appeal this Order and a civil penalty has been assessed under Part 4, you are required within thirty (30) days of receipt of this Order to either forward the penalty amount to the ACHD for placement in an escrow account or post an appeal bond to the ACHD in the amount of the penalty. Please review the specific requirements for prepaying the penalty or posting the appeal bond found in Article XXI § 2109.06.a.2-3.
