#### PART 1: DESCRIPTION OF INSPECTION(s)

The Allegheny County Health Department (ACHD) issued a Title V Operating Permit to the Brunot Island Generating Facility on August 26, 2019 for the operation of a power generation facility with 3 natural gas turbines with heat recovery steam generators. Condition IV.8.a of its permit requires the facility to report a breakdown of control or process equipment within 60 minutes of commencement of the breakdown. Condition IV.8.d requires the Facility to notify ACHD within 7 days of the equipment being returned to normal operation.

Unit #3 experienced a CEM data error on December 15<sup>th</sup>, 2023. The issue was reported to ACHD within 60 minutes. The breakdown was resolved on December 15<sup>th</sup>, 2023. The follow-up seven-day report was due Friday, December 22<sup>nd</sup>, but it was submitted on December 29<sup>th</sup>, the 14<sup>th</sup> day following the incident.

Brunot Island Generating Facility failed to submit a timely follow up breakdown report.

Such a Notice of Appeal shall be filed in the Office of the Director at 542 Fourth Avenue, Pittsburgh, PA 15219.
