



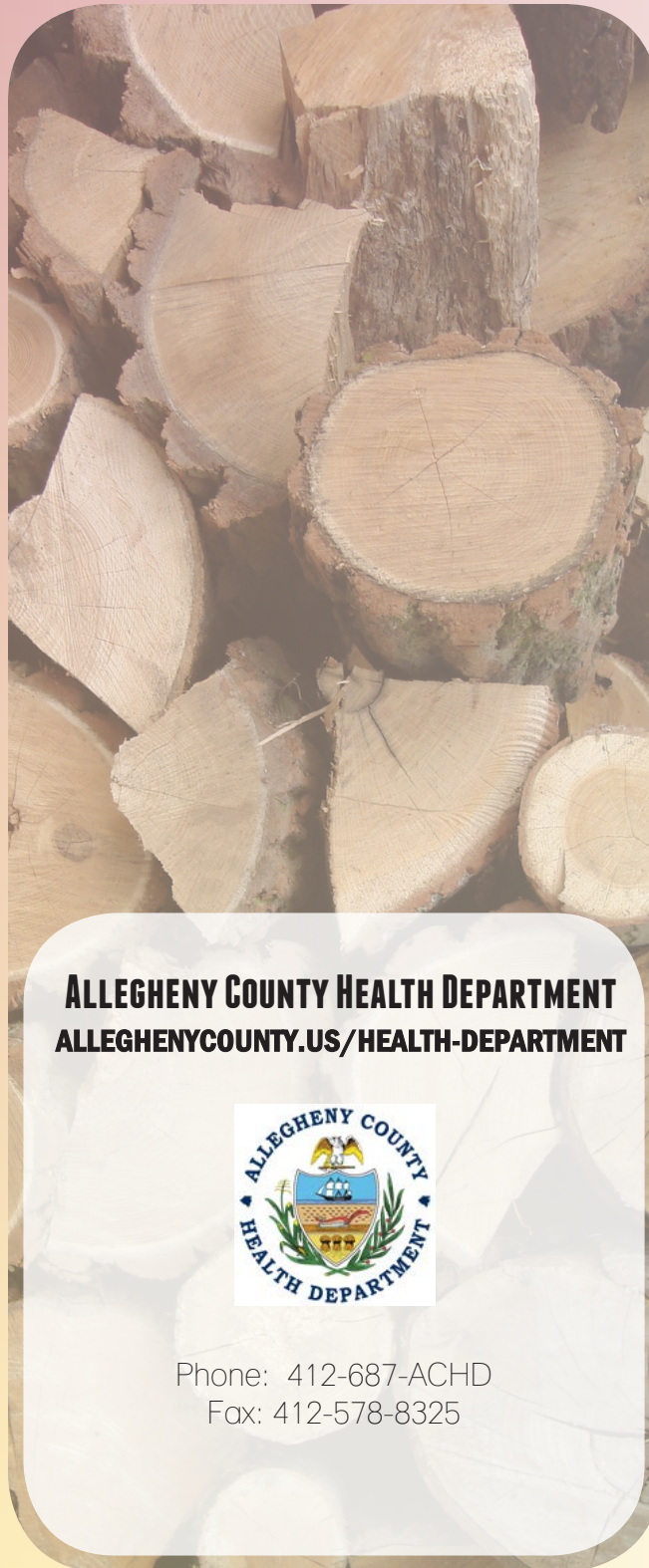

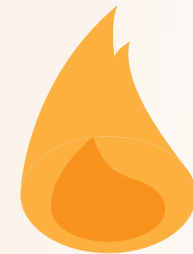

Wood smoke contains pollutants and can be a nuisance. Learn how to reduce smoke production, save fuel, and burn safely.

WOOD SMOKE CONTAINS

H A R M F U L

Carbon Monoxide, Methane, Formaldehyde, Benzene, Toluene, and Sulfur Dioxide are examples of only a fraction of the pollutants that are found in wood smoke.

Pollutants from wood smoke can aggravate cardiovascular and respiratory conditions, such as asthma. They also contribute to a regional fine particulate pollution problem.



3 STEPS TO CLEAN BURNING

BURN HOT

Burning at high temperatures means that your fire isn't smoldering, or creating excess smoke. When you burn hot, you burn more of your wood fuel, and less of it is lost through your chimney.

BURN DRY

When burning, only burn properly seasoned, dry wood. Moist or green wood renders your fire less efficient. You're not using your fuel to its maximum potential, and you're creating nuisance smoke. Let your wood season during the summer, until the end grain shows cracks.

BURN SAFE

Keep a smoke detector, carbon monoxide detector, and a fire extinguisher nearby at all times. Don't burn anything that isn't clean, dry wood. Paint, wood finish, and glues such as those in particleboard burn as well. If they or other wastes are thrown in with clean, dry wood, you will produce harmful air toxics that you and your family end up breathing. Keep your fireplace, insert, and chimney properly maintained year-round.

ODOR NUISANCE VISIBLE EMISSIONS

If nuisance odors cross your property line into a neighbor's, they can file a complaint with ACHD. This could lead to enforcement actions. Reducing smoke production and burning only properly dry and clean wood will reduce your risk of creating nuisance odors.

Every smoke stack, including your chimney, is considered a source by ACHD. Smoke emissions can not be greater than 20% opacity for any 3 minute period within 60 minutes, and they cannot exceed 60% opacity at any time.
