A public hearing will be held regarding the proposed issuance of these permits on **Monday, November 17, 2025, at 6 pm** in the conference room at the ACHD office at 836 Fulton Street, Pittsburgh, PA 15233. Anyone who would like to speak at the hearing should register online **at least 24 hours in advance** of the hearing on the Department's permits webpage at <a href="https://alleghenycounty.us/AQnotices">https://alleghenycounty.us/AQnotices</a>. If no one is registered to give testimony at the hearing by Thursday, November 13 the hearing will be canceled. If the hearing is canceled, the Department will provide public notice on the webpage or through the contact information listed above. When making comments on previously issued installation or operating permits being modified, please consider the modified language only.

#### INTENT TO ISSUE OR MODIFY INSTALLATION PERMITS

**ENERGY CENTER PITTSBURGH – NORTH SHORE (0022-1004),** 111 South Commons Avenue Pittsburgh, PA 15212, for the installation of 2 natural gas generator engines. The installation will result in the following potential increase in emissions: 1.34 tons/yr of PM, 0.07 tons/yr of SO<sub>x</sub>, 20.72 tons/yr of NO<sub>x</sub>, 10.36 tons/yr of CO, and 10.36 tons/yr of VOCs.

**WOOD WASTE RECYCLING – BRIDGEVILLE (0917-1002)**, 43 Prestley Road, Collier Township, PA 15017, for a yard waste and construction/demolition waste processing facility for the installation of grinding and screening equipment. This installation results in the following potential emission increases of criteria pollutants: 30.5 tpy of PM, 26 tpy of PM<sub>10</sub>, 24 tpy of PM<sub>2.5</sub>, 55.7 tpy of NO<sub>x</sub>, 0.02 tpy of SO<sub>x</sub>, 13.2 tpy of CO, 3.2 tpy of VOCs, and 0.04 tpy of HAPs.

**WOOD WASTE RECYCLING – NORTH FAYETTE (1019-1001)**, 111 Kelso Road, McDonald, PA 15057, for a yard waste processing facility for the installation of wood grinding and screening equipment. This installation results in the following potential emission increases of criteria pollutants: 9.4 tpy of PM, 6.6 tpy of PM<sub>10</sub>, 5.5 tpy of PM<sub>2.5</sub>, 29 tpy of NO<sub>x</sub>, 0.01 tpy of SO<sub>x</sub>, 7.3 tpy of CO, 1.2 tpy of VOCs, and 0.02 tpy of HAPs.

# INTENT TO ISSUE OR MODIFY MAJOR SOURCE (TITLE V) PERMITS

Under Article XXI, §2103.11.e. and §2103.21.c, notice is hereby given that the Allegheny County Health Department intends to issue a Title V Operating Permit to the following major facilities subject to the operating permit requirements under Title V of the Federal Clean Air Act and Article XXI, Part C, Subparts 1 and 2. The Administrator of the EPA is being notified of this proposed action.

MAGNUS PRODUCTS, LLC, (0265-OP22a), 1300 Braddock Avenue Braddock, PA 15104, for an amendment to the Title V Operating Permit for a steel waste material processing facility to update the emissions from the Rotary Kiln Dryer based on current stack test data. The change results in a 1.54 tpy increase in PM and a 12.85 tpy increase in VOC. The facility consists of two pugmills, two screens, two front end loaders, twenty-one transfer points, rotary kilns, three storage silos and storage piles. The facility is a minor source of all criteria pollutants and Hazardous Air Pollutant (HAPs), as defined in Section 2101.20 of Article XXI. However, it is considered a major source due to its operation in support of a major source facility, the United States Steel – Edgar Thomson Plant Waste Product Recycling and Briquetting Process.
