











Hospitalizations and Deaths by Vaccination Status








COVID-19 Wastewater Surveillance

Adjusted virus levels





Monkeypox Update

- Monkeypox spread through:
 - Direct contact with infectious rash, scabs or body fluids
 - Respiratory secretions during prolonged, face-to-face contact, intimate physical contact (kissing, cuddling or sex)
 - Touching objects, fabrics (such as clothing or linens) that previously touched rash or body fluids of someone with monkeypox
 - Pregnant people to fetus via placenta
- Can be acquired by all people, regardless of gender or sexual orientation

Orthopoxvirus (genus of variola (smallpox), vaccinia (used in smallpox vaccine), cowpox. **Not related to chickenpox**)



Monkeypox Clinical Information

- Incubation period averages
 - 7–14 days (range 5–21 days)
 - Persons may not have symptoms and may feel fine not contagious

Prodrome

- Early set of symptoms: fever, malaise, headache, sore throat, cough, and swollen lymph nodes
- Not everyone has symptoms
- Persons may be contagious

Rash

- Following prodrome, lesions develop on body, mouth, eyes, palms, soles and progress through several stages
- Contagious from onset of symptoms until scabs healed over



Monkeypox Treatment and Prevention

- Vaccines
 - JYNNEOS
 - Live vaccine from attenuated, nonreplicating orthopoxvirus
 - Licensed by FDA Sept 2019 smallpox and monkeypox disease prevention in adults >18 at high risk for infection
 - ACAM2000
 - Considerations for Monkeypox Vaccination | Monkeypox | Poxvirus | CDC
- TPOXX antiviral med for treatment of human smallpox disease
 - Requires CDC approval investigational drug
 - Specific clinical indications (e.g., severe disease or high risk)



Local Response to Contain Spread of Monkeypox

- Case investigation
 - Test to confirm monkeypox (state and commercial labs)
 - Complete case investigation form, identify and call close contacts
 - Supportive care typically enough consider antivirals with consultation
- Close Contacts
 - Monitor for 21 days
 - If develop symptoms test
 - Consider post-exposure prophylaxis with vaccines (depend on risk level)
 - Limited allocation of JYNNEOS vaccine to ACHD for high-risk individuals (more doses anticipated)
- Cases evaluated in outpatient clinics, including ACHD STD clinic



Bureau Updates

- Environmental Health
 - Air quality software on schedule for completion by end of year
 - Plumbing regulations passed (2015 IPC), today vote to send to public comments incorporation of 2018 IPC
 - Plumbing program to begin limited pilot program for virtual inspections
- Data Reporting and Disease Investigation
 - Continues work on COVID-19, monkeypox, other reportable diseases
 - Quality improvement project to ensure reports meet community needs
 - Significant role in preparing data for CHA






Overdose Deaths 2008-2021




Overdose Death Rate by County 2008-2020




2008 – 2021 Overdose Death Substance Trends




2008 – 2021 Drug Combinations in Overdose Deaths



Naloxone distribution 2021

- Naloxone distributed to 208 different organizations
- •9,585 total Kits Distributed
 - 60% of kits to target areas identified by hot-spot analysis
 - 2,681 kits to treatment/recovery and harm reduction organizations
 - 1,127 kits to social service agencies
 - 2,320 kits to non-traditional first responders such as schools, churches and small businesses
 - 1,860 kits to traditional first responders




Naloxone Distribution and Connection to Care 2020-2021

- •Hosted more than 130 trainings or events and distributed more than 9,000 kits of Narcan and trained over 3,893 people to administer. ACHD will receive 14,000 kits from PCCD over the next year.
- •Supported over 300 referrals for connection to treatment (MOUD). Partners include Bridge to the Mountains, HSAO, Squirrel Hill Health Center, and more.

Overdose Prevention Subawards

- Working with organizations serving high-risk populations
 - Reimagine Reentry (returning citizens)
 - Individuals on probation and parole
 - Liberations (Ukombozi) for community-based naloxone distribution
 - Za'kiyah House for recovery houses accepting MOUD
- Targeting hotspot areas in the county
 - McKeesport, Homewood, Braddock, Clariton, Beechview, Brookline, Homestead, Tarentum, East Liberty, Duquesne, and East Allegheny through NACCHO mini-grants, providing resources for substance use disorder and adverse childhood experiences

Program Update: Academic Detailing on MOUD

Clinical and Provider Support

Efforts through OD2A programming to educate providers on Medications for Opioid Use Disorder

Increase education of area service Increase capacity of area service providers on MOUD providers ACHD contracts with Alosa Health to Squirrel Hill Health Center provides technical assistance on starting MOUD target primary care physicians and encourage prescribing of Medication programs to other organizations for Opioid Use Disorder and Latterman continues to provide xrecognizing the signs of OUD. waiver trainings for residents Alosa and UPMC partner to educate Allegheny Health Network providing education on harm reduction to providers on tapering opioids and replacing with Buprenorphine provider groups

Other Program Updates

- "Small Changes, Big Differences" communications campaign
- Target audience: People who use drugs, Black individuals, friends and family of drug users
- Messaging on reducing stigma around substance use disorder and treatment, informing about the changing local drug supply, and promoting safety through lifesaving harm reduction tools, such as naloxone
- Campaign informed by focus groups, shared stories, and interviews on real experiences

Proposed Revisions to Article XV

Plumbing & Building Drainage

Overview

- Article XV is being revised as a result of the state's adoption of the 2018 amendments to the International Plumbing Code (IPC)
- Revisions were developed by the plumbing program, legal, and environmental health management
- Plumbing Advisory Board unanimously recommended the revisions on June 29, 2022
- The 2018 amendments are not as substantial as the 2015 amendments
- The amendments mainly clarify definitions and change verbiage in existing sections



Examples of Changes

- Chapter 2 Definitions Grease Interceptors
- 403 Name change from "Family and Assisted Use" to "Single User" facilities
 - When two or more toilet rooms are provided for each sex, single user facilities require their own lavatories
- Section 605 no longer approved brass pipe to be installed for water service and water distribution pipes because of lead content
- Section 703 more stringent inspection processes as it pertains to building sewers
- Chapter 13 to bring more specificity to Non Potable water systems as far as Sun/UV exposure
