**JOINT STIPULATION OF WITHDRAWAL OF APPEAL**

Pursuant to Article XI of the Rules and Regulations of the Allegheny County Health Department, Appellants Harsco Metals, a Division of Harsco Corporation (“Harsco”) and ATI Flat Rolled Products Holdings, LLC (“ATI”), and Appellee, Allegheny County Health Department (“ACHD”), hereby stipulate to the withdrawal of this Appeal of the ACHD’s Administrative Order for Compliance to ATI and Harsco dated May 29, 2018 (“AOC”).

The withdrawal of this appeal arises out of the Consent Order and Agreement entered on January 7, 2020 by and between the ACHD, ATI and Harsco (“Consent Order”). It was stipulated in the Consent Order that ATI’s and Harsco’s agreement to the Consent Order did not constitute an admission of fault or liability. This withdrawal of the appeal shall also not constitute an admission of fault or liability by ATI or Harsco.

The ACHD has determined that the Consent Order is deemed terminated as the required conditions of the Consent Order have been satisfied and that the satisfaction of these

requirements satisfies the requirements of ACHD regulations at Article XXI, Section 2102.04.k.3.D. The ACHD hereby releases and discharges ATI and Harsco from the AOC.
