Re: Settlement of Administrative Appeal of November 21, 2017 Civil Penalty Assessment for violations at Icy Roll 2.0 (ACHD Client No.: 201710200002).

Dear Mr. Biumy:

On June 26, 2018, I spoke with you, on behalf of Biumy Enterprises, Inc. ("Biumy"), regarding \$864.00 in civil penalties assessed by the Allegheny County Health Department ("ACHD") on November 21, 2017 for alleged violations of the ACHD's Rules and Regulations Article III, Food Safety, ("Article III") at Icy Roll 2.0, 200 Monroeville Mall #A6, Monroeville, PA 15146 ("November 21st Penalty Letter"). At that time, we discussed the merits of the parties' respective cases and the various food safety compliance measures undertaken by you in response to the ACHD's allegations and civil penalty assessment. As a result of those discussions, the parties agreed to settle the appeal for a civil penalty payment of SIX HUNDRED AND ELEVEN dollars and TWENTY cents (\$611.20) in exchange for a release of liability for all food safety violations alleged in the ACHD's November 21st Penalty Letter. The payment is to be submitted in three (3) bi-weekly installments. The first payment of \$203.74, is due with this signed and returned agreement by July 6, 2018; the second payment of \$203.73 is due by July 20, 2018; and the third and final payment of \$203.73 is due by August 3, 2018.

This letter acts to memorialize the aforementioned terms between Biumy and the ACHD. If you agree to the above terms, please sign this letter in the space provided below and return it, along with your payment of TWO HUNDRED AND THREE dollars and SEVENTY-FOUR cents (\$203.74) by corporate check, cashier's check, or the like, made payable to the "Food Safety Fund", and send to: Donna Scharding, Food Safety Program Manager, Allegheny Co.
