Pursuant to Article XI, "Hearings and Appeals", T&R Properties, Inc., and The Flats at Summit Station hereby appeal the above notice dated 12/17/2021.

An inspection letter attached to this report indicates that there is an accumulation of dog waste at 3020 Perimeter Blvd, South Park Township. This area is contained in our apartment community known at The Flats at Summit Station.

The Flats at Summit Station is a 180-unit apartment community with two full-time on-site maintenance staff Monday - Friday. Our company policy requires our maintenance staff to perform "grounds" at the beginning of each day. This means they inspect the entire property and pick up trash every morning. This includes picking up dog waste when necessary.

We also have on-site property management at this property daily. The property manager frequently walks and inspects the entire property. This includes inspection of the area mentioned in the attached inspection report. We are confident that that our on-site personnel are following company policy and that the health and safety of our residents and staff due to dog waste is not being negatively affected.

At no time has our on-site staff noticed excess odor of dog waste or viewed a hazardous amount of dog waste in this area.

As an added measure, on 12/27/2021, as the Regional Manager and corporate representative from Columbus, Ohio, who oversees this property, I made a surprise visit to Summit Station to inspect the area myself.

I found no odor of dog waste nor a significant amount of dog waste.

Our staff will continue to monitor this area, and all areas of The Flats at Summit Station. We are committed to maintaining the highest possible standards of health and safety for all our residents.
