Comment/Response Document For Proposed Regulation Article XXII ("Use of Electronic Cigarette Devices in Public Places") and Proposed Amendments to Articles III ("Food Safety") and XVI ("Environmental Health Civil Penalties")

November 2, 2016

Introduction

On July 22, 2016, the Allegheny County Board of Health published notice for public review and comment in the Pittsburgh Post-Gazette and Pittsburgh Tribune Review the following proposed regulation and amended regulations:

Article XXII ("Use of Electronic Cigarette Devices in Public Places"): The proposed regulation would prohibit the use of e-cigarettes in indoor public places and work places. The proposed regulation would not apply to any public place or work place that qualifies for an exception under Section 3 of the Clean Indoor Air Act and for specialty e-cigarette establishments that satisfy certain requirements. A specialty e-cigarette establishment is defined as a business establishment whose sales of e-cigarettes and e-cigarette related products comprise at least 50% of the gross annual sales.

Amendment to Article III ("Food Safety"), § 307: The proposed amendment would require that food service workers thoroughly wash their hands after using e-cigarettes and prohibits workers from using e-cigarettes while engaged in food preparation or service or while in certain areas used for food preparation and washing. Article III, § 338, would also be amended to include a definition of "e-cigarette."

Amendment to Article XVI ("Environmental Health Civil Penalties"), § 1604: The proposed amendment would update the titles of the ACHD articles in which the civil penalty provisions in Article XVI are applicable and adds Article XXII ("Use of Electronic Cigarette Devices in Public Places") as an article under Section 1604.

The Board of Health conducted a public hearing on the proposed regulation and amended regulations on August 15, 2016. A total of fifteen individuals offered testimony at the hearing. Several of the commentators at the hearing also submitted written comments.

The public comment period closed on August 22, 2016. The Allegheny County Health Department received a total of 842 comments during the public comment period. The comments were submitted in writing, by email, and include the testimony and written comments offered at the August 15, 2016, public hearing. A total of 30 commentators¹ supported the proposed Article XXII regulation. A total of 812 commentators² opposed the proposed Article XXII regulation. There were no comments that opposed the amendments to Article III and Article XVI. There were nineteen commentators³ who supported the proposed amendments to Article III and Article XVI, but opposed the proposed Article XXII regulation.

This Comment and Response Document summarizes the comments submitted during the public comment period and at the August 15, 2016, public hearing and provides the ACHD's responses to those comments. The comments and responses in this document are organized based on the general topic areas discussed in the comments. Each public comment and response is listed with

the identifying commentator number for each commentator that made the comment to the ACHD. A list of the commentators, including names, affiliations (if any), and whether they are Allegheny County residents are included at the end of the comments.

A copy of the Comment and Response Document will be available on the Allegheny County Health Department website. All of the commentators who submitted comments by email will be forwarded by email a copy of the Comment and Response Document. The commentators who submitted their comments by mail will be mailed a letter informing them on how to obtain a copy of the Comment and Response Document.

Comments and Responses

1. **COMMENT:** The criminal penalties for a violation of the proposed Article XXII regulation are too severe and should be reduced. (ID Nos. 25, 26, 40, 50, 58, 60)

RESPONSE: Based on these comments, the ACHD recommends to the Board of Health that the proposed regulation be changed so that the criminal penalties are the same as the criminal penalty provision under the Pennsylvania Clean Indoor Air Act. The criminal penalty for a first violation would by a fine of not more than \$250, the criminal penalty for a second violation would be a fine of not more than \$500, and the criminal penalty for a third violation would be a fine of not more than \$1,000.

2. **COMMENT:** The requirements for an exception for specialty e-cigarette establishments should be changed to permit minor's accompanied by a parent or guardian to enter a specialty e-cigarette establishment. (ID Nos. 25, 26)

RESPONSE: The ACHD believes that minors should not be permitted to enter a specialty e-cigarette establishment that allows e-cigarette use. As discussed in Comment Response No. 18, there is scientific evidence that exposure to chemicals found in vapors from e-cigarettes may be harmful to bystanders. Additionally, scientific studies indicate that nicotine, which is contained in e-cigarette vapors, is harmful to minors because it impacts normal brain development.⁴

3. **COMMENT:** The proposed Article XXII regulation should be changed to allow customers to purchase beverages for consumption in a specialty e-cigarette establishment. (ID Nos. 25, 26, 58, 60)

RESPONSE: The proposed Article XXII provides an exception for specialty e-cigarette establishments that meet certain requirements. One of the requirements to qualify for the exception is that the specialty e-cigarette establishment does not sell or serve food or beverages for consumption on the premises by customers. The ACHD received comments from specialty e-cigarette establishment owners who requested that customers be permitted to purchase beverages for consumption on the premises. The concern voiced by these owners is that some customers may develop throat and respiratory discomfort as a result of using e-cigarettes and drinking water assists in relieving this discomfort.

Based on these comments, the ACHD recommends to the Board of Health that the language in proposed Article XXII be changed to only prohibit specialty e-cigarette establishments from selling or serving food, and not beverages, for consumption on the premises by customers.

4. **COMMENT:** The commentators support the proposed regulations on the basis that ecigarettes are harmful to users and bystanders. (ID Nos. 1, 11, 22, 28, 32, 39, 41, 43, 45, 48, 55, 56, 57, 59, 63)

RESPONSE: The ACHD appreciates the comments and the support for the proposed regulations.

5. **COMMENT:** The commentators believe that because there is a lack of scientific certainty regarding whether e-cigarettes may be harmful to users and bystanders, the ACHD should take a precautionary approach and prohibit e-cigarettes in public places. (ID Nos. 8, 24, 29, 30, 33, 34, 42, 44, 46, 53)

RESPONSE: The ACHD appreciates the comments and the support for the proposed regulations.

6. **COMMENT:** The commentators support the proposed Article XXII regulation on the basis that the use of e-cigarettes in public places may be perceived by minors as acceptable and normal behavior and may cause some minors to start using e-cigarettes. The commentators also noted that research has indicated that minors who experiment with e-cigarettes are at an increased risk of smoking cigarettes. (ID Nos. 1, 8, 22, 28, 29, 31, 34, 42, 53, 54, 59)

RESPONSE: The ACHD appreciates the comments and the support for the proposed regulations.

7. **COMMENT:** The commentator supports the proposed regulations on the basis that the exposure to e-cigarette vapor causes her to suffer health issues. (ID No. 44)

RESPONSE: The ACHD appreciates the comments and the support for the proposed regulations.

8. **COMMENT:** The commentator believes that there is no evidence that e-cigarettes are significantly better than using FDA approved tobacco use cessation products, such as the nicotine patch, to help stop smoking cigarettes. (ID No. 42)

RESPONSE: The ACHD appreciates the comments and the support for the proposed regulations.

9. **COMMENT:** The commentators believe that e-cigarettes should be banned in the same public indoor places that cigarettes are banned. (ID No. 13, 27, 31, 35, 39, 42, 43)

RESPONSE: The ACHD appreciates the comments and the support for the proposed regulations.

10. **COMMENT:** The commentator supports the proposed Article XXII regulation due to the potential risk of harm of e-cigarettes to pregnant women and their babies. (ID No. 29)

RESPONSE: The ACHD appreciates the comments and the support for the proposed regulations.

11. **COMMENT:** The commentators' request that the definition of e-cigarettes in proposed Article XXII be broadened to include a larger number of products or to define ecigarettes as a tobacco product. (ID Nos. 1, 46)

RESPONSE: The definition of e-cigarettes in proposed Article XXII is consistent with the definition of e-cigarettes contained in several proposed bills in the Pennsylvania General Assembly and the recently passed HB 1198. The ACHD believes that it is important to keep the definition in the proposed Article XXII consistent with these proposed bills and HB 1198.

12. **COMMENT:** The commentators request that Article XXII be changed to strike the following language from the definition of an e-cigarette:

"An e-cigarette does not include any product approved or certified for sale by the United States Food and Drug Administration as a tobacco use cessation product, or for other medical purposes."

The commentators believe that striking this language would make enforcement easier and ensure protection to bystanders from unknown chemicals used in the products. (ID Nos. 1, 41)

RESPONSE: The ACHD agrees with these comments and recommends to the Board of Health that the proposed Article XXII regulation be changed to remove the above language.

13. **COMMENT:** The revenue requirement in proposed Article XXII for a business to qualify as a specialty e-cigarette establishment should be increased from 50% of gross annual sales of e-cigarettes and related products to 80% or higher. (ID Nos. 1, 46)

RESPONSE: The proposed revenue requirements for a business to qualify as a specialty e-cigarette establishment was set at 50% so that it is consistent with the revenue requirements for a "Tobacco Shop" under the Pennsylvania Clean Indoor Air Act. The ACHD believes that a "Tobacco Shop" and a specialty e-cigarette establishment are analogous businesses and believes that the revenue requirements should be the same.

14. **COMMENT:** The commentators request that the affirmative defenses available for violators of proposed Article XXII should be changed because the language is vague and may make enforcement difficult. (ID No. 1, 46)

RESPONSE: The proposed Article XXII regulation allows for an exception for any public indoor place that qualifies for an exception under the Pennsylvania Clean Indoor Air Act and includes the same language regarding violations and affirmative defenses as in the Act. The ACHD believes that in order to avoid confusion by businesses that qualify for an exception under the Pennsylvania Clean Indoor Air Act, it is important keep the language regarding violations and affirmative defenses consistent with the language in the Clean Indoor Air Act.

The ACHD notes that the proposed Article XXII regulation also includes an exception for a specialty e-cigarette establishment that meets certain requirements. One of the requirements to qualify for the exception is that the specialty e-cigarette establishment does not allow individuals under 18 years of age to enter the premises. In order to help ensure that specialty e-cigarette establishments do not permit individuals under 18 years of age to enter, the ACHD recommends that the Board of Health include the following additional language pertaining to violations and affirmative defenses in the proposed Article XXII:

• Under subsection 2203.2 ("Violations"), the following language should be included:

It is a violation of this Article to do any of the following:

(3) Permit individuals under 18 years of age to enter a specialty e-cigarette establishment that allows e-cigarette use under subsection 2202.2(2).

• Under subsection 2203.3 ("Affirmative Defenses"), the following language should be included:

The owner, operator, or manager of a specialty e-cigarette establishment shall not be cited for a violation of subsection 2203.2(3) if the following actions are taken:

(1) The specialty e-cigarette establishment prominently posts signs prohibiting individuals under 18 years of age from entering; and

(2) Upon learning that an individual under 18 years of age has entered the premises, the specialty e-cigarette establishment requests that the individual(s) immediately leave the premises.

• Under subsection 2203.4 ("Penalties"), the following language should be included:

A specialty e-cigarette establishment that violates any provision of this Article shall produce, at the request of the Department, verifiable documentation to support its qualification as a specialty e-cigarette establishment. The supporting documentation may include the establishment's books, accounts, revenues or receipts, including those reported to the Department of Revenue for sales tax purposes.

15. **COMMENT:** The commentator requests that the penalties for violation of proposed Article XXII should be changed to provide a graduated fines structure and a suspension or revocation of an ACHD license for multiple violations. (ID No. 1)

RESPONSE: As noted in Response No. 1, the ACHD recommends to the Board of Health that the criminal penalty provisions in proposed Article XXII be changed so that they are consistent with the penalties in the Pennsylvania Clean Indoor Air Act which provides for graduated fines for criminal violations.

16. **COMMENT:** The commentator requests that restrictions on the use of e-cigarettes in indoor public places be expanded to include private clubs. (ID No. 24)

RESPONSE: The proposed Article XXII regulation provides an exception for public indoor places that qualify for an exception under the Pennsylvania Clean Indoor Air Act. Under the Pennsylvania Clean Indoor Air Act, a "Private Club" qualifies for an exception. In order to keep the proposed Article XXII regulation consistent with the Pennsylvania Clean Indoor Air Act, the ACHD believes it is important to also provide an exception for a "Private Club."

17. **COMMENT:** The commentator requests that Article III § 307 ("Food Safety") be amended to requires that food service employees only use tobacco or e-cigarettes in "outside" designated areas. (ID No. 46)

RESPONSE: The ACHD appreciates the comments. However, the ACHD believes that the proposed amendments to Article III, § 307, will be sufficient to preclude food service workers from using e-cigarettes in indoor public places.

18. **COMMENT:** The commentators believe that there is no scientific evidence that ecigarettes are harmful to users or to bystanders. (ID Nos. 2, 14, 16, 17, 18, 19, 21, 23, 25, 26, 38, 40, 47, 50, 52, 58, 60, 61, 62, 64-842)

RESPONSE: The ACHD disagrees that there is a lack of scientific evidence that ecigarettes are harmful to users and bystanders. The ACHD recognizes that because ecigarettes are a relatively new product, data on the short-term health effects of ecigarettes are limited and there is no adequate data on the long-term health effects. However, while most researchers agree that e-cigarettes are less harmful than cigarettes, multiple studies indicate that e-cigarette ingredients are not harmless.⁵ Chemical analyses of e-liquids, aerosols, and emissions have identified many substances classified as carcinogens and respiratory, cardiovascular, reproductive, or developmental toxicants, including heavy metals (cadmium, nickel, lead, and chromium) and carbonyl compounds such as formaldehyde. The most common base e-liquid, propylene glycol, has been associated with respiratory irritation. Additionally, the FDA recently determined that since studies have indicated that both nicotine and other toxicants are found in the exhaled aerosol from e-cigarettes, as well as in the aerosol inhaled by the user, it cannot conclude that secondhand vapor is harmless. Therefore, based on this scientific research, the ACHD finds that there is sufficient evidence to find that e-cigarettes may be harmful to users and bystanders.

19. **COMMENT:** The commentators believe that there is no scientific evidence that ecigarettes are a "gateway" to cigarette use by minors or will re-normalize smoking for minors. (ID Nos. 23, 49, 58, 62, 65-842)

RESPONSE: The ACHD disagrees with these comments. Recent research has indicated that e-cigarette use by minors may lead to smoking cigarettes. One study found that teens who had never smoked, but used e-cigarettes, were six times more likely to begin using traditional cigarettes within 1 year.⁶ Other studies found that e-cigarette use is associated with an increased intention to smoke traditional cigarettes, especially among younger adolescents, and progression to smoking traditional cigarettes.^{7 8 9 10 11} These findings are very alarming considering that 19.9% of Allegheny County youth aged 14 to 19 have tried e-cigarettes.¹²

20. **COMMENT:** The commentators believe that the restrictions on the use of e-cigarettes will be detrimental to public health because e-cigarettes are less toxic than cigarettes and maybe helpful as a tobacco use cessation product. (ID Nos. 2, 4, 5, 6, 7, 9, 14, 15, 17, 20, 21, 23, 25, 26, 36, 37, 40, 49, 58, 60, 62, 65-842)

RESPONSE: A large number of commentators recounted personal stories of using ecigarettes to quit smoking. However, scientific evidence of e-cigarettes' effectiveness as a smoking cessation tool is limited at this time and the FDA has not approved e-cigarettes as a tobacco use cessation product. Additionally, there is scientific evidence which indicates that e-cigarettes may be harmful to users and bystanders. The ACHD would like to note that if in the future the FDA approves e-cigarettes as a tobacco use cessation product, the ACHD would support the use of e-cigarettes as a smoking cessation product. However, e-cigarettes would still be subject to the use restrictions under Article XXII due to the potentially harmful effects of e-cigarette vapors on bystanders.

21. **COMMENT:** The commentators oppose requiring business owners to ban the use of ecigarettes in their businesses. The commentators believe that it should be the decision of each business owner whether to allow employees and/or customers to use e-cigarettes in their businesses. (ID Nos. 15, 16, 23, 25, 26, 61, 62, 65-842)

RESPONSE: The ACHD disagrees with this comment. As discussed in Response No. 18, scientific studies have indicated that e-cigarettes may be harmful to bystanders. The ACHD believes that prohibiting the use of e-cigarettes in workplaces and indoor public places will help protect employees and customers from the potentially harmful effects of e-cigarettes.

22. **COMMENT:** The commentators believe that requiring e-cigarette users to go outside and use e-cigarettes in the same areas as smokers will cause e-cigarette users to be exposed to second-hand cigarette smoke. (ID Nos. 36, 65-81)

RESPONSE: The proposed regulations do not place any restrictions on where e-cigarette users may use e-cigarettes in outdoor places. Therefore, e-cigarette users would not be required to use e-cigarettes in the same designated smoking areas that traditional tobacco users are required to use.

23. **COMMENT:** The commentators indicated that they were able to quit smoking cigarettes after starting to use e-cigarettes. (ID Nos. 2, 4, 5, 6, 7, 15, 17, 18, 19, 23, 36, 49, 50, 52, 62, 60)

RESPONSE: The ACHD commends the commentators for quitting cigarette use. However, e-cigarettes have not been approved by the FDA as a tobacco use cessation product, or for other medical purposes. The ACHD would like to note that if in the future the FDA approves e-cigarettes as a tobacco use cessation product, the ACHD would support the use of e-cigarettes as a smoking cessation product. However, e-cigarettes would still be subject to the use restrictions under Article XXII due to the potentially harmful effects of e-cigarette vapors on bystanders.

24. **COMMENT:** The commentators believe that the proposed regulations will result in an "overall public use ban." (ID Nos. 65-81)

RESPONSE: The ACHD is not proposing an "overall public use ban" on e-cigarettes. The proposed regulations only prohibit the use of e-cigarettes in indoor public places and workplaces. Further, the proposed Article XXII regulation allows for an exception for any public indoor place that qualifies for an exception under the Pennsylvania Clean Indoor Air Act and for specialty e-cigarette establishments.

25. **COMMENT:** The recently enacted Food and Drug Administration regulations pertaining to e-cigarettes and the Pennsylvania tax on e-cigarettes will have a negative impact on specialty e-cigarette establishments. (ID Nos. 15, 20, 50, 64)

RESPONSE: These comments are not within the scope of the Allegheny County Health Department's proposed regulations pertaining to e-cigarettes.

26. **COMMENT:** The ACHD should not prohibit specialty e-cigarette establishments from allowing customers to sample products. (ID No. 16)

RESPONSE: The proposed Article XXII regulation does not prohibit a specialty ecigarette establishment that qualifies for an exception under the regulation from allowing customers to sample products.

27. **COMMENT:** The Allegheny County Health Department takes too long to respond or recognize a complaint from a citizen. (ID No. 63)

RESPONSE: This comment is not within the scope of the proposed regulations pertaining to e-cigarettes. However, the ACHD would be willing to address the commentators concerns independent of the proposed regulations on e-cigarettes.

28. **COMMENT:** The proposed regulations may be preempted by Pennsylvania law. (ID No. 40)

RESPONSE: The ACHD disagrees with the commentator's opinion that the proposed regulations are preempted by Pennsylvania law. There is currently no Pennsylvania law which preempts the ACHD from formulating regulations on the use of e-cigarettes in public indoor places.

29. **COMMENT:** The proposed regulations would violate an e-cigarette user's "freedom of speech" under the First Amendment to the U.S. Constitution. (ID No. 64)

RESPONSE: The commentator did not provide an explanation on how the proposed regulations would violate an e-cigarette user's freedom of speech. Therefore, the ACHD is unable to provide a response to this comment. It should be noted that the First Amendment does apply to certain commercial speech such as advertising. However, the proposed ACHD regulations do not prohibit or place any restrictions on advertising or other commercial communications pertaining to the sale or marketing of e-cigarettes.

30. **COMMENT:** The ACHD should regulate alcohol, and not "cigarettes," because more people are killed from drinking and driving. (ID No. 10)

RESPONSE: This comment is not within the scope of the proposed regulations pertaining to e-cigarettes.

31. **COMMENT:** The ACHD should ban wood burning fire pits because they are more harmful than e-cigarettes. (ID No. 12)

RESPONSE: This comment is not within the scope of the proposed regulations pertaining to e-cigarettes.
