What is Recertification?

Recertification is the process of verifying that you and/or your child meet the requirements to receive WIC benefits.

Requirements for WIC Benefits

- You and/or your child need to:
- Meet medical or nutritional risk criteria
- Meet income guidelines
- Be a Pennsylvania resident

How to Recertify

The WIC staff will give you a medical form to be completed by the WIC staff or your health care provider. You will be given a recertification appointment.

What to Bring to Your Recertification Appointment

- Identification (driver's license, photo ID, school ID, etc.)
- A completed medical form (if completed by your health care provider)
- Proof of household income (for the past 30 days)
- Proof of your current address
- Yourself and/or your child (whoever will be recertified)

The Recertification Appointment

Your WIC nutritionist will meet with you at the recertification appointment. The WIC nutritionist will verify that you meet the WIC Program requirements. He/She will also provide nutrition education. If you have any questions, please talk with your nutritionist.

NOTE: It is important to bring all of the required information to your Recertification Appointment. You could be asked to reschedule your appointment if any information is missing.
