RFP for Opioid and other Substance Use Disorder Interventions that are Led, Designed and Operated within and by Highly Impacted Communities

Office Hours, June 21, 2023

1. Could you talk about what community involvements looks like, concretely? What kinds of involvement from program participants are you expecting in terms of the design of the program?

We're hoping to enlist resources from organizations within the community that stand outside of the formal behavioral health treatment system. Specifically, we're seeking organizations who have a strong connection to their community, in especially highly affected communities, in terms incidents of overdose deaths and substance use disorder rates. Ideally, these community-based organizations will have a track record of working closely with individuals in the community and have individuals in leadership positions who are representative of the people they serve. This may include people who are in recovery themselves, or people who can connect closely to people who are at risk. We think it important to gather community input regarding what resources and interventions would be most valuable to the community, as well as where the resources should be located and how they should be offered.

Please also refer to page 7 of the RFP under section 2.1 "Approach." An example of community led, designed, and operated that we offer is that community representation is a vital element of planning and decision-making. We request that you document how community feedback was gathered whether it be from surveys, focus groups, or a community advisory board and how community feedback could be a part of planning and decision-making.

2. Do you have an anticipated number of successful Applicants that you intend to award funds to? If so, do you have an anticipated dollar amount that you intend to award each successful Applicant?

We anticipate selecting at least 10 Successful Proposers, and potentially more. We do not have an anticipated dollar amount each Successful Proposer will receive. Funding per project will depend on the Proposals received and selected. We will consider all proposed costs for reasonableness and negotiate the final budget and contract terms with the Successful Proposers.

3. Can funds be used to purchase a mobile unit?

Yes, as long as there is justification for how the mobile unit will serve as an intervention for opioid use and/or substance use disorder and support disproportionately impacted communities.

4. Is the letter of support from the community organization included in the 5-page limit? Als, the budget is not included in the 5-page limit, but what about the Budget Narrative? Is that included?

No, the letter of support from a community organization, the budget, and the budget narrative will not count towards the 5-page limit for the Proposal.
