Mission

Protect children from abuse and neglect; to preserve families, whenever possible; and to assure permanency, that is, to provide permanent, safe homes for children either by assuring safety within the child's own family, or by finding an adoptive home or another permanent setting for those children who cannot be reunified with their family.

Calls logged – CY 2020	<p>14,234 calls of suspected child abuse/neglect were received by CYF.</p> <p>42% (6,007) were screened out at intake. 58% (8,213) were assigned to a caseworker for a full investigation.</p> <p>13% of these (1,104) were accepted for child welfare services 16% of these (1,299) were connected to active cases</p>
People served* – CY 2020	<p>7,722 children; 10,045 adults</p> <p>On March 1, 2022, 3,750 children in 1,673 families were receiving services. 1,546 of these children were in out-of-home placement, with 60% (922) placed with kin, 32% (488) in a foster home, and 4% (67) in congregate care.</p>
