



Senior Farmers Market Nutrition Program (SFMNP)

Allegheny County Senior Community Centers will conduct in-person distribution of the Farmers Market vouchers on Tuesday, June 25, 2024. Applications WILL NOT be accepted by mail. There will be in-person distribution only on a first-come, first served basis. Additional voucher distribution dates will be scheduled throughout the summer based on voucher supply and demand.

What is the SFMNP?

The Senior Farmers Market Nutrition Program (SFMNP) will provide \$50 in vouchers⁺ to eligible Allegheny County residents aged 60 years.

The vouchers are redeemable through November 30th at participating farmers markets and farm stands and can be used to purchase produce that is grown in Pennsylvania or purchased directly from a Pennsylvania farmer.

- People must spend the entire \$10.00 check; change will not be given.
- Lost or stolen checks will not be replaced.

Please review the SFMNP Rules (below) for more details about using the vouchers and allowable produce.

Eligibility⁺

- Allegheny County resident
- 60 years of age or older (by December 31, 2024)
- Meet the income guidelines (self-reported):
 - One-person household: At or below \$27,861
 - Two-person household: At or below \$37,814*
- *Married couples may receive one set of checks for each individual
- Older adults living in a residential facility that provides meals are not eligible to receive vouchers

Proxies

Proxy Forms will be available to eligible seniors who are unable to go to community distribution sites. The Proxy Forms must be completed in full, signed by both the eligible senior and the Proxy (the person designated to pick up the vouchers) and presented at time of initial voucher distribution on June 25. Incomplete or unsigned forms cannot be accepted. Proxy Forms are available at the below links.

Distribution Sites

A full list of distribution sites and times will be made available for the initial distribution date on June 25. Additional voucher distribution dates will be scheduled throughout the summer based on voucher supply and demand and on a first come, first served basis.
