Introductions

- Notice of Meeting posted on group Facebook page
- Discussed mission and ordinance defining advisory role of the Council. - Since the Ordinance establishes our purpose, decided to forgo additional statement. The ordinance to be sent to the FNPC
- Goal of the group is to preserve our park to live on forever - canoeing, kayaking, hiking, horse trails, picnics, tennis, pickleball, wildlife, etc. Some members were interested in reforesting trees, maintaining wildlife, birds, fish, etc.

Reports and discussion Andy Baechle (Allegheny County Parks Director) Requests to County from NPFC:

- Discussion of Accessibility of restrooms, shelters and trails. All accessible areas are noted on the North Park Map
- Asked to have more lights along the tennis court road and making a walking path
- Discussed better monitoring of speeders - esp. speeding on Babcock up to the pool and then down to Lake Marshall - Andy said he'd pass that on to county
- Discussed need for better signs
- Noted a plan developed approximately 7 years ago - a civil & environmental study to get the maximum use of the boat house and other Park assets
- A suggestion to add a shelter and a bench in the small dog park - Andy will ask about getting these in both parks

Reported by Andy:

- North Park Pool improvements including improved bleachers, added more handicapped access areas, plan for a new baby pool and roof
- Finished Pierce Mill Road to give more room for bikers & walkers, plan to extend to 910 County has budget for the Park. It's not a line-item budget but generally provides substantial funding for repairs/improvements.
- Grant received for the north branch of Pine Creek
- Going to be planting more meadows better for nature and better for utility companies Platform tennis is now a three season - push button for lights to go on for one hour at a time to save energy
- NEED LIFEGUARDS - \$16/hour will train & certify for free candidates - have flexible hours & work multiple pools
- Covid brought more awareness to our parks & county had to hire more people
- New signage being made in parks to make them all uniform – NP will be last because of the size

- Marshall Island
 - Being maintained by a park specialist and three landscape architects
 - Storm drainage covered in leaves and sticks - by the state that they address this & that this is being looked at by the McCandless commissioners
- Scouting and other projects need to coordinate with the County to comply with union agreements

Report by Sam Shepard

- 200 miles of trails in all county parks - there is a trail app it is Allegheny City Parks Trails - can find it on Google
- Rangers train on invasive species management specifically Japanese barberry & bittersweet - he also can provide toolboxes with everything needed to do your own volunteering if you can't attend a scheduled volunteer day -- this trail group is shifting to maintain these invasive species and will start in a certain area of the park

-Minutes of the September 17, 2024 meeting were approved as submitted

-Election of officers. Nominated and approved were Colleen O'Toole Lizzi as chair, Ken Allshouse as vice chair, Liz Spence as secretary

-Mike Grable, Interim Director of Parks, introduced himself and gave an update on recent activity

-Melissa Swedish provided details on work in the park including that recent storm had hit park hard, Old Ingomar and other roads were paved inhouse, Pearce Mill Rd work will be closer to end of summer, 400 trees planted near horse rink, pool and spray park being prepared for summer, dog parks will be rotated. There will be many programs including pickle ball lessons, free swim lessons, yoga, fitness and underwater hockey.

North Park Clubhouse has been listed as historical landmark

Question was raised on adding accessible access to the new wetland trail

-Liz Spence gave update on NAEC's ending going over how the organization was an environmental leader in its 56-year history. The most recent contribution to the park was \$12,500 for the Latodami feasibility study. She then added information on the continued work to restore the Arboretum including major planting of native shrubs and trees this spring

-Caitlin Harpster, Allegheny County Parks Foundation, reported 2 recent tree plantings at the Horse Arena and Ledgewood. Latodami study is beginning. North Park study is still being funded.

Improvements will be made to Marshall Island. An economic impact study showed that the parks bring visitors from inside and outside Allegheny County. Additionally environmental benefits of over \$5.8 million come from the parks including carbon sequestration, stormwater management and air quality improvement. -Katie Stanley gave update on Latodami. There are 4 year-round naturalists and 4 more will join for the summer. Over 50 summer programs are scheduled including summer day camps

-Deaglan McManus gave an update on Park Ranger activities. Currently working on storm damage, 3 rangers are assigned to North Park, Harrison Hills, Hartwood and Deer Lakes. 6 summer staff will be added this month. Activities are published on the website and on posters at park facilities.

Other issues discussed included problem of speeding with both cars and bikes. Suggestions were made to have more electronic speed signs as well as to invite the police to the next meeting to discuss what improvements could be made.

Brief discussions on how we could raise money like what other Friends groups do. One suggestion was a plant sale. Also, brief discussion on how many meetings and whether to keep same days and times as in past. Some members are interested in participating in the Garden in the Park Day. Colleen will look into that.
