## INSTRUCTIONS FOR PROBATE APPLICATIONS

These instructions are for the filing procedures in the Department of Court Records. They are not legal advice. **LEGAL QUESTIONS SHOULD BE DIRECTED TO AN ATTORNEY OF YOUR CHOICE.** 

The Department of Court Records does not recommend attorneys.

- 1) One (1) typed application is required.
- 2) The original will and one (1) copy must be presented.
- 3) If the will is not self-proving, the subscribing witnesses must appear in person or notarized affidavits must be provided from the subscribing witnesses attached to a copy of the will. If the subscribing witnesses are deceased or their residence is outside the Commonwealth of Pennsylvania, a notarized affidavit of non-availability must be presented.
- 4) Non-subscribing witnesses must appear in person.
- 5) An original death certificate must be presented.
- 6) A filing fee of \$180.25 must be paid by cash, business/estate check or credit card.

  This fee will include the 10.5 Certification of Notice to Beneficiaries and the 10.6 Status Report complete fee at the time of the Grant of Letters. - 7) There is a fee of \$10.00 per Short Certificate.
- 8) All probates with Grant of Letters must be advertised. (P.E.F., CODE, TITLE 20, § 3162)
- 9) PA Inheritance Tax forms are available in Room 216, City-County Building.
- 10) After probate is complete (the will is filed in the DCR) the following items must be filed:
  - a. Certificate of Notice Must be filed within three (3) months after probate
  - b. Inventory Must be filed nine within (9) months of the date of death
  - c. PA Inheritance Tax return must be filed within nine (9) months of the date of death (a discounted rate applies if filed within three (3) months from the date of death).
  - d. Status Reports must be filed within two (2) years of the probate.
