Re: City of Pittsburgh Campaign Finance Filings for 2025 Primary Election

Dear Candidate and Candidate Committee Staff:

Help is available with campaign finance reports, rules, and contribution limits required for City of Pittsburgh elective office. Please <u>request advice</u> for help with Ethics Board requirements. Forms, instructions, and laws are on our website, and available in hard copy upon request.

When to file with the Ethics Board - Filing due even if no activity:

- 1. Monday, February 3, 2025 (reporting period to include the month of January)
- 2. Monday, March 3, 2025 (reporting period to include at least the month of February)
- 3. Monday, April 7, 2025 (reporting period to include at least the month of March)

Note, you can request an extension to file by the 7th in February and March, to allow at least one week of administrative time to complete the paperwork.

What to file with the Ethics Board:

- Up to four forms are required for each deadline, depending on if you have a committee and if you decide to use a notary. Find the forms and instructions at pittsburghpa.gov/ehb.
- Easy Option: Submit tables in spreadsheet or.csv format, and then simply attach the completed and signed coversheets. Contact me for help!

How to file:

- Email your Ethics Board filing to <u>leanne.davis@pittsburghpa.gov</u>. No paper copies will be accepted.

Questions on content. The PA Dept. of State Division of Campaign Finance (717-787-5280, option 4 <u>ra-stcampaignfinance@pa.gov</u>) and the Allegheny County Bureau of Elections (412-350-4500) can help you with substantive questions since we use the same pre-primary reporting forms.

Statement of Financial Interests ("SOFI"):

- State Ethics Commission at 717-783-1610.
- While I can assist you with SOFI content questions, deadlines and procedures for filing the SOFI with the Office of the City Clerk are not administered by the Board.

Warning: There's a \$50 daily fine for failing to file correctly and on time. A failure to file list will be published at https://pittsburghpa.gov/ehb. Additional reports required with the County and Controller noted in the table below. Finally, remember to keep all required receipts for audits.

How to pay late filing fees:

Pay the \$50 per day late fee to the Dept. of Finance Cashier's Office (412-255-2525), online at https://magic.collectorsolutions.com/magic-ui/Login/pittsburgh.
