Notes:

- 1) A “Co-Located Major Source” is any source that meets the definition of “major source” under Article XXI, § 2101.20, based only on the source being located on a contiguous or adjacent property and under common control of another major source.
- 2) For purposes of this fee schedule, a “Small Minor Source” is a minor source that only operates source(s) that would meet the size and conditions of the following General Permits (GP) issued by the Pennsylvania Department of Environmental Protection: (1) “Small Gas & No. 2 Oil Fired Combustion Units” (GP-01); (2) “Diesel or No.2 fuel-fired Internal Combustion Engine(s)” (GP-09); or “Human or Animal Crematories” (GP-14).
- 3) The installation permit fees under Article XXI, § 2102.10.b, are cumulative.
