# Drug & Alcohol Planning Council Meeting Minutes Microsoft Teams Wednesday, October 9, 2024

- Agendas are required to include time for public comments
  - For example, if someone on the Council has something to announce that they didn't have time to include on the agenda

The bylaws were created and approved by the D&A Planning Council in 2008. Voting requires a quorum of members. There is typically not a lot of voting other than approving the minutes at each meeting and leadership elections. Changing the meeting frequency would require a change to the bylaws.

The Planning Council has not elected a Secretary in the last few terms. DHS has taken the minutes and is comfortable continuing to do that with the consent of the current Planning Council.

#### Questions:

- Gabby has not having a Member at Large slowed down any processes or votes in this group previously?
  - Not in Colleen's experience over the past 2 years. However, the council also has been operating in a response format rather than an active planning format. OBH is hoping for this newly elected council to be a much more interactive experience members create an agenda with the officers in the weeks leading up to the meeting
  - Maisha has also not seen that position filled in the 7+ years she's been here. More support may be better for those who decide to take these positions
- Charles so these positions only last for one year?
  - Yes, one year
- Josie would we need to vote on whether to keep the Member at Large position?
  - Not at this time. When we get to nominations next, you all can choose to nominate or not and then one of the first to-dos for the officers in 2025 will be updating the bylaws.
- Anne as things come up, will you be sending out links and such to catch up on the programming contracted by DHS?
  - In short, yes

- Maisha yes, when receiving an ask from Colleen about what to cover at the council, her team would put together information to share with the council and they'll be able to get to know the council membership and their skillsets and interests over time
- Email Colleen and she can filter them to Maisha as well as distribute answers to all council members to ensure everyone has access to the same information

Maisha – hope is that this is a working council, where members are willing to be vocal about current initiatives and service gaps as well as strategize about how to address these issues.

Are you comfortable continuing to have these meetings virtually only? Note that inperson would need to be at the DHS building and would need to be in-person only, not hybrid, because of how fickle technology can be. Not trying to sway one way or another, but it is an option

- Maisha at least one in-person a year would be a good idea
- Virtual meetings not recorded, but can be recorded if you would like
  - Recordings are required to be published
