November 29, 2022

Meetings are to take place every 2-3 months.

New Business

A discussion on fundraising projects that have occurred in other County parks including: acquisition of land; ponds in South Park needing rehabilitation; and installation of benches, trees, exercise course, solar power lights, and fountains. Two County parks are net zero (Deer Lakes and White Oak) and run on solar.

Members led a discussion on low cost and no cost park projects considering the following: invasive removals, park surveys, and tree plantings. Contractor, trail crew, and rangers help maintain trails. The Parks Department has a goal of 30-50 acres meadow a year and right-of-way (ROW) friendlier habitat.

An update on current Boyce Park projects was provided:

- Upgrade to four full size tennis courts and installation of 6-8 pickleball courts in 2023
- Addition of a new climbing wall
- Hillcrest fence replacement
- New roof on the main building and ski lodge
- New flooring in the ski lodge
- New groomer for slopes
- New belt on magic carpet that is used for tubing
- New rain gardens-signage
- Update to ranger headquarters (there are three naturalists)

The following items below are a list of new ideas, discussion, questions/concerns from all attendees in the meeting:

- Consideration to rent baseball fields for softball leagues. A deposit would be required to ensure cleanliness. Also, an option for a reduced rental rate for the baseball fields was discussed.
- To improve trail development:

- Create walking paths on the flat section of Pierson Run Road.
- Timers on the light poles need adjusted (maintenance).
- Opening the dog park when maintenance opens the park.
- Evaluation of location for dog waste stations.
- Volunteer project of blazing trails.
- Opportunity to rent equipment for cross country skiing (challenge is location for skiing).
- Naming rights (such as on shelters) could be considered to raise funds.
- Sled riding on Meadow Lane by Hillcrest.
- Ice rink – suggestion to enhance winter activities at the park.
- Open grass for recreation.
- Development of an events calendar on the Friends page would help park visitors and community members and bring more participation.
- LED signage for county park events is highly suggested.
- The availability of more food trucks throughout the seasons, especially in the summer.
- Speed humps highly suggested.
- Eagle Scout and Gold Star projects still occur and could be highlighted.

A description of the hunter program in the parks was shared. Each year 5-7,000 pounds of venison is donated to food banks.

A discussion on signage and maps of the park trails occurred. New kiosks allow for updated and consistent signage. Using the County's trail app is more accurate than the printed map. The app reflects the trail assessment work. The park trail is a looped system and questions were raised regarding revisiting the trail system to ensure it is user friendly. Refer to Trail PGH.

1. Call to Order - 6:02 pm
2. Allegheny County Parks Department Report - Andy Baechle
 - a. The wall behind Hillcrest Court is done.
 - b. Working on the top left of ski slopes where the creek is being turned into a wetland area through a Turnpike funded project to improve water quality.
 - c. Pickleball (6ish courts) and Tennis Courts are almost ready, waiting for a blue paint coat but weather prevents til Spring. Putting temporary lines on it now so that it can be used until then.
 - d. Ongoing work on the pump track and climbing walls. The pump track needs special asphalt that can only be done in warm temperatures, so on hold until spring. It will be all asphalt and have a play area with boulders and dirt as well. The climbing walls are still being fabricated in Bulgaria.
 - e. A radar-indicated speed sign has been put in.
 - f. A walking path for the main road is often brought up and wanted by all (the parks department, committee and visitors). However, the cost is exorbitant due to having to widen the road along the hills to make space. It is at the top of Andy's list, the department just needs to find somehow to pay for it.
3. Allegheny County Park Ranger Reports - Rick McIntyre, Braden Meiter
 - a. Rick McIntyre
 - i. Staff have been updating signs throughout the park.
 - ii. Ski season target opening will be around the weekend of December 16th. Most seasonal staffing is sufficient, recruiting at CCAC was useful.
 - iii. Still seeking ski instructors who are over the age of 18.

iv. Lifeguard certification classes are being held on December 29th and 30th at Wilmerding Community Center. Lifeguards hired by the department will have the cost of their class reimbursed.

v. Park Maintenance

- Lots of Silver Beaver trail work has been done.
- Vegetation around ski slopes was trimmed to prepare for the season.
- Lower dog park recently reseeded for the spring.
- Fall leaf cleanup is underway with buildings cleared etc.

b. Braden Meiter

- i. Owl Prowl with Rangers on November 19th has spots left.
- ii. There is a Winter Trees guided hike on December 10th.
- iii. Introduction to Snowshoeing classes offered on January 17/18 and February 14/15. Starts at 10am, costs \$10 and comes with equipment rental.
- iv. Guided hikes scheduled for January 27th and March 2nd at 1pm.

v. Resource Management Projects

- 400 trees were put in just before the meadow.
- Next week volunteers will put 200 more trees just below Cub Shelter.
- The trees are through the [Ten Million Trees](#) Grant funded by the Chesapeake Bay Foundation. We received 1200 trees, tree tubes and stakes and are looking to get another 1000 this spring

vi. Hiring in January for seasonal rangers and trail crew who will work from mid-May to mid-November.

4. Allegheny County Parks Foundation Report - Joey-Linn Ulrich

- a. The Foundation has been working on 6 stream assessments from 2023 and 2024 with the Penn State Master Watershed Stewards. North Park, South Park and Boyce Park will be completed in 2024.
- b. The Allegheny County Parks Foundation would be a great consideration for anyone looking to contribute on Giving Tuesday to help them continue their work to protect, conserve and promote our park.

5. Friends of Boyce Park Committee Affairs & Visitor Issues/Concerns

a. Issues & Concerns raised by members of the public

- i. There is a person repeatedly throwing corn from a car around 4pm in the lower lot of the wave pool.
- ii. Someone is dumping what appears to be construction trash or things from a

remodel (i.e., kitchen sink, tiles, etc.) off the ramp by the flag.

- iii. The gate by the tennis courts makes some visitors believe the maintenance road is prohibited from any use, while it is only closed to vehicular traffic.
- iv. The dog park sign at the main entrance is confusing because you can't actually drive to them from there due to the maintenance road only open to foot traffic and Parks Department vehicles.
- v. There are a few chronic muddy areas along the red dot trail. Rangers are aware of them, however this trail is along an old railbed so fixing it will not be fast nor cheap. They will try to move it up the list.
- vi. Benches for parents to sit on while watching their children play at Universal Playground would be nice. The only place to sit is at the picnic tables under the pavilion, but it is too far to supervise kids from there.
- vii. Consideration for a crossing sign and road markings where the trail from the archery range passes across the street to continue onto the soccer field trail.
- viii. Regarding the never ending pile of crap in the parking lot by the soccer fields and Universal playground: Allegheny County Public Works dumps it there. Officials are trying to get rid of it but have nowhere else to put it.

 - iii. Boyce Park is trying to get funding through the Redevelopment Assistance Capital Program (RACP) in Allegheny County to renovate the Wave Pool. The concrete and major mechanical components are aging, and nearby residents would benefit from upgrades.
 - iv. Trailhead parking was added behind Silver Beaver, a bulldozer will be coming through and finishing it this week.
 - v. A recycling bin has been added to the courts for pickleballs, which can't be recycled through regular collection.
 - vi. The switch to the upper dog park will be on October 26th.
 - vii. Ski Season – Seasonal employees are needed, applications are being taken for all positions including lift workers, instructors and others.
 - b. Braden Meiter
 - i. There are lots of volunteer opportunities and other programming scheduled this season. The Owl Prowl on November 9th is already full.

Boyce Park is hosting tree distribution again, and 12,000 are set to arrive on October 9th. 1,500 will be kept for the county parks, and the rest will be distributed to private land owners and organizations including Allegheny Land Trust, DCNR, and the Army Corps of Engineers. We were also given thousands of extra tree tubes and stakes.
