Dear Hearing Officer Slater:

On October 16, 2018, the Allegheny County Health Department (“ACHD”) issued notices of violation to Nicole Caparanis, Louis Klein, and Robert and Marie Gray. The notices ordered the recipients to enter into a mutual maintenance agreement for the maintenance of their common sewer lateral, or in the alternative, independently and separately connect their properties, located at 5819 and 5821 Holden Street, Pittsburgh, PA 15232, to the public main.

On November 9, 2018 and November 13, 2018, Ms. Caparanis, Mr. Klein, and Mrs. Gray filed notice of appeals in response to the October 16th order. On January 18, 2019, the ACHD withdrew the October 16th order. Pursuant to ACHD Rule and Regulation Article XI, “Hearings and Appeals”, § 1103, “Any person aggrieved by an action of the Department and who has a direct interest in such action may file a Notice of Appeal.” In this case, because the ACHD withdrew the order that gave rise to the appeals filed by Ms. Caparanis, Mr. Klein, and Mrs. Gray, the appeals are now moot and the ACHD requests that the appeals be dismissed.
