- F. The ACHD reserves the right to introduce into evidence any exhibit listed on any pre-hearing statement filed by Appellants and for this reason, only, incorporates the exhibit list on any pre-hearing statement filed by Appellants. In doing so, the ACHD specifically does not waive any objection to any exhibit listed.
