## Re: 685 Washington Road Appeal (Service Request \#: HCE-20190315-2300).

Dear Hearing Officer Slater:
On May 29, 2019, Alex Parrish filed an appeal on behalf of the Denis Theatre Foundation against a notice of violation issued by the Allegheny County Health Department ("ACHD") for a violation of ACHD Rules and Regulations Article VI, Housing and Community Environment, observed at 685 Washington Road, Mount Lebanon, PA 15228 ("Property"). The ACHD observed a vacant structure that was attracting pest vectors. Mr. Parrish claimed that the pest vectors were attracted to overfilled dumpsters owned by nearby restaurants but that nonetheless, the theatre company took steps to comply with the ACHD's order, including sealing openings in their structure created by rodents and placing baits and traps inside and outside the theatre.

Upon re-inspection of the property, the ACHD observed that the violation had been corrected. Therefore, as the appeal is moot, the ACHD requests that the appeal be dismissed. If you have any questions, I can be reached at 412-578-2653.

## Statement

The Denis Theatre Foundation owns an inactive theatre building on Washington Road in Mt. Lebanon. Parse Way, effectively an alley, runs parallel to Washington Road behind the building. The municipality of Mt. Lebanon owns and controls the space behind the building on Parse Way. The municipality has long permitted several restaurants to keep dumpsters for garbage on a sidewalk directly abutting the theatre on Parse Way. The Foundation has no knowledge of the details of the agreements between the municipalities and the restaurants, or in fact which restaurants use which of the many dumpsters.

The dumpsters are frequently overfilled so that they are not fully closed. Often there is trash, garbage, and food waste on the ground around the dumpsters. Apparently, this source of food has attracted rodents. Further, the rodents have apparently gnawed their way into the theatre space.

The Foundation received the attached inspection report and notice of violation, dated April 25, 2019 and delivered in an envelope postmarked April 29, 2019. In accordance with the citation's requirements, the Foundation promptly hired Orkin to eradicate the rodents, and in doing so Orkin has placed bait and traps both inside the theatre and outside near the dumpsters. Further, the Foundation promptly hired a contractor to seal off the openings created by the rodents.

To summarize, so far the Foundation has had to expend significant resources in time and money to fix a problem that was caused by someone else. The Foundation has no knowledge of whether or not the ACHD inspection that resulted in this inspection report and notice of violation included any research into the relevant facts, or whether any other notices of violation were issued. In any event, the Foundation has corrected the problem.

On behalf of the Foundation, I request that the violation be dismissed with no costs assessed to the Foundation.
